## Opec set to extend oil supply cut as Iran endorses pact

Opec and its allies look set to extend oil supply cuts this week at least until the end of 2019 as Iran joined top producers Saudi Arabia, Iraq and Russia in endorsing a policy aimed at propping up the price of crude amid a weakening global economy.

Iranian Oil Minister Bijan Zanganeh told reporters on Monday he would support prolonging output cuts by six to nine months. Tehran has in the past objected to policies put forward by arch-rival Saudi Arabia, saying Riyadh was too close to Washington.

"I have no problem with a production cut ... It's going to be an easy meeting as my stance is very clear," Zanganeh told reporters upon arriving in Vienna.

The United States is not a member of Opec, nor is it participating in the supply pact. Washington has demanded Riyadh pump more oil to compensate for lower exports from Iran after slapping fresh sanctions on Tehran over its nuclear programme.

Opec and its allies led by Russia have been reducing oil output since 2017 to prevent prices from sliding amid soaring production from the United States, which has become the world's top producer this year ahead of Russia and Saudi Arabia.

Fears about weaker global demand as a result of a US-China trade spat have added to the challenges faced by the 14-nation Organization of the Petroleum Exporting Countries in recent months.

Russian President Vladimir Putin said on Saturday he had agreed with Saudi Arabia to extend existing output cuts of 1.2 million barrels per day, or 1.2 percent of global demand, by six to nine months - until December 2019 or March 2020.

Saudi Energy Minister Khalid al-Falih said the deal would most likely be extended by nine months and no deeper reductions were needed.

"Its a rollover and its happening, Falih, whose country is the de facto leader of Opec, told reporters on Sunday.

Benchmark Brent crude has climbed more than 25 percent since the start of 2019 but prices could stall as a slowing global economy squeezes demand and US oil floods the market, a Reuters poll of analysts found.

# Vietnam, EU sign 'milestone' FTA

Sunday signed a long-awaited free trade deal that will slash duties on almost all goods, an agreement that pushes back against a rising tide of global protectionism and hailed as a "milestone" by Brussels.

The signing comes amid worldwide trade turmoil, with a dragging US-China row and Britain's impending exit from the European Union casting a dark cloud over global growth. It follows years of tough negotiations

marred by Vietnam's tarnished human rights record. EU trade commissioner Cecilia Malmstrom called the deal "an important milestone" and a key step towards better co-operation with Southeast Asian economies. "This is the most ambitious trade

agreement that EU has signed with a developing country," she told reporters after the landmark deal was inked in Hanoi on Sunday in front of dozens of negotiators and diplomats.

The EU-Vietnam free trade pact will eventually see duties slashed on 99 percent of Europe's imports from Vietnam.

Billed as a so-called next generation deal, it also includes rules around labour rights and environmental and intellectual property protections.

The TPP has since been reborn as the Comprehensive and Progressive Agreement for Trans-Pacific Partnership, a watered down version of the original pact without the inclusion of the world's biggest economy.

Vietnam was set to gain enormously from that deal, and has courted other trade partners to soften the blow.

"Vietnam sought to accelerate its negotiations... in this case (with) the EU, clearly as a way of diversifying their trade," Stephen Schwartz, Head of Asia Pacific Sovereign Ratings at Fitch Ratings, told AFP from Hong Kong.

Vietnam's export-led economy has largely been buoyed by free trade, and open access to the European market is expected to boost its main deliveries to the bloc, namely textiles, shoes, smartphones and computer parts.

European countries are also eager to tap into Vietnam's market of 95 million people and its fast-mushrooming consumer class. "The advantages we can get from (the

FTA) will bring huge contributions to Vietnam's exports and imports, Vietnam's Trade Minister Tran Tuan Anh said Sunday.

### Italy's jobless rate drops below 10pc

Italy's unemployment rate dropped below the symbolic 10 percent threshold in May to 9.9 percent, provisional data from the national statistics agency showed Monday.

It was the first time it the jobless rate has dipped into the single digits since February 2012, when it stood at 9.9 The data will be welcome news for Italy's populist

coalition government, which has been criticised by Brussels for its big spending but insists that loosening the purse strings will boost the economy and create jobs. While the May figure was down 0.2 points from April,

it was still well above the euro area average, which was 7.5 percent in May, Italy's statistics agency ISTAT said. There was good news on the general employment front as well: the rate increased by 0.1 percentage point to 59

percent. Over a year, the upward trend in the number of people in work continued, with an increase of 0.4 percent compared to May 2018 -- or some 92,000 more people in jobs, ISTAT

Despite the upswing, the forecasts for 2019 are not good. ISTAT expects an overall unemployment rate of 10.8 percent this year in Italy, up on 10.6 percent in 2018.

The OECD is more pessimistic, forecasting a jobless rate of 11.7 percent this year, and 12.3 percent the next.

Italy's gross domestic product (GDP) grew only 0.1 percent in the 1st quarter, after a recession in the last half of 2018, as the nation's economy is being buffeted by an economic slowdown in Europe, trade tensions between China and the United States, as well as unease among Italian businesses over the policies of the far-right and antiestablishment coalition that is leading the country.

The government is currently engaged in delicate negotiations with the European Commission, which has threatened to open disciplinary proceedings against Italy over its mammoth debt.


