Lack of Progress on Rohingya Return

UN envoy will 'ring alarm bell' if no action taken

The UN envoy for Myanmar said Monday that progress on alleviating the crisis that led more than 720,000 Rohingya Muslims to flee to neighboring Bangladesh has been slow and if there is no action it will be time to "ring the alarm bell."

Christine Schraner-Burgener was responding to frustrated speeches and questions from many countries — from Bangladesh to Saudi Arabia to the United States — on the lack of progress in returning Rohingya nearly two years after they fled a violent crackdown by Myanmar's military.

She told the General Assembly there are "not a lot of changes on the ground," pointing to "many challenges" including Myanmar's civilian leaders having "to navigate an extremely difficult environment in which the military continues to have considerable political influence."

In addition, Schraner-Burgener said, "immense complexities" inside the country have been "an impediment" in addition to the Rohingya crisis. She cited Myanmar's 70 years of isolation, 21 armed groups still operating in the country, a lack of development, drug production and human trafficking. She said her highest priority remains "ending the vicious cycle of discrimination and violence, especially in Rakhine," the western state that

was home to the Rohingya who fled - and where she said 128,000 displaced Rohingya languish in camps, many for nearly seven years. As a first step, Schraner-Burgener called for more to be done to end fighting in Rakhine between Myanmar's military and the Arakan Army, a well-trained guerrilla force from the Buddhist ethnic group seeking autonomy for Rakhine.

She said the fighting has displaced 30,000 Buddhists and Muslims. Buddhist-majority Myanmar has long considered the Rohingya to be

In reply to a question as to how Bangladesh maintains good relations with China and India simultaneously, Hasina said the principle Bangladesh's foreign policy "friendship to all, malice to none".

"We don't want to engage in a war or conflict with anyone. Any issue between them [any two countries] is their internal matter. We've been working to maintain good relations with all and so far we have gained success in this regard," the PM was quoted as saying by Foreign Secretary Md Shahidul Haque. He was briefing reporters after the panel discussion.

Asked whether Bangladesh faces a debt trap taking up a number of mega projects with foreign loan, Hasina said, "Our external debt is around 14.3 percent of the GDP -- clearly it is

China is involved in some mega infrastructure projects in Bangladesh. Chinese companies are employed in the construction of the longest 6.9km river bridge in Bangladesh, which is fully funded by the Bangladesh government, she said. "Many people

29 Bangladeshis return home from Libya

Twenty-nine Bangladeshis, who remained stranded in the turbulent Libyan capital Tripoli and its suburbs, returned home early yesterday.

Assistant Director of the Bureau of Manpower Employment and Training Tanvir Hossain said, "They arrived at the airport [Hazrat Shahjalal International Airport | around 5:00am by a flight of Turkish Airlines."

After verifying their identities, the immigration police released them in the evening, he added.

The government of Bangladesh in association with International Organization for Migration is repatriating the Bangladeshis stranded in Tripoli.

ASM Ashraful Islam, labour counsellor of Bangladesh embassy in Tripoli, said 35 more Bangladeshis were scheduled to arrive in Dhaka

Besides, the embassy was working to repatriate over 40 Bangladeshis by this week, he added.

The situation in the civil wartorn Libya turned worse after the Libyan National Army, led by Khalifa Haftar, started an offensive against recognised internationally Government of National Accord in

Bangladesh embassy in Libya announced that it would arrange repatriation of those willing to return home. In response, some 300 were

relocated to safe areas in Tripoli. Of them, some 107, who had shown interest to return home are now being repatriated. Nearly 100 more have recently informed the embassy of their willingness to come

home, Ashraful Islam said. Around 800 Bangladeshi migrants, who were either stranded in the civilwar torn North African country or jailed or fell prey to human traffickers, were repatriated in 2018 and until June this year, he said.


