# Train journey risky as bridges shaky

### Speed limit set at 5 km per hour at a hundred spots to avert accident

The decades-old railway bridges on Akhaura-Sylhet route are in a poor condition as most of the wooden sleepers, banded clips, and nuts and bolts are damaged or missing.

Bamboo slabs have been used in place of the sleepers in some places as a makeshift measure.

The safety issue of train passengers has come to the fore following occurrence of several accidents including a fatal one on June 23 at Baramchal in Kulaura upazila of Moulvibazar, which left five people killed and over a hundred others injured.

crosses about 250 big and small bridges that were built during the British period, according to the engineering department of Bangladesh Railway

Abdul Karim Kim, convener of Songkhubdo Nagorik Andolon in Sylhet, said the railway bridges have become unsafe for train movement.

BR, the rail bridges, constructed on hills and rivers 60 to 70 years ago, have become unsteady due to a lack of maintenance and repair. None of the bridges have been reconstructed

since their construction.

He called upon the railway authorities to repair The 179-kilometre-long Akhaura-Sylhet track the bridges immediately to avoid any accidents.

Tofazzal Sohel, general secretary of Bangladesh Paribesh Andolon in Habiganj, said several bridges are now even more risky as there is pressure of water of the streams flowing from the hills. Indiscriminate sand extraction from the rivers

adds to the problem. Sylhet Railway Station Assistant Station Under the Sylhet division of the East Zone of Manager Sajib Kumar Malakar said nearly 100

small and big rail bridges are vulnerable in the Sylhet-Akhaura section. The authorities have set a speed limit of five

kilometres an hour for the trains while crossing the bridges, to avoid accidents. A few days ago, this correspondent visited a

bridge over a canal about a kilometre away from

Srimangal railway station of Moulvibazar. It was found that several nuts and bolts remained missing in the eight sleepers on the rail bridge.

According to the railway schedule, six intercity trains -- Parabat, Jayantika, Paharika, Udayan, Upaban and Kalni express -- ply Dhaka-Sylhet-Chattogram railway track twelve times a day. About 25,000 to 30,000 passengers use the rail route daily.

Abul Kalam, who lives near Srimangal railway station in Srimangal upazila of Moulvibazar, said there are at least 20 bridges between Srimangal and Kamalganj, more than half of which have been repaired with bamboo sticks.

#### 3 drug peddlers get life term

A Kushtia court on Thursday sentenced three drug peddlers to life term imprisonment.

The lifers are bus driver Thantu Mandol, 45, and his assistants Sagar Ali, 35, of Sadar upazila and Sohel Rana of Mirpur upazila in the district.

According to the prosecution, Rapid Action Battalion (Rab) arrested the trio with 1.5 kg heroin from a passenger bus in Sadar upazila on September 15, 2017 and Abdur Rashid, deputy assistant director of Rab-12, filed a case with Sadar Police Station.

After examining witnesses and evidences, District and Sessions Judge Arup Kumar Goswami found the three guilty and pronounced the verdict.

#### Cattle trader's body found

### One dies from food poisoning, 40 others fall sick

They fell sick after taking khichuri at religious gathering

A schoolgirl died from food poisoning early Sunday while 40 others fell sick after taking food at a religious gathering (milad mahfil) at Char-Bolorampur village in Sadar upazila on Friday.

deceased, Sumaia Akhter Sukhi, 13, daughter of Mohammad Selim Uddin of the village, was a Class VII student at Shahid Ahmed Rafik Girls' High School.

Of the sick victims, 27 including Sukhi's younger sister Bithi Akhter are now undergoing treatment at Pabna General Hospital in critical condition while the rest were treatment to nearly 50 patients,

given first aid.

Pabna Medical College Hospital Dr Ranjan Kumar Dutta said some 40 to 50 patients of different ages infected with diarrhoea came to the hospital for treatment between 12.00am and 2:00am early Sunday.

"During primary investigation we came to know that all the patients took 'Khichuri' at a milad mahfil on Friday afternoon," Dr Ranjan said, adding that the situation turned serious when a girl died early yesterday.

#### Labourer stabbed dead

A day labourer, who was stabbed allegedly by his rivals over land dispute on Saturday, succumbed to his injures at Sirajganj General Hospital yesterday.

The deceased is Amzad Hossain Mandol 42, son of Fayez Mandol of Teghuri village in Sirajganj's Kamarkhand upazila. Police and family members said there

was a longstanding conflict between Amzad and Md Hafizul over the land. Officer in Charge (OC) of Kamarkhand

Police Station Habibul Islam said Hafizul and his men called Amzad out of the house on Saturday night. Later, he was stabbed indiscriminately near his house.

# Two youths get life term for rape

A court yesterday awarded life term imprisonment to two youths for gang rape of a teenager in Mollahat upazila of Bagerhat.

Judge SM Saiful Islam of Bagerhat and Children Repression Prevention Tribunal-1 delivered the verdict in presence of the convicts in the afternoon.

The convicts, Abdur Rahim Molla, 23, son of Mohsin Mollah of Barogaola village in Mollahat upazila, and Jahidul Shikder,

22, son of late Abu Bakar Sikder of the same village, were ordered to pay a fine of Tk 100,000 and in default, to stay one year more in prison. In addition, under the Pornography Siddiqur Rahman.

Act, the two were awarded seven years' imprisonment and fine of Tk one lakh each.

According to the case statement, Rahim and Zahidul raped a teenage girl of Barogaola village after entering her house on June 23 in 2017.

The criminals also captured video of the scene.

The victim filed a case with Mollahat Police Station against the two and police arrested them.

After investigation, on November 27 that year, the then Mollahat Police Station officer-in-charge Abu Sayeed Khairul Anam placed charge sheet to the court.

The allegation was proved and the judge gave the verdict, said Public Prosecutor court inspector.

## Murderer gets life term

A Mymensingh court yesterday sentenced a man to life term imprisonment for killing his neighbour in Trishal upazila in 1999.

The convict is Tabarok Hossain Akanda, son of Abdur Rashid Akanda of Amirabari in Trishal. The court also fined the convict Tk 10,000, in default to suffer three months more in jail.

Additional District and Sessions Judge Md Iqbal Hossain handed down the verdict, said Sheikh Kabirul Islam, court inspector of Mymensingh.

According to the case statement, Tabarok Hossain and his neighbour Farhad Hossain Akanda, locked in an altercation on December 20 in 1999 over a disputed land. At one stage, Tabarok attacked Farhad with sharp

weapons, leaving him critically injured. Locals and family members took him to Mymensingh Medical College Hospital where the doctors declared him dead. Farhad's elder brother Sarwar Hossain Akanda lodged a case

accusing nine persons with Trishal Police Station the following day and later police pressed charge sheet against them. Eight other accused of the case were acquitted as the charges brought against them were not proved, said the

BARAPUKURIA POWER PLANT

### Jobseekers take to street for second day, 10 detained

Police yesterday detained 10 people and dispersed nearly several hundred others who, for the second consecutive day, blockaded the road to Barapukuria 525MW Coal-Fired Power Plant in Parbatipur upazila.

On Saturday, the agitators blockaded the road for a couple of hours, demanding manual work at the plant. They claimed that at least 154 of them deserve jobs there as they had taken part in construction work of the plant's 275MW unit (3rd) in 2015.

Around 10:30am yesterday, after they took to the street again, police used truncheons to push them out of the road that connects Parbatipur and

Phulbari upazilas.

Out of the 10 detained by police, two were leaders of the movement's organising committee. They are Habibur Rahman and Abu Sayeed. Sultan Mahmud, in charge of

Barapukuria police outpost, confirmed the incident. Mahbub Rahman, chief engineer

(acting) of the power plant, said there was no vacancies for workers and Power Development Board is the sole authority of employment at the plant.

One of the agitators said they were employed as construction workers at the 3rd unit of the power plant in 2015 and after the work was done, they could not find any work in the area.
