JP lawmaker's daughter-inlaw hospitalised with gunshot STAFF CORRESPONDENT

The daughter-in-law of Jatiya Party lawmaker Kazi Feroz Rashid was hospitalised on Sunday night with a bullet wound in her abdomen.

Marina Shoaib is now at the intensive care unit of Labaid hospital in Dhaka's Dhanmondi, police said quoting doctors.

Doctors at the hospital operated on her immediately after she was brought in around 10:30pm, said Saifur Rahman Lenin, assistant general manager of the hospital.

Damage from the wound has been repaired but the bullet is still inside, he said. She regained consciousness yesterday morning, but will remain under observation. Family members said Marina and Rashid's son Shoaib got married 28 years ago and they have two children.

Quoting the couple's daughter, police said that she might have shot herself using Shoaib's licensed pistol.

Marina's 20-year-old daughter, 10-yearold son and household help were present several times over phone, but he didn't in the house when the incident took place

around 9pm, said Parvez Islam, inspector (investigation) of Dhanmondi Police Station, adding that they have seized the

Police said the Criminal Investigation Department have collected fingerprint samples from the firearm.

However, Marina's father Sirajul Islam said the pistol belongs to Shoaib and he might be involved with the incident.

"We went to the police station to file a case after the incident on Sunday, but police suggested that we solve the matter mutually between two families," he alleged.

Sirajul said that Marina has had a troubled relationship with her husband for the last few years.

He added, the couple got separated around seven months ago, but a week later there was a mutual understanding and Marina started living at Feroz Rashid's residence in Dhanmondi 9/A.

Halt dev projects near Sundarbans till env assessment

TIB chief urges govt

Transparency International Bangladesh Executive Director Dr Iftekharuzzaman yesterday called upon the government to postpone all development activities including Rampal power plant near the Sundarbans until completion of environmental assessment in the region.

"We will have no objection [against development projects] if the Structural Environment Assessment (SEA) and Environmental Impact Assessment (EIA) come up with positive conclusion," he said at a press conference arranged by the National Committee to Save the Sundarbans at Dhaka Reporters' Unity.

The Unesco World Heritage Committee, during its ongoing session in Azerbaijan's Baku, requested the government to implement relevant recommendations of SEA and submit its necessary documents to the World Heritage Centre (WHC). At the session, Unesco postponed the decision of including the Sundarbans on the List of World Heritage in Danger until next year.

If Unesco puts the Sundarbans on the "World Heritage in Danger" list, it will be a great shame for the country, said Abdul Matin, general secretary of environmental group Bapa.

SEXUAL HARASSMENT ALLEGATION

RU students demand punishment of teacher

Students of Rajshahi University staged a demonstration at Shabash Bangladesh memorial on campus yesterday, demanding punishment of a teacher who allegedly sexually harassed two female students of Institute of Education and Research (IER).

Some 50 students covered their faces with black cloth and demonstrated for half an hour, demanding that university authorities investigate the incident and take proper disciplinary steps to ensure justice.

Earlier, two IER students had filed separate complaints of sexual harassment against Assistant Prof Bishnu Kumar Adhikary.

After the demonstrations, third-year student Jannatul Ferdous Juthy said, "Our department has been taking too much time to investigate; we are not happy with it." Rezwan ul Alam Rizvi, a freshman, said,

"To ensure security of female students,

university authority should look into all cases of sexual harassment carefully." Prof Rubaiyat Jahan, member of the

probe committee formed by the department, denied the allegation. "We have been looking into the incident. Hopefully we will reach a decision next week."

Asked about the authority's stand, student advisor Prof Laila Arjuman Banu said, "We do not have an active sexual harassment prevention cell at the moment, as the old committee expired. We are

working on forming a new committee." IER authorities have already suspended the professor from performing academic

activities. On the other hand, the two students also filed separate general diaries with Motihar Police Station seeking security, claiming that they were being pressured to withdraw the complaints.

Bishnu Kumar has been denying the allegations and demanded a fair investigation to unveil the truth, according to a written statement issued on Saturday. He claimed that the allegations are conspiratory, fictional and baseless.

Later in 2011, the cabinet secretary filed the appeal with the SC on behalf of the government, challenging the HC verdict. On January 11, 2015, the Appellate Division delivered a short verdict after disposing of the appeal.

On November 10, 2016, it released the full text of its verdict. The status of the chief justice should be equal to that of the Jatiya Sangsad Speaker, it observed in the verdict. The Speaker holds third position and the chief justice

fourth in the existing Warrant of Precedence, formulated in 1986 and revised in 2008. President and prime minister enjoy the first and the second positions respectively. The SC in its verdict also directed the government to give district judges the status equivalent to that of government

secretaries. The current position of district judges is 24th and that of secretaries is 16th. The SC said in the verdict, "It is to be noted that vice president was placed at second place and the prime minister was placed at third position of the table of the

Warrant of Precedence of 1975. "Because of the abolition of the post of vice president, the post of prime minister was upgraded to second position, and the Speaker was upgraded to third, keeping the chief justice in fourth place -- thereby degrading the position of the chief justice which is not contemplated in the constitution."

"The chief justice should be placed at third position of the impugned Warrant of Precedence along with the Speaker," it mentioned.

a spotlight on media repression, and build a coalition of governments committed to a stronger diplomatic response when media freedom is curtailed.

"Our co-host Canada is developing a pledge, which we hope participants will sign up to so that they can protect journalists and defend media freedom in their countries," he said.

"In the end we all face a choice. Ignore the threats, and we tolerate the stifling of independent voices and the dangers of unaccountable power. But defend our values, and nations will flourish from the free exchange of ideas," he added.

Speaking at the press conference, Mahila Parishad President Ayesha Khanam said the sudden rise in rapes is both surprising and alarming, which will hinder women's progress.

"What happened in the last six months which caused the rise in rapes? What psychological change happened [in men] should be identified," she said at the press conference. About legal proceedings,

the women's rights activist said, "In Bangladesh, a woman or girl still needs to prove whether she was raped. But in many countries, the accused has to prove that he didn't rape."

Mahila Parishad demanded ensuring speedy trial of cases involving violent incidents, formulation of a separate act to prevent rape and sexual harassment, and putting a stop to providing political shelter to the culprits.
