Man killed in 'gunfight'

A suspected robber was killed in a "gunfight" with police in Pabna's Sujanagar upazila early yesterday.

The dead, Saiful Islam Geda alias Gedalal, 30, of Narashinghapur village in Sujanagar, was arrested a day before he was killed. He had at least five robbery cases filed against him, police said.

Arbinda Sarkar, officer-in-charge of Sujanagar Police Station, claimed a police team, along with Gedalal, conducted a raid in Hasampur field area around 2:30am to recover firearms.

Sensing their presence, Gedalal's cohorts opened fire, forcing the law enforcers to retaliate. At one point of the "gunfight", Gedalal sustained bullet injuries. Police rushed him to Sujanagar Upazila Health Complex where doctors declared him dead, the OC added.

Later, the body was handed over to family members after conducting an autopsy at Pabna General Hospital.

Police also claimed to have recovered a gun, two bullets and a few firearms.

The Daily Star, however, could not independently verify the police

Four policemen were also injured in the "gunfight".

the animals when the gathered in clearing to feed on water plants.

They found that in addition to close family, the gorillas formed an "extended family" social tier comprised of 13 individuals on average.

There were also wider groups, averaging 39 gorillas, where the animals consistently interacted with one another despite not being related.

"An analogy to early human populations might be a tribe or small settlement, like a village," said Robin Morrison, a biological anthropologist at the University of Cambridge, who led the study.

In addition, the team uncovered hints of an even wider social tier, similar to an annual gathering or festivals in human societies, where dozens of gorillas would come

together to eat fruit. Morrison said that the gorillas may have evolved these gathering skills to help maintain a "collective memory" for tracking down hard-to-

find foodstuffs. The tiered system of groups is surprisingly similar to those of humans, according to the authors of the research published in the journal Proceedings of the Royal Society B.

it has taken for the conservation of the Sundarbans by February 1 of next year.

It said the information would be examined at 44th session on the WHC in 2020, so that the committee can decide whether or not to include the Sundarbans in the list of World Heritage in Danger.

The WHC also expressed concerns regarding the currently active 154 industrial projects just upstream of the Sundarbans, and also requested the government to invite a joint WHC and IUCN Reactive Monitoring Mission to assess the state of conservation of the Sundarbans by the end of this year.

Regarding the concern about 154 factories surrounding the Sundarbans, former director general of the Department of Environment Sultan Ahmed said at the press conference that those factories were not built recently and were established in the 1960s.

"Of them, only 24 are in the 'red category' of DoE. Putting them in the red category does not mean it will destroy the environment. It means that there is a chance of polluting of

Iraqi gets life in jail for teen rape-murder in Germany

An Iraqi man was yesterday sentenced to life in jail by a German court for the rape and murder of a teenage girl that fuelled far-right protests against a mass influx of mostly Muslim migrants.

The Alternative for Germany (AfD) party and other far-right groups have seized on the brutal killing of 14-yearold Susanna Maria Feldman in their campaign against Chancellor Angela Merkel's asylum policy.

The accused, rejected asylum seeker Ali Bashar, 22, was convicted of the killing and handed the maximum sentence of life in prison by the court in Wiesbaden, the city where the murder took place in May last year. The judge, Juergen Bonk, also

found the crime to be of exceptional severity, meaning that Bashar will not be granted parole after 15 years as is usually the case in Germany. Bashar committed a "cold-blooded

murder" and showed "neither remorse nor empathy," said the presiding judge, adding that during his trial the defendant had "voiced no sincere
