TIB expresses concern over ACC officials' role

Transparency International Bangladesh (TIB) yesterday expressed concerns over Anti-Corruption Commission officials' admitted role in wrongly implicating jute mill worker Jaha Alam in graft cases. An ACC probe report a few days ago admitted that its

investigation officials wrongly implicated Jaha Alam, resulting in him languishing in jail for three years. He was freed on February 4 following intervention of the High Court. TIB in its statement also urged to ensure proper

compensation of Jaha Alam for his wrongful imprisonment, and bringing all responsible parties under exemplary accountability.

TIB Executive Director Iftekharuzzaman in the statement said ACC report on one hand is the reflection of people's expectations, and on the other, is a matter of deep concern. In the report, negligence in duty of ACC officials

and relevant agencies, their faulty steps, and nexus of a syndicate that had misappropriated money was identified. They should be brought under stern punishment, he said. In 2012, ACC filed 33 cases against a number of

individuals over misappropriation of Tk 18.5 crore from Sonali Bank. In 26 of the cases, businessman Abu Salek was an accused. ACC identified Jaha Alam as Salek; he was arrested in 2016 and sent to jail. When the issue surfaced in the media, the HC intervened

and ordered his release. He was released from Kashimpur Central Jail-2 in Gazipur on February 4 this year.

A man died allegedly by suicide yesterday morning after being accused of stealing an auto-rickshaw in Savar.

Nirmal Pramanik, 42, a construction worker, was found hanging from the ceiling of a room in his house in Tenguri area, said Ram Krishna, sub-inspector of Ashulia Police Station.

Police arrested three persons on charges of instigating the incident, he said.

According to Nirmal's family members, Belayet -- a garage owner, Alamgir, Elias and some locals implicated Nirmal of stealing the vehicle, and on Saturday night arranged an arbitration at the garage over the issue.

At the arbitration, they beat up Nirmal and demanded Tk 50,000 from him. Later, they took Nirmal to his residence, confined him to a room and sent his wife to get the money from relatives.

"We could not manage the entire amount overnight," said Bikash Pramanik,

Nirmal's brother. "In the morning, when we opened the door of the room, we found Nirmal hanging."



Suraiya Ahsan breathed her last at Queens General Hospital, New York, on Friday,


aged 80, says a press release. She left behind two sons - physician Saiful Islam,
