Cane thrown by teacher, madrasa boy loses eyesight

An 11-year-old madrasa boy lost sight of his right eye as a teacher allegedly threw cane at the eye in Kishoreganj's Pakundia upazila.

Victim Mohammad Al Imran, son of painting worker Idris Ali of Char Kawna village, is a student of Char Kawna Hafezia Madrasa in the upazila.

Idris said his son was admitted at the madrasa two years ago. He used to stay at the madrasa hostel.

Hasan Mahmud threw a cane at his right eye as he was allegedly absentminded in the class and started screaming with severe pain. On the same day, Imran was sent back home

On May 28, Imran's teacher Hafez Mahadul

and the teacher allegedly threatened him not to disclose the matter to anyone, alleged Imran's uncle Jalal Uddin, a farmer. The eye was then swollen but Imran did not

disclose the matter, said Jalal, adding that after three days of the incident, they learnt from his classmates about the matter and he was taken to National Institute of Ophthalmology and Hospital in Dhaka, said Jalal, adding that Imran was treated there for two weeks. The eye was badly damaged and he might lose

his sight for ever, said Jalal, quoting doctors. "The doctors have prescribed some medicines

to be continued and also asked us to visit the hospital after a month," he said.

Abdul Kadir, a member of Jangalia Union Parishad, said a week ago, Imran visited National Institute of Ophthalmology and Hospital in Dhaka where doctors informed that he lost sight of his right eye for ever.

On June 23, the victim's father filed a complaint to Upazila Nirbahi Officer (UNO) Mohammad Muklesur Rahman against Hafez Mahmud and Mohammad Monayem, director of



the madrasa.

switched off.

The UNO said he has already asked police to investigate into the incident and police visited the spot.

The madrasa director said Hafez Mahmud hailing from Mymensingh's Gouripur upazila was a part-time teacher for the month of Ramadan only.

The allegation was brought after the teacher

left the madrasa on June 2, said the director. After the incident, they tried several times to reach the Mahmud but his phone remained

Two cops sent to jail for taking bribe from jobseeker's father

Two policemen have been sent to jail in a case for taking Tk 13 lakh bribe from a jobseeker's father in the district.

The accused are Md Shamim Akand, 46, a sub-inspector of Mohammadpur Police Station in Dhaka, and his brother Md Al Amin Akand, 35, constable of Barguna Sadar Police Station. Both are sons of late Eusuf Akand of Jamura village in Patuakhali Sadar upazila.

Senior Judicial Magistrate Md Aminul Islam sent them to jail, rejecting their bail prayers in the case after they surrendered to his court in Patuakhali yesterday, said plaintiff's lawyer advocate Ruhul Amin Reza.

Earlier on Monday, the court issued arrest warrant against the duo, said the lawyer.

According to the case filed by Milon Dakua of Choddoburia village in Patuakhali Sadar upazila on December 23 in 2018, the duo took Tk 13 lakh bribe from him with a promise of arranging a job in police for his son. But they did not keep their promise. The accused policemen also continued

giving threat to Milon over the matter. After receiving the case, the court asked

Police Bureau of Investigation (PBI) to submit a report after investigating into the matter.

On July 6 this year, Md Motiur Rahman, sub-inspector of PBI, submitted the report to the court against the duo saying that they found evidence of taking bribe by the duo from Milon.

After receiving the probe report, the court issued arrest warrant against them.

One more arrested, put on 3-day remand

Another man, arrested for his alleged involvement in killing Freedom Fighter Miah Mohammad Hasan Ali Reza, was

placed on a three-day remand yesterday. Police detained Sharif Hossain, 40, son of Mokbul Hossain of Sabalia Modhyapara area in the town on Monday night and produced him before Tangail Additional Chief Judicial Magistrate's Court yesterday, seeking seven-day remand, Court Inspector Tanvir Ahmed said.

After hearing, Judge Monira Sultana granted a three-day remand for him,

he said. Earlier on Sunday, police detained Tapan Kumar Sarkar, 50, and his son Tonmoy Kumar Sarkar, 20, from Battala area in the town and produced them before the same court on Monday, seeking 10-day remand for each, Officer

in Charge of Tangail Model Police

Station Saidul Haque said, adding that the same court granted them a threeday remand for each.

Meanwhile, Tapon's wife Kalpana Rani Sarkar, 40, who was arrested on Sunday, gave her confessional statement under Section 164 before the same court on Monday evening.

Advocate Reza, 76, also a central committee leader of Krishak Sramik Janata League, went out of his Sabalia residence on July 8 and a roadside close circuit (CC) camera footage shows Reza was getting on a motorbike of a youth, wearing helmet and raincoat.

Reza's younger son Mahmudul Hasan Litu filed an abduction case with Sadar Police Station accusing some unidentified people on July 10.

Later on July 13, police recovered Reza's decomposed body from the Louhajang river in the town and sent it to Tangail General Hospital for autopsy.

Fish worth Tk 2 lakh poisoned to
