ADB to fund its expansion into four lanes

The impasse over financing of the expansion of 214-kilometre Dhaka-Sylhet Highway into four lanes is likely to end soon, as Asian Development Bank has given “consent” to fund the project, officials said.

After a programme on Sunday, Road Transport and Bridges Minister Obaidul Quader told reporters that “ADB will finance the project.”

In that case, a new feasibility study and detail design has to be prepared and project cost will increase, Roads and Highways Department (RHD) officials said.

At first the authority wanted to implement the project with Chinese loan. But the government later decided to do the work using their own resources, following failed negotiations

with a Chinese company.

But the Road Transport and Highway Division (RTHD) later changed de-cision and asked the Economic Relations Division (ERD) to find a foreign financier.

Recently, ADB gave their “consent” to finance the project, a top official of the ERD told The Daily Star yesterday.

An official of the RHD, which is the implementing authority of the project, said the government will now send a formal request to ADB through the ERD.

The organisation will then send its appraisal mission in Bangladesh and on the basis of the mission’s report, ADB will take the final decision in this regard, the official said, requesting anonymity.

“These are all formalities... But ADB

Work more to create right environment

Dhaka urges United Nations

UNB, Dhaka

Expecting to see the commencement of Rohingya repatriation before September, Bangladesh has urged the UN to work more in Rakhine State of Myanmar to help create a conducive environment so that the Rohingyas can return to their place of origin.

“You should work more in Rakhine rather than in Bangladesh. I conveyed this,” Foreign Minister AK Abdul Momen told reporters at his office.

Big thugs of a small town

Over the last few days, The Daily Star has spoken to at least 15 people who have seen them transform from students into drug abusers and then some sort of gangsters. These people include police officers, journalists, lawyers, political party leaders, townspeople, victims and witnesses of their criminal activities.

THE RISE

Rifat Farazi, elder of the two brothers, completed his SSC from Barguna Zila School and got admitted to Infra Polytechnic Institute in Barishal in 2014. Rishan, who passed SSC from the same school, is a sec-ond-year student at Barguna Govt College.

During his time at the Polytechnic, Rifat started taking drugs resulting in his poor show in exams.

“Rifat Farazi was not regular in class and he used to flunk in exams,” said Amir Hossain, a director at the institute.

His association with Sabbir Hossain Nayan, also known as Nayan Bond, the prime suspect in Rifat Sharif murder, began in 2015, according to his accomplices. (Nayan was killed in a so-called gunfight.)

Rifat Farazi left the institute in 2016 without completing his course after his uncle Delwar Hossain became chairman of the district council.

The Farazi brothers looked after a part of the drug supply network run by Nayan, according to the sources.

They were also involved in mugging and extortion, snatching people’s phone and laptops, according to a local Chhatra League leader. Other sources echoed his claim.

“Rifat snatched at least two dozen phone sets in the last six months from the students living in the hostel of Barguna Government College,” said the Chhatra League leader.

“They returned the phones only after getting money from the students,” he added.

“REIGN OF TERROR”

Except for a police officer, now posted in a different district, and a local ward councillor, none of the 15 plus people The Daily Star spoke to would go on record, an indication how they fear reprisal. They said the patrons of the two brothers were politically influential, but would not give any name.

In October last year, just two months before the national elections, a local man found himself in trouble after he lodged a complaint against Rifat Farazi for “demanding extortion money”.

“Police had detained him after I informed them about the matter. But he managed to get out within hours and then started threatening me. I could not come out of my home for a few days,” he said.

“I doubt the brothers will face punishment in the Rifat killing case. If they come out on bail, they would be more ferocious,” he said.

About three years ago, Rifat Farazi attacked the house of Delwar Hossain.

a sub-inspector of Barguna Police Station at the time, on DKP Road in the town.

“Once my family members asked Rifat and his followers not to loiter around my house as they would take drugs openly,” said Delwar, now posted in Jhalakathi.

“Rifat attacked my house with a machete and damaged the door. Police had arrested him, but he was freed soon on bail,” he said.

A businessman in the College Street area said, “The two brothers, along with Nayan Bond, created a reign of terror in the town. Everyone is afraid of them. We don’t feel safe even after their arrest as we know they will get bail. They have some influential leaders to have their back.”

Faruk Sikder, a councillor of Ward-8 of Barguna municipality, shares this view.

“An influential leader has been patronising them for their criminal activities,” he said, but declined to name the leader.

Locals and police sources said they used to get backing from their uncle Delwar, also former Awami League MP from Barguna-1.

Multiple police officials said Delwar would intervene every time police detained the two brothers.

Two days before the killing, Rifat Sharif had a heated exchange with Rifat Farazi about returning a cell-phone that Rifat Sharif had snatched from a man. At one stage of the altercation, Rifat Sharif used of-fensive language referring to Rifat Farazi’s parents, a top police official said, citing Rifat Farazi’s state-ment during interrogation.

“For this reason, Rifat Farazi was demanding an answer from Rifat Sharif during the attack,” said the official, asking not to be named.

Delwar said he never requested police to free them from custody.

He said they were only in touch with Rishan, younger of the two brothers, for the last couple of years.

“I even asked Rifat not to visit my home for his criminal activities,” he said.

Barguna Police Superintendent Maruf Hossain said he was new to the post and could not say why police failed to take stronger actions against them all these years.

CASES AGAINST THEM

Rifat Farazi faced his first attempted murder charges in 2015, but subsequent investigation did not find his link to the murder and was cleared of the charges, according to police records.

Of the four other cases filed against him between 2017 and 2018, police pressed charges against him in one. But police never arrested him in that case.

Family members and locals said Rifat brought his younger brother Rishan into “his world”.

In 2017, Rishan was charged with an attempted murder, and police named him as an accused in the charge sheet. He too was never arrested in this case, records show.

Police suspect militants’ hand

The explosion in Gulistan on April 29 left two traffic constables and a community police member injured. A female assistant sub-inspector and two others were wounded after an IED went off near a police pickup in Malibagh on May 26.

Hours after both explosions, SITE Intelligence Group, an American company that tracks online activity of white supremacist and jihadist organisations, said the Islamic State claimed responsibility for the attacks.

No one been detained in connection with the Gulistan and Malibagh at-tacks yet.

Earlier, CTTC chief Monirul Islam said militants have the strength to carry out stray incidents. They, however, do not have the ability to organise large attacks.

About yesterday’s incident, Inspector General of Police Mohammad Javed Patwary said, “Local militant groups, which were active earlier, might be behind the incident.”

Replying to a query at a press conference at the Police Headquarters

yes-terday, the IGP said police would conduct tests to determine how the bombs were put together and what ingredients were used. “It will take us some time,” he said.

Additional Deputy Commissioner of the CTTC’s Special Action Group Sanwar Hossain said they would be able to say more about the bombs after analysing the materials collected from the spot.

“We will also be clear about its trigger, whether those were remote con-trolled or timed devices ...,” he added.

HOW THEY WERE FOUND

A traffic constable said they noticed a carton left beside the police box in Khamar Bari intersection around 5:00pm on Tuesday.

“One of our colleagues took the carton inside the police box thinking it might belong to one of the policemen. When no one claimed it, we thought it was a container of biscuits. We opened it around 7:00pm and saw the cans tied with tapes,” the constable said.

They informed higher officials about the carton and kept it behind

the po-lice box.

Specialised teams later cordoned off the area.

One of the two bomb-disposal robots bought from Germany last year was used for the first time. “The remote-controlled robot sent us pictures and gave us an idea about how the IED should be destroyed,” said an official of the CTTC’s Bomb Disposal Unit.

The robot carried the bomb several meters away before it was detonated.

“The area is under CCTV coverage. Our teams are looking into who might have left the bombs there,” a traffic sergeant told The Daily Star.

At Paltan intersection, the bomb was put inside a thick polythene packet beside the traffic police box close to the Bangladesh Secretariat, said Abul Hasan, officer-in-charge of Shahbagh Police Station.

The traffic police discovered it around 10:45pm on Tuesday. Later a bomb disposal team detonated it around 1:00am yesterday.

The OC said they were analysing the CCTV footage of the area.

Asked, Dr Aysha Akther, assistant director at the DGHS control room, said they keep records on the deaths from dengue following a review of an IEDCR committee.

Analysing all necessary information and test results, they update the DHGS data, said sources there.

Meanwhile, Road Transport and Bridges Minister Obaidul Quader yesterday said dengue took a terrifying turn as lives were being lost in Dhaka and elsewhere.

“I have talked to both the mayors of Dhaka city. The Dhaka south mayor told me that the insecticide used for controlling mosquitoes is quite ineffective. I have asked the health minister to ensure that the mayors get effective mosquito repellent,” he said at his office.

PM ON DENGUE

Prime Minister Sheikh Hasina yesterday instructed the officials concerned to minimise sufferings of the dengue victims, PM’s speech writer Md Nazrul Islam told a media briefing emerging from an inter-ministerial coordination meeting, reports BSS.

“The PMO asked the authorities concerned of the two Dhaka city corporations to strengthen their anti-mosquito drives to check dengue,” he said.

She also instructed the health authorities to form a special medical team in each city hospital to ensure smooth and proper treatment of dengue patients. A decision was also taken to observe a “den-gue awareness week” from today.

The PMO asked all government officials to clean their respective offices and to prevent dengue, alongside motivating people to keep their residences and neighbourhoods clean by removing stagnant clean water from different pots, particularly flower tubs, air conditioners and refrigerators.

Ferdousi Akhtar, assistant director of DGHS, (Khulna division), said doctors at district and upazila levels did not get training in dengue management and the kit.

She said they were providing treatment based on their experience.

Several other doctors in other districts said the same.

Asked, Prof Sanya Tahmina, director of communicable disease con-trol at the DGHS, said, “Dengue cases are being reported outside Dhaka as well. We will train doctors outside Dhaka through video conferencing from next week.”

are from the housing and public works ministry while the remaining four are from the science and technology ministry, he said.

The minister said it had been decided to file departmental cases against 16 officials of the housing and public works ministry after suspending them, and necessary legal action, including filing of departmental cases, would be taken against 10 ministry officials.

Rest four officials, one is on retirement while three others are enjoying PRL, he said, adding that different action would be taken

against them.

The officials under the science and technology ministry are RNPP project director Dr Shawkat Akbar, deputy project director Hasinur Rahman, sub-assistant engineer Mehdi Hasan and Md Mahabub.

Rezaul said they wrote the science and technology ministry to take action against them.

‘GUNFIGHT’ WITH BGB

2 suspected drug peddlers killed in Cox’s Bazar

Two suspected drug peddlers including a Rohingya man were killed in a “gunfight” with Border Guard Bangladesh (BGB) in Teknaf upazila of Cox’s Bazar on Tuesday night.

The deceased were Mohammad Kamal, 22, of Balukhali Rohingya camp, and Habibur Rahman, 23, of Maheshkhaliapara village in Teknaf.

Addressing a press conference in the force’s Teknaf office yesterday, BGB-2 commanding officer Lt Col Mohammad Foysal Hasan Khan said the gunfight took place near Purbaleda Rohingya camp at 11:30pm.

A BGB-2 team took position in the area on information that a Yaba consignment was being smuggled from Myanmar into the country through the Naf River, he said.

After some time, the BGB team intercepted a group of 8-10 persons who were carrying small packets at their hands. At that time, the drug peddlers opened fire on the border security troopers, forcing them to

tortured me,” Mahmudul Bari Aslam quoted his client Minni as saying.

The district police declined to comment on the claim yesterday.

They said that they did not have any role in recording the confessional statement. The district magistrate personally took consent of the victim before recording her statement under section 164, said police.

Bhuban Chandra Howlader, public prosecutor of Barguna court, also refused to comment on the matter, saying that it was under investigation.

“I found Minni sick and unable to walk properly. She told me that she had aches all over her body,” said the lawyer, adding, “Minni also complained that she was not able to sleep at night and was psychologically disturbed due to the shock of losing her husband.”

“It is evident that she is in immediate need of psychological and physical treatment,” he said.

To withdraw her previous statement, Minni first needs to apply to the jail authority, after which they would take the necessary action.

About the illness, Anowar Hossain, jail superintendent of Barguna jail, said Minni was under observation of a nurse and if necessary they would arrange a doctor.

Rifat, 25, was hacked to death by a group of men on June 26 in Barguna. A video footage of the murder shows Minni trying to save her husband.

Police have so far arrested 15 suspects, including Minni, over the murder.

The prime accused Sabbir Hossain Nayan, also known as Nayan Bond, was killed in a “gunfight” with police on July 2 in Barguna.

The case took a different turn after Minni’s arrest on July 16, after she was questioned for 13 hours at Barguna Police Lines.

A Barguna court placed her on a five-day remand the next day.

No lawyer represented her at the time, and her father claimed local lawyers did not take the case because they were influenced and threatened by some politicians.

Also yesterday, Minni’s father Mozammel Hossain demanded the Rifat murder investigation be transferred from the district police to the Police Bureau of Investigation (PBI) for a “fair” investigation.

“By framing Minni in the case, Barguna police are trying to hide some in-fluential quarters’ involvement in the killing,” he told a press briefing at the Barguna Press Club yesterday.

He urged the prime minister, home minister and inspector general of po-lice to transfer the case to the PBI as he “had no faith in Barguna police anymore”.

“Minni was forced by police to give the confessional statement in order to save the real culprits,” he said.

He alleged that his entire family was suffering from insecurity. The education of his two other children was also stopped due to it, he said.

“The police have turned Minni from number one witness to an accused,” Mozammel added.

Meanwhile, Abdul Motaleb Mirdha, joint secretary of the district Awami League, said they wanted punishment of the masterminds and patrons of the Bond gang.

“People who gave shelter to the Bond group should also be punished,” he said while addressing a law and order meeting at the district commissioner’s office yesterday.

US Senate passes 9/11 victim fund, sends it to Trump

The US Senate on Tuesday voted overwhelmingly to extend funding for first responders and others injured during the September 11 attacks.

The measure, which provides for billions of dollars in funding, including about \$10 billion over the next decade, passed 97 to 2.
