Health minister likens mosquito population growth to that of Rohingyas

Health and Family Welfare Minister Zahid Maleque yesterday compared the breeding capacity of Aedes mosquitos with that of the Rohingyas and claimed the rapid spread of mosquito population is the reason behind the increased number of dengue patients.

"Why such a huge number of dengue patients are there in our country? My simple answer is the spread of mosquito, spread of Aedes mosquito. These [Aedes] mosquitos are healthy and sophisticated," he said.

Addressing a seminar at the Shaheed Milon Hall of Dhaka Medical College yesterday, the minister said, "Somehow we could not control the mosquito population. The mosquito population and the Rohingya population are growing at the same pace."

The statement drew heavy criticism from different quarters who claimed it

to be derogatory. "When a minister makes such an unreasonable comment, then we have to think under which leaderships we are living in the country. This is unfortunate," noted rights activists Nur Khan Liton told The Daily Star.

When the prime minister showed her generosity and humanity by sheltering Rohingya people, such an irresponsible comment from one of her cabinet members is painful, he said.

During the seminar, the minister also urged physicians to ensure proper treatment to the dengue patients in different hospitals across the country.

"We can ensure that no one suffering from dengue fever is out of healthcare facility. The doctors who are providing treatment to the dengue patients were given training," he said.

Speaking as the chief guest, Zahid said as the number of Aedes mosquitoes have increased this monsoon, the number of dengue patients is also on the rise, but the government is trying its best to control the situation. Citing data of the health ministry,

he said a total of 7,766 dengue patients were admitted in different city hospitals from January 1 to July 23 this year. Of them, only 94 were admitted to hospitals outside the capital.

Noting that eight people died of dengue fever so far this year, the health minister said a total of 5,938 dengue patients have received treatment from different hospitals this year, while 1,823 patients are currently receiving treatment.

The picture was similar at other government hospitals and many private hospitals in the capital, which are struggling to handle the rush of dengue patients.

HM Nazmul Ahsan, associate professor at Shaheed Suhrawardy Medical College Hospital, said they are now handling 165 dengue patients against their capacity of 60. Many of these patients are getting

treatment, staying at the hospital's veranda and walkways, he said. Scores of private hospitals in the

capital are compelled to send back dengue patients for not having the capacity to accommodate them. "We have to send back 10-12

dengue patients every day for a lack of accommodation at our hospital," said Dr Pradip Saha, emergency medical officer at Salahuddin Specialised Hospital in the city's Hatkhola. "Around 10 dengue patients are

coming to our hospital every day. Now 35 patients are under treatment here," said Poli Rani Biswas, nurse-in-charge of the 300-bed hospital.

Kinkar Ghosh, an epidemiologist at Dhaka Shishu Hospital, said they could not admit many dengue patients

Talking to reporters at a newspaper office in the town, the grieving mother alleged that Sub-inspector Mohammed Abul Kalam of the police station was the investigation officer of the first case she had filed on July 3 with the assistance of One Stop Crisis Centre accusing Maulvi Farid, 30, who is also a distant family member.

The SI on July 16 asked the woman, her daughter, four other members of their family, and two of their neighbours to go to the police station to give their witness statements, she said.

Talking to reporters, the 5th grader said police held them at the police station for four days and demanded Tk 1 lakh for their release.

They were released on July 19 after giving Tk 16,000 to the officer.

The 5th grader told reporters that she was tortured while they were held at the police station.

She said they threatened to hurt her with a machine used to cut metal.

"They held the machine close to my face. They slapped me and said I would be in prison for the rest of

my life. I was not even allowed to sleep. Through the physical and mental torture, SI Abul Kalam forced me to say

what I had been taught to say," she said. Chowdhury Morshed president of Women and Children Protection Network in Cox's Bazar, said, "Police can do many things for the sake of investigation. But they can't confine a child without a court order. This is very concerning."

Farid Uddin Khandaker, officer-incharge of Cox's Bazar Model Police Station, said, "The allegations against SI Abul Kalam are not true at all. He has worked hard to identify the real accused. He should be praised for unearthing the truth."

THE FIRST CASE On July 2, the plaintiff of the case went to visit her sister's house leaving

FROM PAGE 1 holding a hearing on a suomoto (voluntary) rule issued on July 14.

The HC gave the Dhaka South City Corporation (DSCC) and the Dhaka North City Corporation (DNCC) four days to take effective steps to curb the menace and inform it about the progress.

"The mosquito menace was the authorities used mosquito spray. This year, the situation, however, is not under control. A responsible minister has also reportedly said that the mosquito repellent is not effective this year. Earlier, nobody had confessed it," the court said.

At one stage of the hearing, the lawyers for the DSCC and the DNCC promised that the city corporations would launch a "combined operation" to kill mosquitoes.

Both the DSCC and DNCC have already taken up crash programmes in this regard and that the joint effort will work, they said.

Barrister Toufiq Inam and Advocate Sayed Ahmed Raja, the lawyers for the DNCC and DSCC respectively, told the court the existing repellent was effective and that will be sprayed two to six times every day to bring the situation under control.

Now the spray is being used two times a day, they claimed, adding that at least a month is required to import new type of repellent maintaining the official procedures.

The lawyers prayed to the court to give three or four days to the DSCC and DNCC. It also requested the court to observe whether the combined effort was working.

In response, the HC bench asked the DSCC and the DNCC to inform the progress to the court on Tuesday when brought under control last year after the next hearing is scheduled to be held.

Yesterday, the court also exonerated DSCC Chief Health Officer Brig Gen Md Sharif Ahmed and DNCC Chief Health Officer Brig Gen Md Mominur Rahman Mamun from personal appearance in connection with the rule.

The two appeared before the HC bench yesterday morning as per its July 22 order to explain the steps the DSCC and DNCC have taken to prevent the mosquito menace.

Brig Gen Sharif told the court that the menace was a global problem due to climate change and the country has experienced it due to heavy rain, among other issues.

He said there were 75 wards in 10 zones of the DSCC where more than one crore people live, but only 439 people had been working to prevent the

Brig Gen Sharif claimed that their repellent was tested at two laboratories after its import and the results were satisfactory.

The court said dengue fever was a health concern and the health ministry for passing further order on this issue. along with the DSCC and DNCC

should look into the matter.

Brig Gen Md Mominur Rahman Mamun told the court that the DNCC had planned to import new repellent to prevent the mosquito threat.

Attorney General Mahbubey Alam also told the court that the dengue was a health concern for all and the matter should be taken seriously. Meanwhile, another HC bench STAFF CORRESPONDENT

## SC lawyer for transferring case to CID or PBI

A Supreme Court lawyer yesterday filed a writ petition with the High Court seeking its directive on the government to transfer Barguna's Rifat Sharif murder case to the Criminal

the petition requesting the HC to cancel the remand order against Rifat's wife Aysha Siddika Minni and the statement given by her in court in connection with the case. The petition also requested Minni's immediate release.

In the petition, he also prayed to the HC to order the government to form

Citing from the petition, Eunus told The Daily Star that the local police do not have enough professionalism and expertise to investigate sensitive cases like Rifat Sharif's murder.

The CID and PBI are professional departments of the police for the investigation of such major cases, and so the Rifat Sharif murder case needs to be transferred to one of those two

The lawyer alleged police have reportedly taken Minni on remand and forced her to give a confessional statement to the magistrate, which is illegal.

Besides, the incident of Nayan Bond's death in a "gunfight" with the law enforcers is an extrajudicial killing, which is contradictory to the constitution, he said, adding that a judicial inquiry

Eunus said the HC may hold a hearing on the petition on Sunday, July 28.

On June 26, Rifat Sharif, a 25-yearold internet service provider, was hacked by a group of young men in broad daylight.

In a footage of the incident that went viral on social media, the victim's wife Minni was seen screaming and trying to save her husband from the assailants.

administration has continued to increase punitive measures against Venezuela since January, when Washington -- along with 50 other countries -- recognized opposition leader Juan Guido as the crisis-ridden country's interim leader.

Russia, North Korea and Cuba continue to support Maduro.

"The pressure will continue, we'll have more sanctions tomorrow," said Elliott Abrams, the White House's pointman on Venezuela.
