The amount of cargo being handled by Bangladesh's premier airport has been increasing by 15 percent annually for the past few years coupled with the country's rising exports, said a high official of a top freight forwarders' platform yesterday.

Trump threatens not to recognise China's special status at WTO

President Donald Trump on Friday threatened to withdraw recognition of the countries stop CHEATING the system at the special "developing nation" status of China expense of the USA!," Trump said on Twitter. and other relatively rich countries at the World Trade Organization unless changes wealthiest economies in the world claim are made to the body's rules.

The salvo fell the week before top US trade officials are due to return to China to rekindle trade talks that acrimoniously collapsed in May.

Trump said in a statement the global trade body uses "an outdated dichotomy between developed and developing countries that has allowed some WTO members to gain unfair advantages."

Without "substantial progress" to reform WTO rules within 90 days, Washington will no longer treat as a developing country any WTO member "improperly declaring itself a developing country and inappropriately seeking the benefit of flexibilities in WTO rules and negotiations," the statement said.

While the statement points to multiple countries that benefit from the designation, it focuses mostly on China.

The statement notes that seven of the 10 developing country status, as do Mexico, South Korea, and Turkey, which are members of the Group of 20 leading economies. Trump's order directs the US Trade

Representative's office to "use all available means to secure changes at the WTO," with the cooperation of other countries where possible. It is unclear how the measure would

change US policy but it likely would open the door to even more retaliatory tariffs against China and other countries. "When the wealthiest economies claim

developing country status, they harm not

only other developed economies but also economies that truly require special and differential treatment," the statement said, and that "cannot continue to go unchecked." Developing country status in the WTO

allows governments longer timelines for implementing free trade commitments, as well as the ability to protect some domestic industry and maintain subsidies.

Private credit growth target may be 15pc

The private sector credit growth target is immaterial as it

will have little impact on the investment scenario.

A lack of power supply, bureaucratic complexities and corruption are discouraging investors from taking up fresh investment plans or expanding their existing units, she said.

"The country's ranking in the World Bank's ease of doing business index has reflected the actual scenario of the private sector. We should remove the barriers for the sake of investment, or else the monetary policy will not have any effect," Fahmida added.

Any monetary policy can be implemented when lenders and businesspeople play a collective role, said AB Mirza Azizul Islam, a former adviser to the caretaker government. "Many banks are facing a liquidity crisis mainly due

to high volume of default loans. This has lessened their capability of distributing loans. This will create a roadblock in implementing the monetary policy." A large number of businesspeople is going through a

confidence crisis because of the haphazard situation on the country's socioeconomic front. "So, both the demand and supply sides are going through

crisis. This had an adverse impact on implementing the monetary policy in recent years.' Unless the situation improves, the central bank will face

the same problem this time in materialising its monetary policy, Islam added.

Messaging giant WhatsApp plans to launch its first payment service this year in India, its biggest market with 400 million users, the company said Friday.

The Facebook-owned firm has tested the service with about one million people over the past year. But a commercial launch has been on hold while it waits for approval from India's banking regulator.

"WhatsApp Payments will make it as easy to pay someone on WhatsApp as it is to send a message, the company's global head Will Cathcart said in a statement.

"We can't wait to provide this service to our users across India this year," he added.

India would be the first country to get WhatsApp payments, but Cathcart did not say whether the authorities have given final approval. He said such services were critical to accelerating financial inclusion in India and bringing millions more into the country's fast-growing digital economy.

India is one of the world's quickest-growing major economies, with tens of millions already using online transactions.

annual charge will be only Tk 1 lakh to Tk 1.25 lakh. And if foreign satellites use the

BCSCL's landing stations, they will have to pay Tk 3 crore per year, according to the draft guideline. However, televisions or interested companies will have to pay bandwidth

charges apart from the regulatory charges for using the satellite bandwidth. The BTRC officials said they will finalise the charges and rates after

taking feedback from stakeholders. Salauddin Salim, chief of transmission and ICT at Somoy TV, said they found that the initiative

would not lower their costs. Somoy TV is already connected with Bangabandhu-1 satellite along with four other private television channels broadcasts of events and television

While using the BCSCL, the up-link they are maintaining their previous connections as Bangabandhu-1 is still fine-tuning its operations.

About the issue, Shahjahan Mahmood, chairman of the BCSCL, said having guidelines on satellite landing rights is important for a country like Bangladesh that just launched its first satellite.

"It was our request to the government as foreign satellite companies are entering Bangladesh freely. Without getting regulatory approval, Bangabandhu-1 cannot provide services in countries where its footprint is comparatively strong. Then why will Bangladesh not

secure its rights in the sky?" According to the landing rights guideline, the telecom regulator is trying to keep control of live television

channels will have to take prior permission from the regulator for live broadcast of any programme or news. However, for any emergency

situation they can take post-facto

permission within 30 days of the said broadcasting. For taking permission for live broadcast, television channels will have to pay a Tk 10,000 charge, but to cover national events by state-owned

television operators no permission

and charges will be applicable. Officials said the telecom regulator had formed an eight-member committee on fixing the landing rights rules in 2013 soon after starting the country's first satellite project.

The telecom regulator has dusted off the process again now, more than one year past Bangabandhu-1's launch.
