

Waterbodies disappearing in Brahmanbaria town

Three-fourths of over 200 ponds filled to build houses, business structures in last 35 years

Once known as a 'town of ponds', Brahmanbaria now hardly retained only one-fourth of its 200 natural water bodies. Filling up of the natural water bodies

started, especially after Brahmanbaria was upgraded into a district in 1984, for construction of residential buildings, markets, bus-truck terminals, and other commercial establishments but the environmental issues were grossly ignored, said environment activists.

"Targeting a pond, the syndicate men dump garbage in it and at one stage the water body loses its utility. Then they start filling it up with sand or mud in the dead of night. The practice has been going on in this town for the last 35 years," said Nasir Mia, a lawyer of earth and sand from there, which was Brahmanbaria Bar.

Once famous Ram Thakur Asram

Paikpara area, is now a part of history as a big market was constructed after filling it. Scores of age-old ponds of different

sizes have disappeared from the town due to unplanned urbanization and lack of monitoring by the authorities concerned. Currently, an influential quarter is filling

A month ago, a group of influential people led by Ali Ahsan Kawser, a councillor of ward No 5 under Brahmanbaria Municipality, filled up a pond in Modhyapara Border Bazar area. Afterwards, a mobile court fined its owner Tk 2 lakh and ordered him to remove the carried out within a couple of days.

If the trend goes on, the town's map will be without any pond in future, he said in tone of regret.

The town sees increase in waterlogging due to filling up of the water bodies, said Ashraful Imam Rana, convener of 'Committee for Protection of Town Ponds'.

Tanharul Islam, deputy assistant director of Brahmanbaria Fire Service, said, previously firefighters used water from adjacent ponds to douse fire but now they face problem to collect water during fire incidents.

Contacted, Brahmanbaria Deputy "When we go to save a pond from Commissioner Hayat-Ud-Dowllah Khan said, "The Department of Environment files cases when receive any information about pond filling. We also conduct mobile courts to thwart pond filling."

ENCLAVES EXCHANGE

4th anniversary observed

The residents of 36 former enclaves in Panchagarh have observed the fourth anniversary of the historic deal on the exchange of enclaves between Bangladesh and India,

which ended the virtual statelessness of these people. The celebration programmes including a procession, a discussion, and cultural events were held in the last two days.

On the midnight of July 31 in 2015, 51 Bangladeshi enclaves inside India and 111 Indian enclaves inside Bangladesh were attached to the respective countries. With this, about 40,000 people living in the

Indian enclaves got Bangladeshi identity, access to government services as citizens of this country, and eventually a chance of a better life. The 111 former Indian enclaves were located in four districts -- 36 in Panchagarh and the rest in Kurigram, Lalmonirhat and Nilphamari. On the occasion, the former enclave people demanded

declaration of July 31 as "Enclave Exchange Day" and enrolment of the teachers of the enclaves' educational institutions in the government's monthly pay order or MPO scheme.

They included their demands in a memorandum submitted Wednesday to Prime Minister Sheikh Hasina through Panchagarh Deputy Commissioner Sabina Yasmin.

Earlier in the day, they gathered at Sher-e-Bangla Park in the district town, brought out a colourful procession and paraded different streets before ending it at the DC office. On the afternoon, a discussion and a cultural

function were held on Mofizar Rahman Degree College premises at Grati village (a former enclave village) in the sadar upazila. Later, the residents placed floral wreaths at Shaheed Minar on the college ground on the eve of the anniversary -- at 12:01am on Thursday -- and lit candles there.

A newly married girl was killed allegedly by her husband over a family feud at Alinagar village in Astagram upazila of Kishoreganj on Wednesday. The 18-year-old victim China Akter, was daughter of

Akkas Mia of the village. After the incident, China's husband Fayez Mia, 24, who

used to live at his in-laws' house since the marriage, fled the area to avoid police arrest. Quoting the victim's family members, Officer in Charge of Astagram Police Station Mohammad Kamrul Islam

Mollah said China was married to Fayez, a day labourer and son of Samir Uddin of the village, on July 8. The couple went to bed on July 30 but their door

remained closed till the following noon. Later, failing to find any response despite repeated knocks, family members entered the room by breaking open the door and found China's body on the bed, the OC said.

Being informed, police went to the spot, recovered the body and sent it to Kishoreganj General Hospital for autopsy.

Police suspect that the girl might have been killed by her husband as her body bore marks of injuries on the neck and right hand, the OC added. Victim's father filed a case with Astagram Police Station

accusing Fayez the same night, he said, adding that they were conducting drives to arrest Fayez.

Two siblings died from electrocution in Kaliganj upazila on Wednesday.

The deceased are, Mafizul Islam, 21, an Intermediate student at Chaparhat Degree College, and his younger brother Shakil Islam, 15, a Class IX student at Shialkhawa School and College, sons of Abdul Gafur and Sahera Begum of Nithok Thingirpar village.

Quoting the villagers, Chalbala Union Parishad (UP) Chairman Mizanur Rahman said the two brothers were trying to connect a cable to an electricity pole nearby their house.

IMPACT OF FLOOD IN GAIBANDHA, TANGAIL

Fisheries damage to exceed Tk 30cr

The floods this year have inflicted a severe blow to fish farms in affected districts including Gaibandha and Tangail where partial damage estimation so far amounts to around Tk 30 crore.

fisheries According to department in Gaibandha, fish from as many as 6,290 ponds and hatcheries were washed away by the flood, causing Tk 26.84 crore worth of damage to farmers in six out of seven upazilas in the district.

The total number of affected farmers is no less than five thousand, as per an estimate by the department.

With water flowing a record 150 centimetres above danger mark in more than 400 villages of 49 unions, including two municipalities, the flood also damaged crops dwellings belonging to thousands of inhabitants as well as infrastructures including roads and embankments.

land in the six upazilas and an

estimated 2,060 tonnes of fish and around 1.11 crore fish fries from the fisheries were washed away by floodwaters, fisheries department officials said.

The department also estimated that Tk 2.06 crore worth of infrastructural damage has been sustained by the fisheries in the upazilas. Budharam Das, a fish farmer

in Gajaria union of Phulchhari upazila, said fish from his two ponds escaped into overflowing floodwater before he was able to take any steps to contain the fish inside the ponds.

The onrush of floodwater inundated the ponds so fast that the fish farmers did not even get any time to catch their fish. Although a few of the farmers set up nets around their ponds, the nets could not withhold against the strong current, he also said.

Anil Chandra Das from Bhasarpara village in the same upazila said all the fish he had

been rearing in three ponds for the last six months were washed away by the flood. Nagarpur upazila said he borrowed Gaibandha Fisheries Officer Tk 1.5 lakh from a moneylender

in a primary estimation found that 240 fish farmers in the six upazilas sustained around Tk 4 crore worth of damage as the flood inundated 786 ponds belonging to them.

Bhuapur upazila saw the highest devastation, with 185 fish ponds, belonging to 55 farmers, washed away by floodwaters.

Many of the farmers said after losing their fish to the flood, they

no longer have the capacity to repay the loans they took from banks and moneylenders. Fish farm owner Shamsur Rahman from Solimabad in

During their visits, they have been providing advice to farmers regarding preparation of ponds for fish cultivation after the floodwater recedes.

There will also be post-flood rehabilitation programmes, under which the affected fish farmers will be provided with necessary assistance including the supply of fish fries, he added.
