Libya's Government of National Accord has protested at what it said were "untruths" in UN envoy Ghassan Salame's latest report on the conflict in the North African country.

Fayed al-Sarraj, head of the UNrecognised GNA which is based in Tripoli, summoned Salame on Wednesday "to deliver a protest note over untruths" in his report to the United Nations Security Council, it

Salame, in a videoconference on Monday, raised the alarm over "the increasing frequency of attacks on Mitiga", the Libyan capital's only functioning airport.

"Several of these attacks have come perilously close to hitting civilian aircraft with passengers on board," he said.

Salame urged "the authorities in Tripoli to cease using the airport for military purposes and for the attacking forces to halt immediately their targeting of it".

Mitiga has closed several times over the past four months because of a battle for Tripoli between GNA forces and fighters of military strongman General Khalifa Haftar. Nearly 1,100 people have been

killed since Haftar launched the offensive against the capital on April 4, according to the World Health Organization.

On October 26 last year, Government Railway Police (GRP) personnel arrested a jailer of Chattogram Central Jail, Sohel Rana Biswas, and recovered Tk 44 lakh in cash, documents showing fixed deposit accounts worth Tk 2.5 crore, and cheques of Tk 1.3 crore issued in favour of him, and 12 bottles of

Phensedyl from his possessions. Two cases were filed over the incident -- for money laundering and for carrying drugs.

At that time, Partha was DIG (prisons) of Chattogram division. An investigation launched by prison authorities found that a section of Chattogram prison officials were involved in the incident. As per recommendations of the ACC, several prison guards and senior officials

alleged that on July 10 last year Rupganj OC Monir called her fatherin-law Zaher and asked him to go to the Police Headquarters along with his eldest son Abdul Matin to discuss some business and official issues.

Zaher left for the PHQ with his son-in-law Taher and since then their cell phones were found switched off. "They were blindfolded and confined to a secluded place," she alleged.

The next day, on July 11, Zaher was forced to sign five documents declaring transfer of his land. The deed numbers are 8430, 8431, 8432, 8433 and 8434, the statement reads.

Four days later, some of the accused claiming themselves as DB members

"He [Aminul] is charge-sheeted in 33 cases and the main culprit of the Sadar upazila. scam," said an ACC official.

The official said Aminul led the syndicate of frauds who embezzled Tk 18.5 crore from Sonali Bank.

On September 14, 2010, the state-run bank lodged a case with Motijheel Police Station over misappropriation of the money. The Detective Branch of police arrested Aminul in connection with the case. He was then freed on bail, he said.

The case was later sent to the ACC

for further investigation. "He told the DB that of the Tk 18.47 crore, he got Tk 4.8 crore as his

share," the ACC official added. Aminul has Tk 52.14 lakh and Tk 30.64 lakh in Begum Rokeya Sarani

and Mirpur branches of Brac Bank Ltd.

On ACC's appeal, a Dhaka court sent to jail. Darus Salam Police Station on froze the accounts in September 2018. It also seized his 473 decimal land worth Tk 1.17 crore in Manikganj

crore there," the ACC official said. "He has 11 accounts with Brac Bank's Mirpur branch. We've got proof that he made transactions of over Tk 8 crore in the accounts between 2010

and 2011," the official added. In 2012, the ACC filed 33 cases against a number of individuals over misappropriation of Tk 18.5 crore from Sonali Bank.

In 26 of the cases, Abu Salek, a businessman, was accused. But the anti-graft body identified Jaha Alam as Salek. He was arrested in 2016 and

When the issue of wrongly implicating Alam surfaced in the media, the HC intervened and ordered his release. He was released from Kashimpur Central Jail-2 in Gazipur on February 4 this year.

The ACC then assigned its Director (legal wing) Abul Hasnat Md Wadud to enquire into the matter.

On July 11, the anti-graft body submitted before the court Wadud's findings, where former investigation officials of ACC are held responsible for the wrongful implication. "It seems that the mistake of

identifying Jaha Alam as Abu Salek happened because of the investigation officials," said the report.

Describing the extent of the officials' carelessness, the report said 12 ACC officials investigated the cases, but none of them visited Alam's house.

Some bank officials and introducers of Salek's bank accounts misled the investigation officials, it mentioned.

"But it is the duty of the investigation officials to unearth the truth and present it before the court. There is no scope for shifting this duty to bank officials or someone else," said the probe report.

"During my investigation, I visited Jaha Alam's house. His house is so dilapidated that anyone would doubt how the house of a person involved in misappropriation of over Tk 18 crore could be in such a dismal state?"

On July 16, the HC said they wanted to know about the actions taken against the officials of ACC and banks responsible for wrongly implicating jute mill worker Alam in corruption cases.

It fixed August 21 for further hearing and passing order on this issue.

father's side in Afghanistan before the Sept. 11, 2001, attacks on the United States and spent time with him in Pakistan after the US-led invasion of Afghanistan pushed much of al Qaeda's senior leadership there, according to the Brookings Institution.

Osama bin Laden was killed by US special forces who raided his compound in Pakistan in 2011. Hamza was thought to be under house arrest in Iran at the time, and documents recovered from the compound indicated that aides had been trying

to reunite him with his father. The New York Times reported that the United States had a role in the operation that led to Hamza's death, which it said took place in the past two years. Reuters could not immediately

verify those details. Still, the US government's conclusion appears to be a recent one. In February, the State Department said it was offering a reward of up to \$1 million for information leading "to the identification or location in any country" of Hamza, calling him a key

al-Qaeda leader. Introduced by al-Qaeda's chief Ayman al-Zawahiri in an audio message in 2015, Hamza provided a younger voice for the group whose aging leaders have struggled to inspire militants around the world galvanized by Islamic State, according to analysts.

Hamza has called for acts of terrorism in Western capitals and threatened to take revenge against the United States for his father's killing, the US State Department said in 2017 when it designated him as a global terrorist.

He also threatened to target Americans abroad and urged tribal groups in Saudi Arabia to unite with Yemen's al-Qaeda in the Arabian Peninsula to fight against Saudi Arabia, it said.

In March, Saudi Arabia announced it had stripped Hamza bin Laden of his citizenship, saying the decision was made by a royal order in November
