# Agonising wait vexes flyers

The outbound passengers at Hazrat Shahjalal International Airport go through a painful ordeal as they need to wait even for hours in long queues just to enter the airport and drop off luggage for scanning.

Besides, people who arrive late at the airport because of the city's horrific traffic jams sometimes miss their flights after further delays at the gates, officials of a

Different airlines are now requesting their international passengers to come to the airport three to four hours ahead of schedule.

For the chaotic situation at the airport, officials blame the shortage of entrance doors equipped with luggage scanning machines as passengers need to stand in queues to complete the security checking procedures.

Following a hijack bid of a Biman flight on February 24, the Civil Aviation Authority of Bangladesh has asked the authorities to ensure foolproof security checks at all airports including Shahjalal.

Taking advantage of negligence by some staffers in security checking, a youth named Polash Ahmed boarded BG-147 flight carrying a toy gun and some plastic pipes

## We don't support torture in custody

Hasina tells the BBC

Prime Minister Sheikh Hasina yesterday told the BBC that her government does not support torture in custody.

"To tell you the truth, our government is never led by any intention to torture people in custody and it [government] also doesn't do it [either]," she said.

Senior broadcast journalist at BBC World Service Manoshi Barua interviewed the PM in London when issues of Bangladesh economy, politics and social issues came up.

Her comments on the custody issue came as Manoshi asked what steps the present government took to stop such torture, which the journalist described as a legacy of subsequent governments. "Incidentally, some [one or two incidents] may happen.

. . if you see our position in the last 10 years, we could take appropriate measures to control crime," Hasina said.



## Ensure there's no still water

Experts urge Eid-vacationers; 5 more die; 2,348 new cases

Health experts fear the exodus of thousands of people during the upcoming Eid ul Azha vacations could increase the record spread of the dengue outbreak in the city, as mosquitoes might use the empty homes, schools and offices as prime breeding grounds.

If stagnant water in any of those sources is not cleaned, then they may become breeding sites for the Aedes mosquito.

Educational institutions will remain closed for Eid for 10 days from August 8. Office holidays will be observed on August 11, 12 and 13, following the weekend holidays.

According to the Centre for Disease Control in America, an Aedes mosquito takes approximately 8-10 days to go from being an egg to an adult mosquito.

A big worry for experts during this period are educational institutions. "If the authorities of educational institutions do not take proper steps to clean the property, eventually it will become a breeding ground of

#### Kashmir on edge

Lockdown continues; Pak army vows to stand by Kashmiris

A communications blackout in disputed Kashmir entered a second day yesterday, after India snapped television, telephone and internet links to deter protests over its scrapping of special constitutional status for the Himalayan region.

Moving to tighten its grip on India's only Muslim-majority region, the government dropped a constitutional provision for the state of Jammu and Kashmir, which has long been a flashpoint in ties with neighbouring Pakistan, to make its own

"We are managing for now," said a senior official at a hospital in the region's main city of Srinagar that was among the medical facilities hit by the communications crackdown.

Expatriates' welfare minister wants no trafficking cases by legal migrant workers against recruiting agents PORIMOL PALMA

Expatriates' Welfare Minister Imran Ahmad wants police not to record cases under the anti-trafficking act if workers sent abroad with proper documents come up with complaints against recruiting agents.

He rather suggests actions be taken through the ministry, Bureau of Manpower Employment and Training (BMET) or Bangladesh Association of International Recruiting Agencies (Baira) instead of filing the cases.

Experts and activists say migrants can fall victim to human trafficking even after going abroad for jobs maintaining all legal procedures. So, they should be able to file cases under the Prevention and Suppression of

Human Trafficking Act, 2012. "The suggestion of expatriates' welfare minister will encourage human traffickers and leave victims unprotected. Therefore, I would say this is an ill-advised instruction, said Prof Mizanur Rahman, former chairman of National

Human Rights Commission. In a letter to the home minister on June 25, Imran Ahmad said over 1,400 licensed recruiting agents, mostly members of Baira, are involved in sending the workers abroad under the Overseas Employment and Migration

After collecting job demand letters and visas, the agents get those verified by the Bangladesh missions in SEE PAGE 2 COL 1

### Haftar forces say they hit pro-govt airbase in Libya

Forces loyal to Libyan strongman Khalifa Haftar said they launched air strikes early yesterday against an airbase in third city Misrata held by government loyalists.

"Our air force carried out several raids against the Misrata airbase, targeting anti-air defences as well as a Turkish aircraft transporting ammunition, drones and missiles, Haftar's self-styled Libyan National Army said in a statement on its Facebook page.

Pro-Haftar television channel Libya Al-Hadath said a Turkish Ilyushin aircraft "was destroyed as it landed at the Misrata base".

It aired footage, which could not be independently verified, of the alleged

visiting the outbound terminals of the airport in May, this correspondent found passengers waiting, from 20 minutes to over an hour, at the entrances of Terminal-1 and Terminal-2.

There are six gates -- three each at Terminal 1 and 2 -- at the departure terminals. Two of those were not in operation due to shortage of necessary security equipment during the visit of this correspondent.

Passengers said the authorities should increase the number of entry gates for better management of the

entrances. Group Captain, Abu Sayeed Mehboob Khan, director of the airport admitted that passengers often suffer

because of long queues. "Within the existing structure, we cannot add more gates. But the government has taken an initiative to construct a third terminal," he told The Daily Star on August 3.

"We have appointed supervisors at different points inside the terminals to make sure passengers face no hassle."

Talking to The Daily Star on May 18, qbal Hossain, who was waiting at the entrance of Terminal-2, said he was not sure whether he would be able to catch

"Considering the city's huge traffic jam, I started around 11:00am from my Lalbagh home to catch my 4:00pm flight," he said.

I reached the airport at 1:45pm and since then I have been standing in the queue to enter the airport terminal. It's now 2:30pm -- I am not sure whether I

will be able to catch my flight."

Several passengers next to Iqbal expressed their frustration.

"We don't object to the security checking. But this checking shouldn't be at the cost of our flight," shouted Nurul Islam, a migrant worker who came from Cumilla.

Several passengers said they were not aware that additional one or two hours will be required only for entering the terminal.

The airport authorities should run media advertisements about the long queues for security checking," Abdul Maleq, a Dubai-bound passenger said, asking, "Who will take the responsibility if I miss the flight?"

Some passengers raised a hue and cry while talking to the security staffs.

"For VIP passengers, the situation is different as there is no long queue at the VIP gate. But ordinary passengers are left to fight the chaos at the entrance in the name of security checking," said Enam Hossain, a Śingapore-bound

This correspondent saw around 70 to 80 passengers standing in queues at each of gate no 1 and 3 around 4:30pm on May 9.

Some security staff of the airport said the number of passengers in queues increases a lot at night when large planes depart one after another.

Upon scrutiny, the BMET issues immigration certificates and smart cards for the aspirant migrants.

"If any worker faces any problems after going abroad, recruiting agents address those as per the instructions of the Bangladesh mission concerned, the ministry and the BMET," read the letter.

The minister further said migrants make complaints -- "true or false" -- to police stations or other agencies and the complaints are recorded under the antitrafficking act, instead of the migration

Because of this, the recruiting agents regularly face harassments, searches, passport seizures and detentions, and remain fearful of law enforcement agencies, he said.

"It has a serious negative impact on the overseas jobs sector. Overseas employments are going down. There are fears that remittance inflow will come down and it will affect the overall

economy of the country," the letter read. Under the anti-trafficking act, the highest punishment is death penalty while under the Overseas Employment and Migration Act, a criminal faces maximum ten years of rigorous imprisonment and a fine of Tk 5 lakh.

"The overseas employment act is much softer than that of the antitrafficking law. So, not allowing the victims to file case under this law means allowing the human traffickers to get off scot-free," added Prof Mizan.

Talking to The Daily Star, Prof Mizanur Rahman said police certainly assess the merit of any complaint and a case is filed accordingly.

"So, if the case has merit, why shouldn't police accept it? Why should a minister make such a suggestion to the home ministry?" said Prof Mizan, who also teaches at Dhaka University law department.

## TIB places proposal for quality education

Citing 2.28 crore unemployed youth in the country, Transparency International Bangladesh (TIB) yesterday placed a 12-point recommendation for ensuring quality education.

The anti-corruption watchdog claimed that the country's younger generation is failing to outsmart the competition in both home and abroad due to lack of adequate skills and quality training.

The recommendations Chai "Tarunner Protvasha: (Youth's Shikkha" Gunogoto Aspiration: Quality Education) were placed at a human chain at Teacher-Student Centre (TSC) premises on Dhaka University campus, marking International Youth Day to be observed on August 12. Students from different schools, colleges and universities participated.

Referring to the country's poor quality of higher education according to the World Economic Forum, TIB Executive Director Iftekharuzzaman said that Bangladesh ranks at recommendations, he said that

Law minister says about statement made at **UNCAT** review meeting

Law Minister Anisul Huq yesterday claimed that the United Nations Convention Against Torture (UNCAT) is satisfied with the anti-torture report of Bangladesh.

"I have placed the report, describing the present situation and reality, and the condition of rule of law in Bangladesh before them [review committee of the UNCAT in Geneva, Switzerland]. We observed that they were satisfied," he

On August 4, BNP leader Barrister AM Mahbub Uddin Khokon told the media that the real situation in Bangladesh does no corroborate the recent statement placed by the law minister at the review meeting of UNCAT in Geneva.

Yesterday, Anisul Huq said the present government has ensured the trial of many important cases, including war crimes committed during the country's Liberation war in 1971, Bangabandhu Sheikh Mujibur Rahman murder case, jail killing case, 10-truck arms haul case and August 21

grenade attack case. "In this context, I have said the Prime Minister Sheikh Hasina-led government has taken all necessary steps to establish rule of law in Bangladesh. Have I lied? You

### HC issues status quo on publishing gazette notification

The High Court yesterday issued status quo for two months on publication of gazette notification on implementing the recommendations of 9th wage board for journalists.

The court also issued a rule asking the respondents to explain why the unilateral finalisation of the award by the 9th wage board without giving the stakeholders opportunity to raise objections to the recommendations should not be declared illegal.

In the rule, the HC also asked the respondents to show cause why sending such recommendations to government for the final publication of the gazette notification should not be declared without lawful authority.

The cabinet committee for finalisation of 9th wage board award, represented by its convener -- road transport and bridges minister, secretaries to the ministries of information and labor and employment, and chairman of 9th newspaper wage board have been made respondents to the rule.

The HC bench of Justice Obaidul Hassan and Justice Mohammad Ali passed the order and issued the rule following a writ petition filed by the Newspaper Owners' Association of Bangladesh (Noab) -- challenging the legality of the 9th wage board and its recommendation.

Following the HC order, the government cannot implement the recommendations, Advocate Md Yousuf Ali, lawyer for Noab, told The Daily Star.

Contacted, Attorney General Mahbubey Alam said his office will move an appeal before the Appellate Division of the Supreme Court against the HC order.

Citing the writ petition, Advocate Yousuf Ali said the chairman of 9th wage board finalised the award unilaterally, without first publishing a gazette notification complying with the provision of Rule 128 of the Bangladesh Labour Rules, 2015, enabling stakeholders concerned to submit their respective objections, if any.

The award determined by the respondents in absence of the petitioner in the process of the wage board is absolutely unilateral, mala fide and arbitrary and hence it cannot be allowed to be finalised and published in the gazette notification without final scrutiny of the HC, he added.

On July 25 this year, Road Transport and Bridges Minister Obaidul Quader said a cabinet committee on 9th wage board award for newspaper and news agency journalists and employees has finalised its report for cabinet endorsement, after Prime Minister Sheikh Hasina returns to the country.

Quader, who heads the seven-member cabinet committee, told newsmen "after the final approval [by the cabinet], a gazette will be published" for its implementation.

He is having difficulty seeing, as some kind of dust was thrown in his eyes, the doctor added.

Mushfiqur told journalists that he was abducted from Dhaka's Gulshan area on Saturday night. Someone put something in his eyes so he could not see anything.

All he could remember was that he walked till he fainted. "When I regained consciousness, I found my eyes covered and my hands tied up," he said.

The abductors intimidated him, beat him several times, and fed him only a piece of cake and some guavas, Mushfiqur described.

"I don't remember how I reached Sunamganj. Some people forced me out of a car and asked me to run and I started running. Then I realised I'm in Sunamganj and asked the locals to help me," he said.

Mushfiqur went missing when he was returning home from Gulshan-1 after meeting his uncle. A general diary was later filed with Gulshan Police Station.

He received a threatening phone call on July 21, and filed a general diary with Pallabi Police Station the next

### TIB demands resignation

"Such allegations against almost all officials of a commission is rare in the history of Bangladesh," he said in the statement.

TIB said such immoral activities by the top EC officials maligned the "pillow scam" at Rooppur Nuclear Power plant. Saying that such allegations raises

questions about the entire commission, TIB said the CEC and other election commissioners should resign as the highest responsible persons for the serious irregularities and moral turpitude, in a bid to restore the constitutional dignity of EC.

According to a report on Bangla daily Prothom Alo on Tuesday, the CEC, four commissioners, EC secretary, an additional secretary and two joint secretaries, have pocketed over Tk 2 crore, allocated for delivering 'special talks' at training programmes for the 11th national parliamentary election and the upazila polls which followed.

Additionally, the EC secretary at the time (presently secretary of the local government division) alone drew Tk 47 lakh as the 'course consultant'. He was paid separately as a 'special speaker", though the exact

remuneration for this is not known.

According to EC sources, the election commission allocated Tk 61.25 crore for training during the parliamentary election held on 30 December last year. And another Tk 61.75 crore was allocated for trainings pertaining to the upazila

According to information from the election commission, those who received payment in the name of delivering talks 'special speakers', included chief election commissioner (CEC) KM Nurul Huda, election commissioners Mahbub Talukdar, Rafiqul Islam, Shahadat Hossain Chowdhury and Kabita Khanam, secretary Helal Uddin Ahmed, additional secretary Mokhlesur Rahman and two joint secretaries Abul Kasem and Kamrul Hasan.

Another four joint secretaries were added as 'special speakers' during the upazila election. And director general of the Election Training Institute (ETI) Mustafa Faruk took around Tk 19.39 lac as 'course director' for an upazila election training course. In other words, these officials pocketed over Tk 2 crore as 'special speakers,' 'course advisor,' and 'course director'.

### Mohammad | Anti-Aedes campaign in Ctg tomorrow

A daylong anti-Aedes mosquito campaign will be launched tomorrow in all districts and upazilas of Chattogram

The decision was made at a coordination meeting to kill Aedes mosquitoes and prevent dengue, organised by Chattogram division and district commissioners at Chattogram Circuit House.

Chattogram City Corporation Mayor AJM Nasir Uddin was the chief guest, with divisional commissioner Abdul Mannan in the chair. Mannan said the dengue situation in Chattogram is

much better compared to the rest of the country. Some 1,100 patients were identified with dengue fever in the 11 districts while 400 patients were undergoing treatment. "Of them, only two patients, one in Cox's Bazar and

another in Noakhali, died," he said. However, authorities should not be lax in dealing with the situation, he added. Mayor Nasir said making people aware and getting them involved in cleanup campaigns is key to destroying breeding grounds of mosquitoes. "CCC has been prioritising this matter from the very beginning of the season," he added.

Deputy Commissioner of Chattogram Ilias Hossain suggested conducting a one-day programme to destroy Aedes mosquitoes and their breeding grounds, and his suggestion was later accepted at the meeting.

### College student killed in Rajshahi

STAFF CORRESPONDENT, Rajshahi

A college student was killed in Rajshahi yesterday, while he was returning home in Dinajpur to celebrate Eid.

The victim -- Fardin Isna Asharia Rabby, 18, son of Mozaffar Sarker of Parbatipur -- was a 2nd year HSC student at Rajshahi Government City College, said Nibaron Chandra Burman, officer-in-charge of Boalia Police Station.

Informed by locals, police recovered his body -- in a pool of blood -- from the roadside in Hatemkhan area at 6am, he said.

Police said they were yet to find an eyewitness, although the crime scene is within 100 metres of a local mosque, and the murder happened around the time of Fajr prayers.

"Analysing the crime scene, we think it was a planned murder," the police official said. He said, the victim's body bore a single stab injury on the head and his bag, watch, mobile phone and wallet were found intact on the scene.

Rabby's blood-stained fingerprints were found on a nearby electric pole, said the police officials, suggesting that

He went out of his room at a private dormitory in the area at 5am to catch the intercity train Titumir Express --

scheduled to start for Dinajpur at 6:20am. He was supposed to travel along with his friend and classmate Ripon Mohonto.

"I was waiting for him at the station and called him repeatedly. He answered at 5:20am and said he was walking to the station. I couldn't reach him again," Ripon said.

At 6:20am when Ripon boarded the train, police called him from Rabby's phone and asked him to come to the police station. Police interrogated Ripon and another classmate Badsha Sekandor.

Rabby's sister Mansura Parveen filed a murder case with Boalia Police Station, accusing unnamed miscreants.

### Unapproved cattle market set up by Dhaka-Aricha highway

Local administration yet to take action

A cattle market has been set up in Savar's Ulail without permission from local administration, on the same ground that municipality authorities earlier failed to get a lessee for despite inviting tenders

For the last three years, Savar municipality authorities have been leasing out the Ulail Balur Matth, a land beside the Dhaka-Aricha highway, for a temporary cattle haat ahead of Eid-ul-Azha. The municipality earned Tk 44 lakh from it in 2016, Tk 48 lakh in 2017 and Tk 62 lakh last year, according to official sources.

This year, two tenders were submitted

for the market but both were rejected for being incomplete. Municipal authorities called for tenders a second time but found no bidders.

However, a cattle market has sprouted on the grounds.

Sharf Uddin Ahmed Choudhury, chief executive officer of Savar municipality, said they did not award any lease, as no one bought tender applications in the second phase of invitations.

This correspondent visited the cattle market on Monday evening, where livestock were already seen lined up for sale, and loudspeakers blared invitations to locals to visit the haat.

### Authorities backtrack after animal rights group intervenes

An animal rights organisation has raised allegations against Cumilla City Corporation (CCC) of violating a high court order against indiscriminate culling of dogs -- in different places of the city.

In a press release, Rakibul Haq Emil, chairman of People for Animal Welfare (PAW) Foundation said, "Cumilla Ĉity Corporation has been killing dogs indiscriminately for the last 15-20 days, in blatant violation of a high court order against killing dog, and what is a punishable offense according to section 7 of Animal Welfare Act 2019.

Sharing a video in which some men were seen picking up dogs using metal tongs and putting them in a cage, Emil claimed that conservancy staff of CCC were catching dogs in a brutal manner.

In a phone conversation with a representative of PAW Foundation, Alamgir Hossain, inspector of conservancies of CCC admitted that dog culling had taken place. "I know about the order of the high court. We are conducting drives because local residents report against dogs.

He claimed they were only picking up "sick" dogs, but could not confirm that the dogs were rabid, or how many people were bitten by dogs. He further said they were doing it upon "oral permission from mayor and councilors," and would not do it any more.

The Daily Star obtained a recording of the conversation, but could not reach Alamgir despite repeated attempts.

About the allegation, CCC sanitary inspector Mejbah Uddin said, "Everyday people come to us with allegations of dog bites. Dogs have bitten a primary school teacher, some college girls, and many people including school students have been complaining against dogs."

CCC Mayor Monirul Haque Sakku, said, "Everyday a lot of people come to us complaining against dogs. As it is against the law, we will not carry out any drives against dogs any more. We only used to do it if anyone complained.'

Dr Md Mozibur Rahman, Civil Surgeon of Cumilla told this newspaper, "Cumilla General Hospital is treating 50 to 100 people daily from all over the district who were bitten by dogs. In recent times, we did not identify any rabiesinfected dogs or patient, but in general if a dog bites several people it is thought to be rabid."

#### Change of Kashmir's status

Scrapping Article 370 and more

N an unprecedented but not quite unexpected move, the BJP government has scrapped the 70-year-old Article 370 of the Indian Constitution that had accorded a special status to the state of Jammu and Kashmir (J&K). In fact, this was one of the points in the BJP election manifesto in the last general election which it has followed through on. But not only that, the BJP government has also bifurcated the state into two with J&K and Ladakh becoming Union Territories, the latter coming under the direct rule of New Delhi.

Admittedly, this is patently an internal affair of India, and under normal circumstances might neither merit any comment nor evoke much international interest were it not for the fact that the issue has to do with J&K. The state has a unique dynamic of its own, and the political developments in Kashmir have both direct fallouts and trickle-down effects. It affects not only the countries of South Asia but the consequences also go much beyond the region. One cannot lose sight of the fact that India and Pakistan have gone to war on Kashmir thrice since the partition of the subcontinent.

While it is not for us to question the rationale of the Indian leaders, who in their wisdom have thought it fit to do what they have done with Article 370, one is curious to ask, why, after seven decades, a ruling party in India thought it was appropriate to change a political dispensation accorded to a state whose accession to the Union of India in October 1947 was effected under a situation which was far from normal. While the BJP narrative is that the new arrangement has been compelled by the prevailing internal situation in J&K, the party also feels the new arrangements would enhance the development of the region. However, critics traduce the move as blatantly political and ascribe motives that go beyond the pious desire to bring peace in the valley.

The state of J&K has been strife-ridden for a while but statistics show that the incidents of terror have gone down considerably in the state post-1990s. One only hopes that the desired purpose for which the Act was repealed would be fulfilled, alienation of the people of J&K would disappear, and there would be lasting peace and

#### How much does a lecture cost?

Expenditure on 'training' by EC should be investigated

news report that was published in the front page of a leading Bangla newspaper on August 6 gives us pause to think about the flagrant way in which money is spent by the Election Commission (EC). EC records show that each commissioner has given 520 speeches in 18 days, which translates into 14 public speeches every day—a feat that is not possible for any

It is the job of the EC officials to carry out training for its officials to conduct elections. So why should they be paid to give lectures? We are informed that people who took money as "special" guest speakers include the chief election commissioner himself, and the four election commissioners. These officials can at best take travel/daily allowance to go to various venues in the country, but what sort of message does it give out when they take money for giving lectures which is their job?

A former election commissioner has stated that during his time in office, no EC official received any monetary benefit for speeches they gave in different parts of the country as part of training officers on the conduct of electoral procedures. The report also points out that a particular secretary, who had been deputed to the EC during the last national elections, had received Tk 47 lakh as a course "adviser". We are aghast to think that a part of the public money for the purposes of training—a total of Tk 123 crore which was allotted to conduct training for the last general election and upazila elections—has been

The EC is a constitutional body and it plays a crucial role in conducting elections in the country. The officials employed by the EC are supposed to be people of integrity and hence when questions are raised about the way money meant for training is being spent, it shows blatant disregard for public money by the people running the EC. This is a serious matter and it needs to be properly investigated. As the government has adopted a "zero-tolerance" policy towards corruption, no stone should be left unturned to preserve the sanctity of the office of the EC.

In Bangladesh, according to unofficial sources, so far this year, at least 60 people have succumbed to the deadly menace caused by Aedes mosquitoes. And a staggering 27,437 people have been infected with the disease. This is more than double the number of dengue cases last year (10,148). Government figures, however, put the death toll at 18.

With the increase in the number of dengue cases, various narratives have emerged from different quarters, including the government, the city corporation and the politicians. While the prime minister has urged the countrymen to keep their surroundings clean and has instructed her party leaders and activists to conduct countrywide cleaning campaigns to battle the dengue outbreak—with dolled-up celebrities instantly obliging by taking to the streets with brooms to swipe away the mosquitoes—the Local Government Division (LGD) minister of her cabinet, Md Tazul Islam, claimed that dengue was "under control", as hospitals kept scrambling to accommodate the influx of newly infected patients.

And although DSCC Mayor Sayeed Khokon has said that dengue "cannot be called an epidemic yet", the number of people infected by the disease is increasing by the hour, setting a new record for the country, every day. With the health minister, after his recent return from Malaysia, sensing conspiracy centring dengue, it is unclear how many more lives will be wasted before we can counter the conspiracy of the mosquitoes against the human race.

On Monday, the health minister claimed that the number of dengue cases was coming down, the same day 2,065 dengueinfected people were admitted in various hospitals across the country, the highest number of dengue patients to be admitted in hospitals in a day this year. The very same day, the country also witnessed the highest number of deaths (seven) related to dengue in a 24-hour span. Such comments coming from government authorities reflect either their ignorance or their apathy towards the sufferings of the common

Narratives have been quick to emerge.

What has unfortunately been slow in coming, however, are initiatives by the concerned authorities to tackle the dengue outbreak. From the use of ineffective pesticides to the inadequate supply of mosquito repellents in the market, the people of this country are having to face multiple hurdles day in and day out just to protect themselves and their loved ones from lethal mosquito bites.


Adult Aedes population in Dhaka has increased manifold over the last few months. According to a report by The Daily Star, a recent Directorate General of Health Services (DGHS) survey shows that the current density of adult vector Aedes population in the country is 487, which is almost 14 times higher in comparison to

the comparatively limited concentration of Aedes mosquitoes in the off-peak season will only make it easier for the city corporations to contain their numbers.

Professor Rahman also added that spraying pesticides on roadsides is not very effective in containing Aedes mosquitoes; instead focus should be on destroying mosquito larvae, and for this, workers will need to visit individual houses to inspect them and destroy the larvae. A similar view has been shared by the World Health Organization (WHO) which recently suggested that fogging the streets and roadsides might not be effective in destroying mosquitoes, since Aedes mosquitoes travel less and mostly stay in darker places. The WHO recommended

The city corporations' fix over the pesticide issue and the lack of pace in importing an effective pesticide reflect poorly on their preparedness and ability to combat this disease.

The authorities did take up some measures though, including waiving tax on dengue testing kits, site inspections and fixing rates for dengue tests; however, these measures can at best be considered piecemeal initiatives, with very little impact on long-term protection from the disease. The government's knee-jerk reaction to the dengue outbreak reveals the lack of a policy framework that is of the essence now, in order to combat and, if possible, eliminate this disease from the country. The government must now roll



only 36 in the pre-monsoon period. The pre-monsoon study was commissioned between March 3 and 12, while the recent survey was conducted between July 17 and 27, in 100 locations around the capital. The survey also reveals that the concentration of mosquito larvae is high, which essentially means more Aedes mosquitoes and a further spread of the disease.

While discussing the ongoing dengue outbreak across the country with this writer, Professor Mahmudur Rahman, former director of Institute of Epidemiology Disease Control and Research (IEDCR), suggested that the city corporations should intensively conduct anti-Aedes drives across the country round the year, since dengue is not a seasonal disease. If exhaustive drives are continued throughout the year. it will be easier to combat the prevalence of dengue during the peak season; and

using mosquito aerosol at home and leave temephos, a larvicide, in water containers, to contain mosquito-breeding.

With dengue spreading across the country, one wonders how long it would take for the new insecticides to arrive and contain the situation. On August 2, DNCC Mayor Atiqul Islam said that new samples of insecticides to kill mosquitoes "will arrive in a day or two." According to a newspaper report, DSCC has started testing a sample of a new US-made pesticide since Friday, with a success rate of up to 26 percent. According to the same report, entomologist Professor Kabirul Bashar of Jahangirnagar University has suggested that the success rate of a pesticide below 80 percent is not satisfactory. Another sample of pesticides has arrived from India lately, which will also be tested to assess its effectiveness.

up its sleeves and get down to work to prepare a dengue prevention and control policy to curb its increasing menace.

With so many quarters making so many comments, and so little effective action being taken, people have resigned to their fate—living in constant fear of mosquito bites. News of fathers burying little children and husbands burying expecting wives and their unborn babies have become a common feature on the front pages of our newspapers. And amidst all this, the only thing that is shining bright is the failure of the concerned authorities to save people from the grip of a deadly disease that could have been contained at an early stage with comprehensive planning and effective implementation.

# How Bangladesh can improve access to climate funding



Agreement of the United Nations Framework Convention on Climate Change (UNFCCC), rich countries have promised to provide, collectively, USD

the Paris

100 billion every year to support the developing countries tackle climate change, both by mitigation and adaptation.

The UNFCCC also set up the Green Climate Fund (GCF) with its headquarters in Korea to handle a significant part of these funds. The GCF started with around USD 10 billion that has been allocated over the last few years and they are currently seeking a major replenishment from richer countries.

The GCF Board also made a laudable early strategic decision to allocate half the funds to mitigation and half to adaptation and to prioritise the most vulnerable and poorest developing countries for adaptation funds.

In practice, however, while allocation for mitigation projects has been relatively better, allocation for adaptation has been slow and allocation for the poorest and most vulnerable countries has been quite

The GCF also laid out a complicated set of procedures for countries to prepare proposals and have national-level accredited institutions to be eligible to submit proposals. This is one of the major reasons for the inability of the most vulnerable developing countries to get accreditation and submit proposals for funding.

The GCF is going to hold its major annual event with partner countries in Korea in late August and this column is the first of three columns that will shed light on the topic of how Bangladesh and other vulnerable countries can more easily access the funds meant to support adaptation actions at national and local levels.

accreditation proved to be quite onerous and difficult and only two entities managed to get accredited after nearly two years of back and forth with the GCF.

These two entities are the Infrastructure Development Company Limited (IDCOL), which specialises in renewable energy projects for mitigation, and the Palli Karma Sahayak Foundation (PKSF), which specialises in adaptation projects, especially for vulnerable communities.

Both these agencies are now in the process of submitting project proposals for funding (but none has been approved yet).

At the same time, the government of Bangladesh applied for two projects through multilateral agencies which were already accredited by GCF. The first one was a project for building climate-resilient infrastructure by the Local Government Engineering Department (LGED) through

a German development bank called KFW. The second was a project to provide fresh drinking water to pregnant women, and others, in the low-lying coastal districts already suffering from salinity in drinking water which adversely affects pregnant women. This was to be implemented by the Ministry of Women and Children's Affairs (MoWCA) submitted through UNDP which is already accredited. Both these projects were finally approved by the GCF and are about to start being implemented by the concerned agencies.

Bangladesh's success rate in accessing GCF funding has been moderate but not great. It is important that all the relevant institutions both within and outside the government get up to speed in the procedures for accessing climate change funds available through the GCF.

While it has taken a long time to set up the correct institutions and build our own capacity to follow all the complicated procedures of the GCF, we are going up the knowledge curve and need to improve our understanding and performance. This will be particularly important as we enter the next phase to enable NGOs and private sector entities to apply and get accreditation for the private sector window of the GCF which Bangladesh has yet to tap.

Finally, while developing our capacity to access more climate funding, it is also important for us to come up with good monitoring mechanisms to ensure that the money is actually used for the purpose it is meant for. Our access to potentially larger amounts will depend on spending the money we get well and effectively.

## Life after Article 370

Abolition of 'special status' of Jammu and Kashmir calls into question India's traditional vision of unity in diversity

T was a dramatic momentous Monday for Jammu and Kashmir. In one go, the Bharatiya Janata Party-led Indian government put the militancy-hit state in a new template of its future journey along a path that is set to be very different from the

one it has treaded for the last seven decades since the accession of the princely state to India after Partition in 1947.

On August 5, Home Minister Amit Shah introduced two bills and two resolutions regarding Jammu and Kashmir in the Rajya Sabha that repealed Article 370 of the Indian Constitution—which gave the state a special status—and bifurcated the state into two federally-administered territories, drastically reducing its powers to function with a greater degree of autonomy and putting it under the decisive control of the federal Indian government.

All the bills and resolutions were passed with emphatic majority by the Rajya Sabha where the BJP and its allies lack a favourable arithmetic, thanks to the government's deft management in bringing the lawmakers of some opposition parties and a group of key regional parties on board to back its most audacious move on Kashmir. India has not witnessed such landmark legislative amendments with far-reaching ramifications for its polity within a day. The abrogation of Article 370 came after much speculation about the massive security build-up in Jammu and Kashmir over the last one week and about the strategy of the government of Prime Minister Narendra Modi.

In his speech while announcing the revocation of Article 370, which has since long been one of the three pillars of the BJP's Hindutva ideology and vision of India, Amit Shah viewed Jammu and Kashmir's past



and future through the prism of economic development or rather the absence of it. An overwhelming portion of his speech was devoted to how Jammu and Kashmir has lagged behind in economic progress and how robust economic infrastructure can turn the state around by attracting private investment and increasing employment opportunities for the youth. He pointed to Article 370 as the source of all problems in Jammu and Kashmir—economic backwardness, lack of democracy, corruption and terrorism. Postrepeal of the Article, he said, doors to private investment in the state would be opened, which would in turn increase the potential for development there. Land would be opened up for purchase which would bring in investments from private individuals and multinational companies and give a boost to the local economy, he added.

Article 370 did not allow people from outside Jammu and Kashmir to do business there and led to the absence of economic competition, the home minister said, and he pointed out that "land prices are at rock bottom because no one can buy land there and no industry is allowed to flourish there." Over the decades, the Indian government pumped hefty funds into the state but adequate educational and health services were missing. Article 370 prevented skilled professionals from outside the state to settle down there and prevented some of the welfare schemes of the Indian government from reaching the people of Jammu and Kashmir.

There appears to be a short-term and a medium- to long-term strategy behind the Indian government's actions. It is quite possible that Prime Minister Modi will come up with plans of mega investments and other measures for Jammu and Kashmir which would help generate jobs for locals as well as plans for land allotment for setting up industries and incentives for private sector investments. The assumption is, economic prosperity would alleviate the sense of

alienation among the people of Jammu and Kashmir and drive them away from the appeal of militancy.

Interestingly, the economic-developmentand-good-governance narrative was flagged upfront in Indian Foreign Secretary Vijay K Gokhale's briefing of envoys of key countries, including the five permanent members of the UN Security Council, explaining the rationale behind the repeal of Article 370. Thus, the Modi government deftly cloaked its Hindutva plank with the robe of a grand economic vision for Jammu and Kashmir. So, the performance of the Modi government in delivering economic progress to the state would be its biggest challenge in the time to come.

Abrogation of Article 370, construction of a Ram temple in Ayodhya and introduction of a uniform civil code have, for decades, served as the three key pillars of the BJP's Hindutva agenda. They had so far remained statements of intent because the party had lacked the requisite parliamentary strength and astute political management to overcome adverse legislative arithmetic to implement them. But the Modi government has a reputation for taking calibrated risks when it comes to furthering its foreign policy (as was seen in Modi's unscheduled stopover in Lahore to meet Nawaz Sharif, the then Pakistan PM, in December 2015) and its ideological planks at home (witnessed by its daring foray into Muslim personal law and outlawing the

practice of instant triple talaq last week).

The parliamentary passage of the bill against instant triple talaq, which the BJP projected as a gender-justice issue, and scrapping of Article 370 are set to find greater salience among the growing constituency of Hindu nationalists and position these changes as an alternative to Jawaharlal Nehru's vision of secularism. While the law against instant triple talag is seen by many as the BJP's march towards a uniform civil code, the majority of the public pulse in India today is against the continuation of Article 370. The BJP's assessment was that the time was ripe for abrogation of Article 370 as most of the mainstream political parties stand accused of failing in governance, indulging in corruption—feasting on the Indian government's financial assistance to the state—and milking the autonomy issue for perpetuating the status quo.

There is little doubt that after the repeal of Article 370, the BJP will up its ante in re-shaping the future of India, calling into question the Nehruvian ideas of secularism, citizenship and federal structure and the traditional vision of India's unity in diversity. With the opposition fragmented and in a quandary about its own future after this year's parliamentary poll debacle, the BJP is expected to push through its Hindutva planks with more aggression.

The abolition of Article 370 has set off anxiety in the entire north-eastern India where almost all the seven states have special laws barring sale of land to "outsiders" and allowing for preservation of local social and religious practices. Should different ethnic, religious and linguistic communities be viewed through the lens of their distinctiveness and not as part of a monolithic structure? This fundamental question will now be increasingly asked across India post-demise of Article 370.

## Fighting a different kind of war

Millennial 'burnout' and why this generation simply cannot seem to catch its breath

process. The Dutch have even coined a term for this luxury: "Niksen", which, in plain English, translates to "enjoying idleness" and which, in plain reality, is an almost impossible task for Gen Y.

Being born during the time bracket of 1981-1996 may have its bright sides (we were thankfully spared the horrors of the World Wars and the Great Depression) but it was accompanied by its own set of stumbling blocks.

According to Chuck Palahniuk, author of *Fight Club*, "Our generation has had no Great War, no Great Depression. Our war is spiritual. Our depression is our lives." With all that has been unfolding in our era, which is taut with economic and political tensions, this generation has been suffering. The millennials, the witnesses and the unenthusiastic participants of the seismic changes worldwide are struggling to stand out and fit in at the same time. They cannot seem to heave a sigh of relief or catch a break. At all.

Psychologist Herbert Freudenberger came up with the term "burnout" in 1974—which describes a constant state of chronic stress resulting in physical and emotional fatigue—and in 2019. Anne Helen Petersen made her readers re-adjust in their seats when she associated millennials with this very condition. Her viral Buzzfeed article titled "How Millennials Became the Burnout Generation" stirred all kinds of reactions among its readers—from mass approval to mocking scoffs. For a generation that is rebuffed for being lazy, whiny, confused and is frequently asked to "grow up", especially by the Baby Boomers, the concept of "burnout" may appear to be yet another generational idiosyncrasy that is simply romanticising laziness or glorifying exhaustion. According to many critics, the burnout syndrome may be a cover-up for millennial lethargy.

But the picture is far more complex because this demographic group has been caught right in the eye of the vortex of massive turbulent and unpredictable changes throughout their lives and has constantly been pressurised to thrive under these circumstances.

The pace of the global economic and political shifts fuelled by social media, cellphones and advanced technology has created an alarming degree of disillusionment and frustration among these people. From the dominance of Facebook

and Netflix to the downfall of TV and radio, from China's accession to the breakneck speed of the fourth industrial revolution, from widespread terrorism, rampant corruption and rising debt to the sense of foreboding that the world is nearing its doomsday—all these factors have been at play at the time this generation was coming of age. And let's not forget the universal threat of global warming. The future seems so bleak for this generation that they have to continuously hear about the blaring warning of climatic catastrophes in the coming decades when their career/family life may be at its peak.

Combine these factors with the exclusive features of a millennial's trajectory—intensive parenting, striving for perfection in personal and professional domains, neoliberal meritocracy and of course hyperconnectivity and information overload—and what we have is

generational panic.
According to a 2018 report by the

Blue Cross Blue Shield Association, a federation of a number of US health insurance organisations and companies, there has been a 47 percent rise in major depression among millennials since 2013 and they have the highest incidence of anxiety compared to all other generations as substantiated by the American Psychological Association. The disturbing undertone of these statistics is how millennials have to bear the brunt of a world that is constantly in transition, and yet they are deemed as "entitled" adults with a perpetual sense of ennui.

But one could argue about the context of historical tunnel vision as surely the previous generations had their own share of adversities. Historians and cultural enthusiasts speak of the widespread feeling of listlessness, *acedia*, in medieval times

that prevented true connection with God, or the condition recognised in the nineteenth century, *neurasthenia*, that referred to extreme stress on the nervous system due to the advent of the industrial society. But how is millennial burnout different enough to be causing this generation to turn into cases of a neurotic mess?

Victims of millennial burnout easily become guilt-ridden and cannot rest even for short periods of time, and this is where the burnout of this generation diverges from the concept of simple fatigue—where an act of repose feels rewarding and does not leave any feelings of guilt afterwards. In the curious case of the millennials, a period of rest or inactivity may not mitigate their stress but rather aggravate it. They get conscience-stricken for not utilising every moment to work towards their goals, pertaining to both their personal and professional life.

Anne Helen Petersen talked about "errand paralysis"—a condition where doing simple chores becomes overwhelming. This burnout also induces cynicism, low self-esteem, depleted energy levels and insomnia, which might overlap with the already prevalent problems of depression and anxiety. Many millennials already suffer from the Imposter Syndrome—they credit mere luck for their achievements and feel paranoid about being exposed as frauds. One of the things that have given rise to this condition is over-expectation from guardians who adopted parenting strategies that sent mixed signals, switching between overpraising and harsh criticism.

Other factors include societal pressure which comes along with the constant nagging sense of "always having to prove a point", technological advancement, fierce competition in a cut-throat job market and the dire need to achieve perfection in all aspects of life exacerbated by social media comparisons. Social media instigates millennials to fall into a sad spiral of comparisons. They then resort to posting Instagram pictures of themselves, brandishing their "good life"—#LivingTheMoment. They paint a picture of themselves as young, exuberant and accomplished whereas in reality they are in distress.

This overworked, overexposed and overstimulated generation has to navigate itself through the maze of socially constructed standards of career, beauty and relationships, being thrown at them by screens of all sizes. They work relentlessly. They are swimming in debt. They are struggling to attain the same living standards as their parents, while striving for perfection in the face of constant upheavals. Their inner battles are taking a collective toll on their psyche and yet they have to maintain a stoic disposition of having everything under control.

This situation is somewhat akin to the "Stanford Duck Syndrome", a term that means putting up a facade of false ease. Picture a duck floating on water, gliding effortlessly, but

below the surface, its duck feet are paddling furiously. Millennials are not any different. It may look like they have it together, but underneath it all, they are scampering frantically

and are running out of breath. They are fighting a different kind of war.



## Legal challenges to test move

REUTERS, New Delhi

India's move on Monday to strip Kashmir of special rights is likely to face legal challenges, constitutional experts and Supreme Court lawyers said, with some questioning the legality of the route used to make the change.

New Delhi's action also provoked condemnation in Pakistan, which has disputed sovereignty over Kashmir with India for decades. India's revocation of the Himalavan territory's special status is a bid to fully integrate its only Muslimmajority state with the rest of the country.

Indian Home Minister Amit Shah said the government would scrap the constitution's Article 370 that grants special status to Jammu and Kashmir state and allows permanent residents rights to property, state government jobs and college places.

To do so, it used a provision under Article 370 of the constitution that allows the law to be tweaked by a presidential order - provided there is consensus in the constituent assembly of Jammu and Kashmir.



constituent assembly of the state was dissolved in 1956.

The government has tweaked another constitutional article so that a reference in Article 370 to "constituent assembly of the state" becomes "legislative assembly of the state". The legality of that move, the lawyers said, could be questioned in court.

Furthermore, New Delhi said all the changes were agreed to by the state government. And that, some lawyers say, could be another issue for the government of Prime

One problem, though, is that the Minister Narendra Modi as there currently is no government in Jammu and Kashmir.

For the past year the state has been under presidential rule, after Modi's Bharatiya Janata Party (BJP) pulled away from an alliance with a local Kashmiri party and dissolved the state assembly.

"If there is president's rule, then how does that work? Does it fulfil the requirement?" said senior Supreme Court advocate Akhil Sibal. "That to my mind would be the legal faultline.

Malavika Prasad, a constitutional

lawyer, said: "How did the government of Jammu and Kashmir concur with the changes if the state has been under presidential rule for

Shah said earlier on Monday that the changes would pass "every legal scrutiny." But lawyers said they expect several petitions challenging India's changes to Article 370. One group of lawyers in New Delhi is already working on a possible petition, an attorney said.

There could also be legal objections to related government legislation concerning the division of Jammu and Kashmir into two entities, including a separate Buddhist-majority but sparselypopulated mountainous territory, Ladakh. That law will rely on the constitutional changes made on Monday.

Critics of Modi's government and the BJP have accused it of changing the constitution to shift Jammu and Kashmir's demographics - it is currently majority Muslim - as well as to pander to many in its Hindu nationalist base that have long demanded the right to own property in Kashmir.

## Water bankruptcy looms

Researchers warn one in four people worldwide will soon face dangerous water shortages

A quarter of the world's people are just a few dry spells away from facing dangerous water shortages, a US think tank warned yesterday, with India home to the bulk at risk of running dry.

Seventeen countries face "extremely high water stress" because they consume 80 percent of their available water annually, a situation worsened by more frequent dry shocks tied to climate

change, the World Institute Resources (WRI) said.

currently "We're facing a global water crisis," said Betsy Otto, director of WRI's global water program.

New data in WRI's Aqueduct Water Risk Atlas showed the lion's share of the most thirsty countries are located in the largely arid Middle East and

North Africa region. Qatar is the most water-stressed country, followed by Israel and Lebanon.

India ranked 13th among "extremely high" water-stressed nations. But with a population of more than 1.3 billion, it has over three times more people than the other 16 countries combined whose agriculture, industry and municipalities depend on avoiding water "bankruptcy".

In recent weeks, India's sixth-largest city, Chennai, was the latest metropolis worldwide to warn its taps could run dry, as reservoir levels plunged.

That followed similar countdowns to water "Day Zero" in South Africa's Cape Town last year and Brazil's Sao Paulo in 2015, WRI said.

"We're likely to see more of these kinds of 'Day Zeros' in the future," said Otto.

The world's water supplies are threatened many factors, from climate change mismanagement in the form of water waste and pollution, Washington-based WRI said.

groundwater supplies - difficult to measure and manage because they are buried deep is an additional concern, Paul Reig, who leads work on the Aqueduct Water Risk Atlas, told journalists.

Nearly a third of the world's fresh water is groundwater, according to the United States Geological Survey.

"Because we don't understand (groundwater), and don't see it, we manage it very poorly," Reig said.

The Philippines yesterday stood firm on its ban on the world's first dengue vaccine while declaring a nationwide epidemic from the mosquito-borne disease

that it said has killed

hundreds this year. Dengue incidence shot up 98 percent from a year earlier to 146,062 cases from January 1 to July 20, causing 662 deaths, Health Secretary Francisco Duque told a news conference in which he announced a "national dengue

epidemic" Manila banned the sale, import and distribution of the Dengvaxia vaccine in February following the deaths of several dozen children who were among more than 700,000 people given shots in 2016 and 2017 in a government

immunisation campaign. Duque said Thursday the government is studying an appeal to allow French pharmaceutical firm Sanofi to put the vaccine back in the Philippine market, but ruled out using the drug to combat the ongoing epidemic which has hit small children hard.

The vaccine, now licensed in 20 countries according to the World Health Organization, is approved for use for those aged nine and older.

Duque said the United Nations agency also advised Manila that the vaccine was "not recommended" as a response to an outbreak.

Dengue, or haemorrhagic fever, is the world's most common mosquito-borne virus and infects an estimated 390 million people in more than 120 countries each year -- killing more than 25,000 of them, according to the WHO.

## Do not 'play with fire'

China tells Hong Kong protesters, warns them not to mistake Beijing's restraint as weakness

Protesters in Hong Kong must not "play with fire" and mistake Beijing's restraint for weakness, China said yesterday in its sharpest rebuke yet of the "criminals" behind demonstrations in the city whom it vowed to bring to justice. Hong Kong has suffered weeks of

sometimes violent protests that began with opposition to a now-suspended extradition law, which would have allowed suspects to be tried in mainland courts. But the protests have swelled into a broader backlash against the government

## Beijing warns of 'countermeasures'

China warned yesterday it would take unspecified countermeasures if the United States goes ahead with plans to deploy ground-based intermediaterange missiles in the Asia-Pacific region.

The comments come days after US Defense Secretary Mark Esper said Washington was now free to deploy the weapons following its withdrawal last week from the Intermediate-Range Nuclear Forces (INF) treaty with Russia.

"China will not stand idly by and will be forced to take countermeasures should the US deploy intermediate-range ground-based missiles in this part of the world," said Fu Cong, the director of arms control at the Chinese foreign ministry. "And we also call on our neighbours, our neighbouring countries, to exercise prudence and not to allow a US deployment of its intermediate-

range missiles on (their) territory," he added, naming Australia, Japan and "That would not serve the national security interest of these countries." Fu said it was important to recognise that the US is proposing to install

the weapons at China's "doorstep".

"Especially for a country that has experienced the Cuban missile crisis, I think the American people should understand China's feelings.

Australia on Monday ruled out the possibility of the missiles being deployed on its soil, saying Canberra had not even been asked to host

South Korea's defence ministry said it had not had any discussions with the US about the deployment of intermediate missiles.

"We have also not internally reviewed the issue and have no plan to do so," ministry spokesperson Choi Hyun-soo told reporters.

## Iran 'favours' talks

President Hassan Rouhani yesterday said that Iran favours talks with the US if it lifts sanctions against the Islamic republic, despite his top diplomat turning down a meeting with US President Donald Trump.

Rouhani said "peace with Iran is the mother of all peace" and "war with Iran is the mother of all wars" as he defended a landmark 2015 nuclear deal between Iran and world powers.

Tensions between Iran and the US have been rising since Trump unilaterally withdrew the US from the nuclear deal in May 2018 and began imposing sanctions on it as part of a "maximum pressure" campaign.

In response, the US ambassador on disarmament Robert Wood said: "Iran simply needs to make up its mind to decide what it wants to do".

However Rouhani described as "weird" the US approach of calling for negotiations and then slapping sanctions on Zarif.

#### **Taliban warns Afghans** against taking part in polls

The Taliban warned Afghans to keep away from election rallies and ordered its fighters to "stand against" the planned September vote. The militants and other insurgent groups conducted frequent attacks during previous elections, and this year's campaign season has already been rocked by deadly violence. The presidential election is slated for September 28, but the race has got off to a lacklustre start and some candidates have yet to launch their campaigns. Many observers think the poll will be postponed again -- it has already been pushed back twice this year -- to create space for a peace deal to be finalised between the US and the Taliban. In a statement, Ghani's office said security forces are "fully prepared" to protect Afghans against Taliban threats and would not allow anyone to disrupt polls.

## Venezuela accuses US


of 'economic terrorism' Venezuela's government yesterday accused the United States of trying to derail political crisis resolution talks with the opposition after President Donald Trump ordered a freeze on its US-based assets. The regime of President Nicolas Maduro, in a foreign ministry statement, denounced the US move as "another serious aggression by the Trump administration through arbitrary economic terrorism against the Venezuelan people." US national security adviser John Bolton yesterday called for tougher international action against Maduro. "The time for dialogue is over. Now is the time for action," Bolton said. "Maduro is at the end of his rope," Bolton said, warning Russia not to provide him with further support.

#### Korea tests missiles, slams US-S Korea drill

North Korea yesterday threatened to carry out more weapons tests after it fired its fourth pair of projectiles in less than two weeks following the start of joint exercises between the US and the South. The rising temperature on the peninsula threatens to derail putative negotiations between Pyongyang and Washington, with the North saying the combined drills were a "flagrant violation" of the process. Pyongyang has always been infuriated by military exercises between the South and US, seeing them as rehearsals for invasion, but in the past it has tended to avoid carrying out missile tests while the war games were taking place. The speed of its statement Tuesday was also unusual, coming within an hour of the launch, rather than the more normal day later.



## Indonesian leader threatens to sack firefighters

Indonesian leader Joko Widodo yesterday warned that officials would be sacked if they failed to stamp out rampant forest fires that are belching out toxic smog over Malaysia and Singapore.

The threat came as Indonesia faced pressure from its neighbours to douse the blazes, which are blamed for sending air quality plummeting in parts of Southeast Asia.

"I've told the military and police chiefs to sack people who don't tackle forest fires," Widodo told a ministers meeting on the issue in Jakarta.

"We'll be humiliated in front of other countries if we can't solve this haze problem.

"No matter how small the fire is, put it out immediately," he added. authorities Indonesian deploying thousands of extra personnel to prevent a repeat of the 2015 fires, which were the worst for two decades and choked the region in

The blazes are an annual problem during the dry season but they have worsened in recent weeks.

Many of the worst fires occur in carbon-rich peat, which is highly combustible once drained to make

Damascus and Russia resumed air strikes on Idlib in northwest Syria on Monday, a monitor said, scrapping a ceasefire for the jihadist-run bastion and accusing the regime's opponents of targeting a Russian air base.

The northwestern region, which hosts some three million people, is one of the last major centres of resistance to President Bashar al-Assad's regime after eight years of war.

Damascus said Thursday it had agreed to a truce from Friday to halt three months of regime and Russian bombardment on the area, which has killed more than 790 civilians and pushed 400,000 people from their

But jihadists running the region on Saturday refused to comply with a key condition to that truce, declaring they would never withdraw from a planned buffer zone around the area.

The Syrian Observatory for Human Rights said regime air strikes resumed on the region minutes after the truce was cancelled, before Russian planes

Russian planes pounded the western edge of the enclave, while aircraft from both sides resumed bombardment of its southern flank, the Britain-based war monitor said.

Further south, the monitor said four civilians were killed in regime barrel bombings on the town of Morek in the northern Hama region, adding that these were the first civilian victims since the regime bombardments resumed.

Earlier, an AFP correspondent saw the wind blow plumes of white smoke across the fields after planes and helicopters pounded Khan Sheikhun town in the south of the region.

A few families fled the town in cars or trucks piled high with their belongings, women and children perched on top, the correspondent

#### 11 dead, dozens missing in DR Congo boat accident

Eleven people have drowned and dozens are missing after a barge sank on a river in central Democratic Republic of Congo, authorities said

Sixteen people survived the accident on the overcrowded vessel by swimming to safety on the Lukenye river, a journalist working for a local community radio told AFP.

The disaster -- the latest in a string of deadly accidents in Congolese waters -- occurred a week ago in a remote and densely forested region of Kasai province where rivers are the main means of transport due to a lack of driveable roads.

"We have recovered 11 bodies and about 50 people are missing," Kasai governor Dieudonne Pieme told AFP.

The local journalist said most of those on board were travelling to the DR Congo capital of Kinshasa.

Boat accidents are common in the vast country, typically caused by overloading of passengers and cargo.

Tolls are often high because there are no life jackets and many Congolese do not know how to swim. In May, 32 people died in a boat

Aedes mosquito," said HM Nazmul Ahsan, associate professor at Shaheed Suhrawady Medical College Hospital.

Moreover, she said, school authorities will clean their school the day before classes begin on August 18.

As many travel to their ancestral homes to celebrate Eid, experts say the resulting empty apartments can become ideal breeding spots for Aedes mosquitoes, which can lay eggs in stagnant water sources left behind in pots, trays and under refrigerators.

Prof Mahbubur Rahman, also principal of Norail Govt Mohila College, who did his doctoral research on Aedes mosquito, said that if the several million people leaving Dhaka a three-year-old girl, died after during Eid do not clean up their apartments properly, it could become a big issue.

"If 50 or 60 percent of the people leave a single container with some water at their houses, chances of it becoming a breeding ground for Aedes mosquitoes is huge," he said.

Former director of Institute of Epidemiology Disease Control And Research Mahmudur Rahman urged all to clean all stagnant water at houses, offices and school premises after returning.

It is a regular phenomenon that people unknowingly leave some water in pots or the office toilet which was dangerous, said Mahmudur.

DGHS's Communicable Disease Control Director Prof Sanya Tahmina said they had taken different awareness measures centring the upcoming Eid

The Directorate General of Health Services (DGHS) director said they would urge Eid-vacationers to keep water storage containers, pots and other kitchen utensils upside down before leaving their homes during the vacation. "We will circulate this message

among people through bulk SMS service shortly," she said. Health experts said non-monitored

Dengue has spread to almost all the districts and health workers say it has claimed the lives of 65 people diagnosed with the disease. The government maintains that 23 have died of dengue so far.

many dengue cases go unreported.
A record 2,348 dengue patients got admitted to hospitals across the country in 24 hours since 8:00am Monday, according to a DGHS report.

A total of 29,912 people have been infected with the mosquito-borne disease until yesterday, the highest ever in the country. Last year the number was 10,148.

BN Nagpal, senior entomologist at the South East Asia Regional Office of the World Health Organization, at a press briefing at the DGHS on Sunday said it was very important to search for and destroy Aedes mosquitoes.

He said the onus was on people to stop the spread of the disease, adding 'source detection" was the key.

"It can breed even in 2ml water,"

"It's a smart mosquito. It does not rest on walls. It rests under the tables, beds, sofas, curtains, hanging clothes and dark places," he said, suggesting spraying those places with aerosol during the peak time of the mosquito's activity.

## Floating Aman seedbeds to overcome seedling crisis

KM REZAUL HOQUE, Gaibandha

Prolonged flood in the char lands of Gaibandha district has completely damaged aman seedlings causing local farmers to worry about their crops. However, with advice from agriculture officers, farmers found a solution in the floating seedbed technology

This year the Brahmaputra river rose 150 centimetres above danger mark, the highest in two decades, and inundated croplands including aman seedbeds.

According to district agriculture extension office, aman seedlings on 2,881 hectares of land in Gaibandha went under five to seven feet of standing water, damaging all prospect of transplanting the seeds in the next phase of aman cultivation.

Instead of waiting for the water to subside for preparing regular seedbeds on land, the agriculture department advised farmers to prepare floating aman seedbeds on the floodwater.

This way the saplings will be ready for transplantation in time within the aman cultivation season and also not get damaged if another flood occurs.

While visiting the flood ravaged unions of Sundarganj upazila, farmers were seen sowing aman seeds on floating beds made from heaped up water hyacinths and

"I have prepared two floating beds as suggested by our upazila agriculture officer and sowed seed of BRRI- 51 aman variety. The seedlings can later be transplanted to cover four and half bighas of land," said

Raju Mia, a farmer of Ramjibon union in talk to the agriculture department and Sundarganj upazila.

BRRI- 51 aman, a flood tolerant variety suitable for flood prone areas, specially char lands along river basins, survives for two weeks under water, said SM Sarower Hossain, sub-assistant agriculture officer of Ramjibon union.

Another farmer Rafiqul Islam of Bochagari village in Kapasia union, said "My aman seedbed on five decimals of land, which could have been transplanted on five bighas of land, got damaged in the recent flood. The land would remain fallow if I do not arrange aman seedlings

When asked why Rafigul did not prepare floating seedbeds, he said, "I don't know how to do so but I will try to start it soon.'

Reza-e-Mahmud, Agriculture Officer (UAO) of Sundarganj said at least 32 floating seedbeds have already been prepared in different areas of Sundarganj Upazila, some people have leased water bodies to prepare floating seedbeds to sell saplings commercially.

Deputy Director S M Ferdous of the Agriculture Extension Directorate, Gaibandha, said, "As per instruction of the agriculture ministry, we have selected 56 farmers of seven upazilas of the district, trained them, and gave each of them an incentive grant of Taka 1165 to prepare floating seedbeds."

This will encourage other farmers to follow suit, he hoped.

#### Injured madrasa girl cannot return home

A female madrasa student of eighth grade has been staying away from her home in Kulaura upazila of Moulvibazar as her stalker, who stabbed her on June 30, has been making threats on her and her family to withdraw a case against him.

The girl's family filed the case with Kulaura police station the day after the attack.

According to the case statement, Ruhul Amin, 22, son of Monaf Mia from a neighbouring village, along with two others stopped the girl on her way to the madrasa in the morning and demanded her to accept his marriage proposal.

As she refused, Ruhul and his accomplices beat her up with bamboo sticks and at one stage, they started hacking her with sharp weapons.

When locals responded to her cry for help, the attackers

Dr Zakir Hossain, resident medical officer of Kulaura Upazila Health Complex, said the injured girl was initially admitted to the health complex and later transferred to Sylhet MAG Osmani Medical College Hospital.

Afraid of possible repercussions, the girl and her family have been staying at undisclosed locations after she was released from the hospital.

Family members of the girl said they could not return home out of security concern as no security was provided for them despite repeated threats made by the attackers, roaming free in the area.

Asked about the alleged threats made by the accused, the police station Officer-in-Charge (OC) Yardous Hasan said Ruhul secured bail after he surrendered before a

However, following the report of threats, they were conducting raids to arrest all the accused, he also said.

## Panchagarh growers leaning towards lotkon

QUAMRUL ISLAM RUBAIYAT, Thakurgaon

Mouth-watering fruit Burmese grape, commonly known as lotkon, is gaining popularity among growers in Panchagarh.

Rising demand coupled with good selling price and high yield are drawing most growers to invest in the fruit for commercial production in recent times.

Most growers are also taking interest in Burmese grape because its plant grows on higher land where other cash crops do not grow well. Many of them now find it more profitable to grow Burmese grape in betelnut orchards on such fallow land

Much to the delight of the growers, the commercially produced larger, tastier and bright-coloured variety of Burmese grape, especially from Panchagarh, is now in high demand across the country.

Abu Hanif, deputy director of Department of Agricultural Extension (DAE) in Panchagarh, said Burmese grape is being cultivated on nearly 35 hectares of land in betelnut orchards in the district this year.

The fruit is being cultivated on 28 hectares of land in Panchagarh Sadar alone, while on 7 hectares in other four upazilas of the district, he said, adding that climate condition in Panchagarh is favourable for Burmese grape, a fruit that contains higher nutritional value than most other common fruits grown in the region.

More and more people, who have betelnut orchards around their homesteads, are finding it attractive to grow Burmese grape alongside the betelnut trees after witnessing success of others and because the fruit tree grows well without much space.

Initially, around 200 saplings of Burmese grape can be planted on 30 to 35 decimals of land. After reaching maturity, a tree usually produces more than 40 kilograms of fruit, the DAE official also said.

During a recent visit to Panimachpukuri, Haribhasa and Boleyapara villages in Sadar upazila and Bhaulaganj Tistapara village in Debiganj upazila of Panchagarh, the areas were found abuzz with growers harvesting the fruit. Buyers from faraway places were also busy

packing the fruits for transport.

Hasan Ali, a fruit trader from Panimachpukuri village, said "Lotkon produced in Panchagarh has a high demand in other parts of the country for its good taste, size and colour."

He also said he paid Tk 5 lakh for harvesting the fruit from 1,000 trees in different villages and spent and additional Tk 1.20 lakh to nurture the trees. He hoped to make Tk 2 lakh profit from selling Burmese grape this season.

Currently, fruit traders are paying Tk 50 to growers for each kg of the fruit. Its retail price is now more or less Tk 100 per kg.

Another grower, Gokul Chandra Roy, said he planted 70 Burmese grape saplings in his betelnut orchard about two decades ago in Bhaulaganj Tistapara village of Debiganj upazila. After the trees matured this year, he earned Tk 2 lakh from the sale of the fruit.

The older the tree gets, the more profitable it becomes for the grower as a matured tree does not need as much care as opposed to the care it needs during the earlier stage, he also said.

Blacksmiths are passing busy time making sharp tools used for slaughtering sacrificial animals and processing the meat, as the Eid-ul-Azha is only a few days away.

Our Lalmonirhat Correspondent reports: A good number of people are approaching blacksmiths for machetes, choppers, knives and other iron-made tools.

Depending on the sizes of tools and quality of the iron used, machetes are priced between Tk 300 and Tk 800, butcher knives between Tk 200 and Tk 300, small knives between Tk 70 and Tk 200 and cleavers between Tk 300 and

Many blacksmiths have stopped receiving fresh orders to make tools as they are too busy, said Nur Islam, 48, a resident of Saptana in

Lalmonirhat town.

The demand of tools used for slaughtering animals sees a sharp rise during Eid while many people bring damaged tools for repair, said several blacksmiths including Subodh Kumar Karmakar and Suresh Chandra Karmakar at Mahishkhocha Bazar in Aditmari upazila during this correspondent's visit there yesterday.

Blacksmith Maqbul Hossain, 56, at Bhelabari Haat in Aditmari upazila said usually they earn Tk 400 to Tk 600 a day but it rises to

over Tk 1500 ahead of Eid. Knife sharpeners also get added work during this time. They are sharpening knives and cleavers for Tk 70 to Tk 100 per piece.

Other items used during slaughter of animals – pieces of tree trunks, bamboo mats and bags for

disposal of cattle waste are also in the local markets. high demand.

Citing gradual increase in prices of raw materials like iron, charcoal and wood as a problem, several smiths said facilities like banks loans on easy terms would help them make and market the tools easily.

Our Sylhet Correspondent adds: Blacksmiths are working long hours ahead of Eid-ul-Azha as people are coming for machetes, choppers, knives and other sharp iron-made

Considering the size of the tool and the quality of the iron, a machete is priced between Tk 500 and Tk 1,200, a butcher's knife between Tk 250 and Tk 500, a small knife between Tk 100 and Tk 300 and cleavers between Tk 400 and Tk 700 in

Topkhana, Kazirbazar, Mirabazar and Ambarkhana in Sylhet city are well-known for smithies while the tools are sold at every bazaar of the

While visiting the blacksmiths at Topkhana and Amberkhana area, this correspondent found that they are passing busy hours.

The sale this year is good although the price is higher than last year's, said Anongo Karmakar, a blacksmith of Topkhana area.

Several blacksmiths of the area said the period before the Eid-ul-Azha is the only time of the year when they do good business.

Blacksmiths demand support like soft loan from banks, so that they do not have to depend on moneylenders who charge high

#### Youth gets life term for murder

The following day, deceased's mother Romena Bewa filed a case with Tentulia Police Station against three people, including Rubel.

## 'No final word on Mash farewell'



The issue of Bangladesh ODI skipper Mashrafe Bin Mortaza's retirement is still a cloudy one as the Bangladesh Cricket Board (BCB) are yet undecided on

how to provide the inspirational cricketer

Making the issue murkier still is that the 35-year-old has not clarified his thoughts

As there are no more ODIs for Bangladesh this year in ICC's Future Tours Programme, there has been speculation about whether the BCB would arrange any fifty-over series at home to bid farewell to Mashrafe, who has already retired from T20I cricket.

There is a one-off Test and two T20Is against Afghanistan at home later this year. Plans are afoot to include Zimbabwe and host a T20I tri-series after the Test.

There was also talk about whether the BCB would change the T20I tri-nation series involving Afghanistan and Zimbabwe into an ODI series - which presumably would give Mashrafe a chance to retire in front of a home crowd, as he wished -- but according to BCB CEO Nizamuddin Chowdhury, that is still not confirmed.

"I am yet to receive any final instructions [on arranging a series to bid farewell to Mashrafel as it's a policy-based decision. So far, what we have communicated [to ZCB] is that there is a tri-nation series involving

Bangladesh, Afghanistan and Zimbabwe and we are heading in that direction," Nizamuddin told reporters yesterday.

Meanwhile, the BCB is yet to announce the schedule for the one-off Test against Afghanistan and it was learned that the visitors will take part in the Test between August 31 and September 10, which will be followed by the tri-nation series.

"First, there will be a Test series with Afghanistan and then we will play the tri-nation or bilateral T20I or ODI series during the first week of September. So far there are some optional discussions going on between the boards but I think if Afghanistan confirms, we will go with the T20s," he said.

Although Zimbabwe cricket has been suspended by the ICC over political interferences, the BCB CEO informed that there will not be any issues for Zimbabwe to take part in the series.

Ouestions still remain for the Tigers fans on when actually Mashrafe will retire from international cricket as the cricketer previously informed that he wished to bid farewell to the game in front of a home

Even if the BCB manages to arrange an ODI series at their own expense as a tribute to the legendary cricketer, it will mean little without an official announcement from Mashrafe - who has maintained radio silence recently -- about his retirement to make his stance clear.

## BCB yet to receive WC reports


James Anderson has been ruled out of the second Ashes Test, with England uncertain when he will be fit to return after injuring his right calf.

## Aus media revel in Smith redemption

Australians basked rediscovered pride in their cricketers Tuesday after Steve CRICKET Smith inspired a thumping Ashes Test win over England, redeeming himself following a ball-tampering scandal that left the team in disgrace.

Smith, pilloried and banned for a year over the infamous 'Sandpaper-gate' affair, rose above taunts of "We saw you cry on the telly" with centuries in each innings before England crumbled to a 251-run defeat in Birmingham. "It's a redemption story like no other, from

England," tweeted 7News Brisbane. Miracle trumpeted The Australian, as any lingering embarrassment from the tampering scandal

Sandpaper-gate to standing up to England, in

more than 18 months ago evaporated. Instead, attention turned to 'redemption" of Smith from a tearful press conference last year to his Test-defining innings which humbled England, just

weeks after they were crowned ODI world champions.

Nathan Lyon and Pat Cummins took all 10 wickets as England's second innings folded for 146, but it was the knocks of 144 and 142 by Smith that set up the victory and renewed

comparisons with the great Donald Bradman. At the start of the Test the Australians were mocked as "cry-babies" and endured taunts of "cheats and losers", but five days on they were winners, the Herald's Malcolm Knox

Knox described the fidgety Smith's centuries as "pure cricket alchemy, turning base metals into gold". The net effect of the abuse by England fans "was to knit the Australians together" and bring out their best cricket, he wrote.

"Even as he received his player-of-thematch award, Steve Smith had to speak above the songs of the last desperates whose claim to fame was having seen him cry on the telly. He wasn't crying now.'

Guardiola's side have been nothing short of dominant in the domestic league since the beginning of the 2017/18

City amassed an incredible 198 points in those two seasons and broke the record for the most Premier League wins in 2017/18 before matching it last year, while plundering a record 163 goals in all competitions in

An unprecedented domestic treble was completed in emphatic style with a 6-0 romp over Watford in the FA Cup final in May, but for all their domestic success under Guardiola, there is still one major goal yet to be reached continental glory.

"I've said before that for City to be where they want to be, I think they need to win the Champions League," said the club's England defender Kyle Walker.

"I think some of the players in the dressing room have achieved too much in their careers and done too much for football not to win the Champions League. So we owe it to them and ourselves.

City again fell at the quarter-final stage in last season's Champions League -- this time to eventual runners-up Tottenham Hotspur. They have only reached the last four once in the competition's history and have never competed

However, Guardiola tried to put the pursuit of Europe's elite club trophy into perspective after City beat rivals Liverpool on penalties to win the Community Shield on Sunday.

"The Champions League is an important tournament, difficult to win," he said. "But I don't want to go to the casino and gamble everything I have in my pocket for "I'd sign right now to do what we did last season again.

## PSG aim to shatter glass ceiling

Neymar transfer rumours linger on

Interminable rumours surrounding Neymar continue to swirl unabated as the new Ligue 1 season kicks off this weekend

with defending champions Paris Saint-Germain launching their assault for a seventh title in eight attempts. Thomas Tuchel's side began their

campaign by lifting the Champions Trophy in Shenzhen, China, gaining a modicum of revenge with a 2-1 victory over Rennes, the team that shocked PSG in last season's French Cup final. As Neymar served the last of a

three-match ban, incurred after a spat with a fan following April's shootout loss, Kylian Mbappe pleaded with the Brazilian to stay during their trip to the Far East.

"Everyone loves him and I love him so much," Mbappe said of Neymar, the world's most expensive player who has been linked with a return to his former club Barcelona.

"I don't want him to leave the team, obviously. I want him to stay. When you think about his situation and then he plays very well and he co-operates with the team you can see what he means to us.

The Brazilian suffered another injury-plagued season, missing PSG's embarrassing Champions League defeat by Manchester United, as well as Brazil's triumphant Copa America campaign.

The 27-year-old has also been embroiled in widely publicised rape allegations, vehemently denied, which were eventually dismissed by Brazilian police for lack of evidence.

Amid Neymar's tumult Mbappe, who took the 2018 World Cup by storm, tormented Ligue 1 defences to the tune of 33 goals to emerge as the club's true poster boy.

Mbappe moved to quell any doubts over his own plans, having caused alarm when he spoke of playing



"elsewhere" at the French league awards ceremony in May.

"I think it wasn't the right place (to say that)," the 20-year-old said while in China. "I'd like to say sorry to the players who were there, because I spoiled the party.'

Last season's title race quickly turned into a cakewalk for PSG, but after a domestic treble in 2017/18 under Unai Emery, his successor fell short in both domestic cups.

Despite that disappointment the brief for Tuchel a year on remains unchanged with PSG desperately craving success in Europe, after

another calamitous exit. "It hurts a lot, it hurts still that we did not go through," midfielder Julian Draxler told AFP, five months on.

"But from the potential in the team, we are ready to go far in the Champions League."

While PSG have crashed out at the last-16 stage in Europe each of the past three years, it is almost unfathomable they could be dethroned in France with last season's chief rivals losing a number of key players.

Lille sold leading scorer Nicolas Pepe to Arsenal for a reported £72 million (\$87 million), while Lyon head into the new campaign without Nabil Fekir, Tanguy Ndombele and Ferland Mendy. Fekir left his boyhood club for Real

Betis, Mendy signed for Real Madid, and Ndombele became Tottenham's record signing in a deal that could rise to 70 million euros. Perhaps unsurprisingly, Lyon have

struggled in pre-season under new boss Sylvinho, the former Barcelona and Arsenal full-back. Sporting director and club legend

who handpicked his compatriot to replace Bruno Genesio, said the start of the campaign would be a "moment of truth" after limp displays against Liverpool and Bournemouth.

The arrival of Andre Villas-Boas, who was out of football for 18 months, at Marseille makes for an intriguing prospect. The former protege of Jose Mourinho has pledged to do his all to restore the 1993 Champions League winners to the top after they failed to qualify for Europe last season, prompting the dismissal of Rudi Garcia.

#### Palace swoop for Cahill





## Dhaka's rusty gas pipes to be replaced

Says Nasrul Hamid

State Minister for Power, Energy and Mineral Resources Nasrul Hamid vesterday said the government would replace the capital's old gas distribution pipelines with new ones.

"We are taking up a large project. We will remove all old gas pipelines in Dhaka and will lay new lines," he said.

Nasrul was addressing the inauguration ceremony of the two-day South Asia LNG Forum 2019 at a city hotel. He said the project would cost the

government around Tk 1,200 crore. According to officials, Titas Gas Transmission and Distribution Company Limited found that about 160 million cubic feet (mmcf) of gas is being wasted every day either through pilferage or through leakage in old pipelines.

There are 7,000-km distribution pipeline in the capital and many of those have become worn out as those were installed around 35-40 years ago.

The Titas Gas distributes gas to its 2.78 million consumers, including households, power plants, fertilizer factories, industries and CNG refueling stations.

Nasrul said the government was expecting a better management in the gas sector and the country's development partners like the JICA and the European

Earlier, Nutrition Unit, BARC also tested successfully pesticide residue of raw, washed and cooked vegetables; antibiotic residue of poultry feeds; gama oryzanol of rice bran oil; as well as pesticide residue of cooked and steamed vegetables available in different classes of hotels including hotel Intercontinental and Radisson of Dhaka city from the SGS, Chennai.

Hence, Bangladesh Agricultural Research Council believes that tested results of milk done by SGS, Chennai are correct, authentic and reliable. There is no iota of doubt in these tests results. However, if anybody has any confusion about these results, BARC will be happy to welcome to test the milk samples in other countries in any internationally recognized accredited laboratory.

It is noted that ICDDR,B and BLRI has no capacity to conduct antibiotic and heavy metal residue analysis. Indeed, sometimes partial report produced by such organizations and reported in mass media results in misconception to the public.
