The High Court (HC) yesterday extended for one year its earlier order that granted bail to BNP Chairperson Khaleda Zia in a case filed over killing seven people and injuring 25-26 others by setting a bus on fire in Cumilla on February 3, 2015.

The HC bench of Justice AKM Asaduzzaman and Justice SM Mojibur Rahman passed the order following a petition filed by Khaleda, seeking extension of her bail in the case.

The HC on March 6 this year granted bail to Khaleda for six months in the case.

During the hearing, Barrister Kayser Kamal appeared for Khaleda.

Deputy Attorney General Dr Md Bashir Ullah told The Daily Star that Khaleda cannot get released from jail because she is convicted and sentenced to 10 years' and seven years' imprisonment in Zia Orphanage Trust corruption and Zia Charitable Trust

Police officer rescues newborn in Agrabad

It was around 5am yesterday. Subinspector (SI) Mustafizur Rahman of Double Mooring Police Station and his team were on patrol duty in front of Akhtaruzzaman Centre in Agrabad area of port city.

The girl, whose body was recovered from the toilet of an abandoned carriage at Kamalapur Railway Station on Monday, was raped before being murdered, a forensic doctor suspects. Asma Akhtar was choked to death and

signs of rape were found, Pradip Biswas, lecturer of forensic medicine department at Dhaka Medical College and Hospital (DMCH), told The Daily Star after an autopsy.

DNA samples and viscera have been collected for further analysis, he said.

Police could contact her family members in Panchagarh as they found her birth certificate near the body.

Asma's father Abdur Razzaq said his daughter left home on Sunday morning without telling anyone and had been traceless since then.

Sub-inspector Rusho Banik of Dhaka Railway Police Station said Asma's uncle Raju filed a murder case accusing her classmate Badhan.

Asma's father claimed that she was in a relationship with Badhan, who left home on Sunday as well. Police are trying to arrest Badhan, the SI said.

Case filed against eight for provoking suicide

Victim was sexually assaulted and blackmailed, claims son

Police filed a case against four youths and four other unnamed persons on charge of provoking suicide by threatening to release the victim's nude video on the internet at Gazipur's Sreepur upazila. The accused are: Siam (22), Sadeq (25), Rony (18), Shyamol (25) and

four others. The accused had a long-standing rivalry with the victim, Md Jamal

Uddin, 43. All of them are residents of Tepirbari area of Sreepur upazila.

On Sunday evening, the accused and Jamal locked in an altercation over a motorcycle. At one stage, they forcibly took Jamal to a nearby Shal forest, gang-raped him, and took photos and videos, claimed the victim's son, Rakibul Hasan Ridoy. Then they tried to extort Tk 2 lakh from Jamal, threatening to release

the photos and videos on the internet, according to Rakibul. They released Jamal at around 9pm that night. Traumatised by the incident, the victim committed suicide at around

11am on Monday at his residence. Early yesterday, the victim's son filed a case on different criminal charges, including provoking suicide, committing crime under Pornography Control Act, and extortion.

Police arrested one Moniruzzaman for his suspected involvement with the incident, said Md Nayon Bhuiyan, sub-inspector of Sreepur Police Station. However, none of the eight accused had been arrested until 10pm last night.

Yaba now coming in via India: Ctg DIG

Due to strict vigilance and continuous drives against drug trafficking by law enforcement agencies in Cox's Bazar, drug peddlers have adopted new techniques and are smuggling yaba to the country through the Indian border, said Khandker Golam Faruq, deputy inspector general

(DIG) of police (Chattogram Range), yesterday. The DIG said this while addressing a monthly crime conference of Chattogram Range, held at Chattogram District Police Lines in port city's Halishahar area.

"We have information that yaba peddling through Cox's Bazar border has decreased because of the ongoing drives. As a result, the [yaba] pills are now being trafficked through Indian border and entering Bangladesh via adjacent districts," he said.

"I have asked the superintendents of police in Cumilla, Brahmanbaria and other districts to remain alert in this regard," the DIG said.

At the meeting, DIG Faruq also gave directives to the SPs to keep their offices and other police establishments clean to prevent the breeding of Aedes mosquitoes.

Additional DIG of Chattogram Range Abul Faiz, SPs of 11 districts under Chattogram Range and senior police

officials were present at the conference, among others. The DIG also awarded 18 police officers of different districts for their outstanding works in the month of July.

Rajshahi Metropolitan Police has come up with a new approach of investigating allegations of sexual harassment by taking notes from social media discussions for gaining public confidence.

The initiative was taken after the police noticed that victims frequently took to social media to write about incidents of sexual harassment, rather than complaining to police.

In the last ten days, RMP dealt with at least two such incidents where the victims explicitly denied to go to the police and instead posted on social media, generating widespread


