# Find alternatives to coal, gas

Says Anu Muhammad at Phulbari Day rally

Suggesting the government to find out alternative source of fuel, Professor Anu Muhammad -member secretary of National Committee for Oil, Gas, Mineral Resources, Power and Ports -yesterday said waste materials and solar energy can be used as sources to generate power, to meet the increasing demand in the country.

He was speaking as chief guest at a rally in Phulbari upazila of Dinajpur yesterday, marking 13th anniversary of Phulbari Day.

Dinajpur chapter of the national committee organised the event.

"We do not want any development project in

the country that affects human lifestyle, nature and ecological system", he said. A large volume of waste is produced in

Phulbari every day, which can be used as an alternative source of fuel to generate power. Besides, the government can set up solar plant in the upazila, he suggested. About the Phulbari coal mine, Prof Mohammad said Asia Energy has continued its efforts to persuade government and people of Phulbari to implement the coal mine project.

He urged the government to close down activities of Asia Energy in Bangladesh, and demanded that the cases pressed by the company against people of Phulbari be withdrawn.

"People of Phulbari will not allow a coal mine," he said.

If the demands are not met within September, they would hold agitation in front of PMO in October and November to press the government

'unsuitable' for power import Joint steering committee on Bangladesh-India Power Sector Cooperation holds meeting

Bangladesh wants to import 340MW more electricity from other parts of India instead of previously proposed Tripura, as its transmission system is said to be weak.

"We've discussed such a proposal at a meeting of the joint steering committee Bangladesh-India Power Sector Cooperation. Both sides agreed to study the technical aspects of the proposal," Bangladesh Power Secretary Dr Ahmad Kaikaus said yesterday while briefing reporters about the outcome of the meeting. Dr Kaikaus led the Bangladesh team at the meeting held at a Dhaka hotel.

Currently, Bangladesh is importing 1,160MW of electricity from India, of which 1,000MW is coming from West Bengal through Bhreramara substation while

160MW from Tripura through Cumilla. The proposed 340MW is an addition to this current cross-border electricity trade

between Dhaka and New Delhi. The 17th meeting of the joint steering committee concluded with discussing various issues related to power sector cooperation between the two neighbouring

nations. India's Power Secretary Subhash few months of targeted time frame.

Chandra Garg, who led his country's team at the meeting, said both sides are happy with the progress and agreed to continue the cooperation.

Dr Kaikaus said the proposed import of 340MW is in addition to the existing supply and Bangladesh finds the proposed import technically and financially unviable as the transmission system from Tripura is "weak".

He said Bangladesh now has available electricity in Cumilla region which is being generated from gas-fired plants at a lower "So, we'll prefer the proposed 340MW

to be imported for regions like Rangpur, Dinajpur and Thakurgaon where there is power shortage and liquid fuel is used to generate electricity at higher cost," he said. Dr Kaikaus said Bangladesh also wants

to export electricity during its off-peak season of winter to India if it finds any suitable buyer, as there is no bar on export or import of electricity to or from India. He also said Bangladesh-India joint

Quoting locals, police said the accident took place around 10am while Fatima was crossing the road, killing her on the spot.

Police later went to the spot and recovered the body. The truck was seized but its driver and helper managed to flee. A case was filed in this connection, they added.

In Jamalpur, a rickshaw-van puller was killed when a Leguna (human haulier) hit his van at Kazirakh intersection in Jamalpur

The deceased is Hashu, 50.

The accident took place around 9:30am, leaving him severely injured, police said.

Police rushed Hashu to Jamalpur General Hospital and was later transferred to Mymensingh Medical College Hospital where he succumbed to his injuries, they added.

Police seized the Laguna but its driver fled the scene.

In Chattogram, a rickshaw-puller was killed after a truck hit his vehicle at Patiya Bus Stand in Patiya upazila.

The deceased is Abu Samad, 40. Police, quoting locals, said the accident

happened around 2am and left Samad critically injured. He was rushed to Chattogram Medical

College Hospital where doctors declared him dead around 5am, they added.

The trucker fled the scene with the vehicle, and police are trying to catch him. In Gaibandha, a fish trader was killed

when a speeding bus ran him over at Fasitola in Gobindaganj upazila. The deceased is Hariram Sarker, 38. Police, quoting locals, said when on the spot.

Hariram reached Fasitola, a speeding bus of Nabil Paribahan hit him from behind. After he fell down, the bus ran him over, killing him on the spot, said police.

The bus driver fled soon after the incident.

Police recovered the body and sent it to Gaibandha District Hospital for autopsy. In Kurigram, two people were killed and

two injured when their motorbikes collided in Hasnabad union of Nageshwari upazila. The deceased are Jahedul Islam, 35,

and Alomgir Hossain, 35. The injured are Yousuf Ali, 28, and Bulbul Ahmed, 30. Police said the two riders, Jahedul and Alomgir, died on the spot. The pillion

passengers were severely injured. Locals took them to Kurigram General Hospital. Bulbul was later referred to
