Artificial' transport crisis spells misery for port city commuters

There has been an acute transport shortage on two major routes in Chattogram city for more than a year, as most public buses are being used for RMG workers after their duty hours.

Eventually, other commuters -- especially office goers -- said they face difficulties to go home after 6pm.

The authorities of readymade garment (RMG) factories in and outside the city reserve most of the buses and minibuses plying CEPZ-Bahaddarhat and Kathgar-Laldighirpar routes to carry their workers, factory sources said.

As a result, commuters find sparse public transports on those routes from 6pm to 8:30pm.

According to transport sources, around 400 buses and minibuses ply route no-10 stretching from CEPZ to Bahaddarhat and some 200 such vehicles on route no-6 from Kathgar to Laldighirpar.

Although a total of 600 vehicles are supposed to be operated on the routes throughout the day, hardly 20 are found after 6pm, said commuters. This correspondent recently made a

trip on the Kathgar-Laldighirpar route. There were adequate public vehicles in the and tried to board it. afternoon but the scenario changed in the evening.

Hundreds of commuters were seen waiting for transport at Katgar, Steel

"My residence is at Agrabad and the regular fare from CEPZ to Agrabad is Tk 7, but they demand Tk 20 in the evening seizing opportunity of the artificial crisis."

Mill Bazar, Bandartila, CEPZ, customs intersection, Barek Building intersection, intersection, Agrabad Badamtoli Chaumuhani, Dewan Haat, Tiger Pass, Lalkhan Bazar intersection and GEC intersection bus stops.

SAPLING PLANTATION IN RESERVE FOREST

Tea estate staff bar forest officials

Forest officials in Chattogram yesterday said a sapling plantation programme of theirs at a reserve forest in Fatikchari was foiled by staff of a tea estate.

AZM Hasanur Rahman, assistant conservator of forest at Chattogram South Divisional Forest told The Daily Star that at least 70 persons from Halda Tea Valley -- armed with locally-made weapons -took position to attack them at a nearby hill, when they started planting saplings at Anandapur area of the Ramgor-Sitakunda reserve forest yesterday afternoon.

"At one stage, they threatened us. Sensing danger, we contacted the manager of Halda Tea Valley, who claimed the land belongs to the tea estate," Hasanur

"I requested him to come over and help us detect the demarcation so that we could avoid their land and continue the plantation. However, he replied with more threats, saying we would face grave consequences if we continue the work there," Hasanur added.

Forest department planned to plant six thousand saplings at Anandapur, he said, adding that the land falls under Ramgor-Sitakunda mouja while the tea estate's land falls under Halda mouja.

Hasanur further alleged that at least 500 saplings that they planted were removed by the tea estate workers, and the rest were taken away by them. He also claimed that police and local administration did not help, and rather "took the tea estate's side."

Jahangir Alam, manager of Halda Tea Valley told The Daily Star that the High Court issued a status quo on the land where forest department was planting saplings. He denied allegations of uprooting any

saplings, adding that they sought help from local administration to maintain the status quo. Sheik Abdullah, officer-in-charge of Vujpur

Police Station told The Daily Star, "Some tension prevailed between tea estate staff and forest officials when they started planting."

Life-term convict arrested 2hrs after escape from jail

Police yesterday arrested a man convicted to life-term imprisonment, two hours after he escaped from Rajshahi central jail.

Amar Kisku, 26, was arrested from the city's Dingadoba area while he was walking on the railway track at 12:15pm, said Golam Ruhul Kuddus, deputy commissioner and spokesperson of Rajshahi Metropolitan Police.

Amar, a member of the Santal community, was arrested at the age of 18 in 2011, in connection with the gang-rape and murder of schoolteacher Moriam Murmu in the same upazila.

He has been in jail since then. In May 2012, he was convicted in the case and awarded with 60 years of rigorous imprisonment.

Three other accused -- Johan Marandi, Andrias Murmu, and Shawkat Iqbal -- were awarded death sentence in the case; according to the judgement, Amar was not given capital punishment considering his

At 10am yesterday, he managed to flee the jail, climbing over the high boundary wall of the jail, the police official said, quoting their sources. No one from the jail authorities received phone calls despite repeated attempts, to comment on how the man escaped from jail.

However, the jail authorities filed a case against Amar with Rajpara Police Station, accusing him of escaping prison and hindering government activities, the police official said.

to reports from our correspondents. In Sylhet, a man was killed and 12 were injured after a collision between a CNG-run auto-rickshaw and a human haulier in Pargana


Bazar area in Sylhet Sadar upazila.
