

HOLEY ARTISAN ATTACK CASE

Three witnesses testify COURT CORRESPONDENT

Three more prosecution witnesses, including two physicians of United Hospital, yesterday gave their statements before a tribunal in the Holey Artisan café attack case. Including them, the tribunal has recorded statements o

100 out of 211 prosecution witnesses in the case. The witnesses are Dr Sadia Islam Swarna and Dr Nadim

Mahmud, and inspector of police's Counter Terrorism & Transnational Crime (CTTC) unit Shafiuddin Sheikh. Judge Majibur Rahman of the Anti-Terrorism Special Tribunal of Dhaka recorded statements of the witnesses, after which defence lawyers cross-examined them. The

tribunal set August 29 for the next hearing. In their statements, the physicians told the court they treated over 20 persons who were injured in the terror attack. Shafiuddin said he arrested Jahangir, one of the accused

in the case, during the investigation of the case. Eight accused, now in jail, were produced before the tribunal during yesterday's hearing of the case.

Militants killed 20 people, most of them foreigners, in the grisly attack at the café on July 1, 2016. Two police officials valiantly laid down their lives trying to save people there.

4 GET LIFE-TERM FOR GANG RAPE IN N'GANJ A Narayanganj court yesterday sentenced four men to life imprisonment and fined them Tk 1 lakh each for gang-raping a girl on March 15, 2010.

The convicts are Shahidul, 30; Shakil, 28; Chanchal, 31; and Arif, 30. Only Chanchal was

present before the court, as the others are on the run. Judge Md Shahin Uddin

Public prosecutor Rakibuddin Ahmed said as per the case statement, the convicts abducted a 14-year-old girl on her way home from work, and raped her.

Mehedi Hasan said the miscreants used to drug bus passengers by mixing sleeping pills in coconut water, and later looted valuables.

"They first mixed sleeping pills in water and then injected it into green coconuts; Harun used to sell the coconuts from a van in busy areas in the city," said the DC while addressing a press conference at his office.

The victim from Bakalia is still unconscious and undergoing treatment at Chattogram Medical College Hospital, said the DC. Arrested Harun said they collected the sleeping pills

from medicine shops in Laldighi area and used to mix 10 to 20 sleeping pills with water for each coconut, and later injected it into coconuts using medical syringes. After the victim fell unconscious after drinking the

coconut water, they stole valuables and cash from him in guise of helping, Harun added. Additional Deputy Commissioner (South) Shah Md

the hospital on April 10. Her death triggered a huge public outcry across the country. Moazzem was withdrawn the same day of the incident

as Nusrat's family alleged that he was not cooperating with them. He was suspended on May 8 over negligence of duty. Police arrested Moazzem from the Supreme Court area

on June 16. The following day, a Dhaka tribunal rejected his bail petition and sent him to jail.

On July 9, the HC bench of Justice Md Moinul Islam Chowdhury and Justice Khizir Hayat rejected a bail petition of Moazzem in connection with the case, saying that Moazzem failed to protect Nusrat's life and damaged police's image.
