SOLVING ROHINGYA CRISIS

BNP calls for national unity

The BNP yesterday reiterated its call for forging national unity among the political parties and civil society members to resolve the Rohingya crisis and ensure the refugees' repatriation to Myanmar.

Placing a 10-point recommendation, the party alleged that the government had failed on the diplomatic front.

"We all know that the government has no moral stance as it is unelected. So to fill up the moral gap, the government has to unite all the political parties, civil society members and other stakeholders to mount pressure on the

Myanmar government to take back the Rohingyas," Mirza Fakhrul Islam Alamgir, the party's secretary general,

The BNP leader also urged the United Nations, international organisations and the global community to come forward to resolve the ongoing humanitarian crisis.

Fakhrul's comments came at a seminar titled "Plight of the Rohingya and role of Bangladesh", which was organised by the party at a city hotel. Delegates from embassies or high commissions of the

United States, United Kingdom, China, India, Canada, France, Australia, Japan, Pakistan, Norway, Switzerland, Turkey and some other countries also joined the seminar. None of them, however, made any statement.

BNP's standing committee member Amir Khasru Mahmud Chowhdury presented the keynote paper where he placed the 10-point recommendations. He discussed the context of the Rohingya exodus, former UN secretary general Kofi Anan's report on the matter and his solutions for it.

REVOKING KASHMIR AUTONOMY

Indian SC to hear petitions against govt action

India's Supreme Court said yesterday it will hear challenges in October to a government order revoking the autonomy of contested Kashmir, and it allowed an opposition politician to visit the region that has been under lockdown for weeks.

India stripped the Muslim-majority region claimed by both India and Pakistan of its special status this month, and also divided Jammu and Kashmir state into two, to the fury of many of its residents.

More than a dozen petitions have been filed in the Supreme Court questioning the legality of the action, which the government said was aimed at developing the region at the heart of animosity with Pakistan for decades.

A panel of judges headed by Chief Justice Ranjan Gogoi yesterday said the court would hear the petitions starting in the first week of October.

"How the court decides these cases will have a deep bearing on the destiny of democracy in India," Suhrith Parthasarathy, a Chennai-based lawyer, said in an article for the Hindu newspaper.

The court also ordered the federal government to submit a response within seven days to a plea by Anuradha Bhasin, the editor of the daily Kashmir Times, who has sought a relaxation of a government ban on telephone and internet services in Kashmir since August 5.

Graphene-lined clothes show hope

Clothes lined with graphene could stop mosquito bites and help prevent the spread of deadly diseases such as malaria, new research suggests.

Since its discovery in 2004, graphene has been touted to improve everything from water filtration to solar cells. This is made possible by the remarkable properties of the one-atom thick material, which is 200-times stronger than steel, more conductive than copper and as flexible as rubber.

Now, scientists say the super thin material blocks chemical signals in sweat that encourage the blood-sucking insects to bite. Tests also showed that the material is

Statements of IO, SP don't match

HC observes regarding Minni's involvement

The High Court yesterday observed that a statement from Barguna SP on Minni's involvement in her husband's murder does not sufficiently corroborate the case docket (CD) of the investigation officer.

"She [Minni] may or may not be involved in the incident, but we are not finding sufficient corroboration between the statement given by the SP at a press conference and the statement recorded by the IO in the CD," the court said.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman made the observation while hearing a petition filed by Aysha Siddika Minni seeking bail in the Rifat Sharif murder case.

After concluding the hearing, the HC bench fixed today for delivering the verdict on the petition.

Speaking at a press conference in his office on July 18, SP Maruf Hossain said they arrested Minni as they found her link with the murder.

The court did not disclose the statement recorded in the
