FR Tower Case

Shah Md Sadrul Alam, an assistant director of Rajdhani Unnayan Kartripakkha (Rajuk) who was arrested on charges of design manipulation of FR Tower in Banani, was granted bail yesterday.

Five other accused -- former Rajuk chairman KM Harun, former inspector Mehedi Uzzaman, former directors (estate) Shamsul Alam and Md Moamzzem Hossain, and former coordinator Mofazzel Hossain -- also got bail after their surrender yesterday.

Court passed the order, after the accused filed bail petitions. On August 8, Liakat Ali Khan alias Mukul, 57, chairman of Rupayan Group -- the builder company of FR Tower -- got ad-interim bail after his surrender before a Dhaka court.

Judge KM Emrul Kayesh of Dhaka Senior Special Judge's

Two other accused -- FR Tower land owner SMHI Faruque and building co-owner Tasvirul Islam -- were earlier arrested

and later granted ad-interim bails in the cases.

Yesterday, the judge granted them permanent bail.

On June 25, ACC filed two cases accusing 23 people, including a former chairman of Rajuk, chairman of Rupayan Housing Estate Ltd and several government officials, for alleged involvement in illegally extending the building.

An ACC enquiry, found that the 23-storey building had no fire alarms, narrow exit points and staircases, blocked fire exits and other issues.

Although authorities had legally obtained permission for a 15-storey building, they extended it to 23 storeys.

ACC sued 25 people in two cases filed over the illegal extension -- to 16th to 18th and 19th to 23rd floors.

Holey Artisan Café attack

An imam of a mosque in Narayanganj -- whose decapitated body was found inside his room last week -- was murdered by a friend over repayment of a loan, police said yesterday.

Police on Wednesday arrested Wahiduzzaman, an imam at a mosque of Shibchar area in Madaripur, from Shibchar on charges of killing Didarul Islam, imam of Mollikerpara Jam-e Mosque under Sonargaon upazila. SI Abul Kalam Azad of Sonargaon Police Station

conducted a drive in Madaripur area after finding Wahiduzzaman's connection with the murder, and arrested him, said Harun-ur Rashid, superintendent of police (SP) in Narayanganj at a press conference at his office on Wednesday.

Wahiduzzaman has since given a confessional statement to the SP saying he killed Didarul, he added.

Police sources said Wahiduzzaman had taken a loan from Didarul, and was being pressured to pay it back.

On the night of August 21, Wahiduzzaman went to Didarul Islam's mosque, bringing two bottles of soft drinks, one of which was spiked with sedatives.

After Didarul fell unconscious drinking the beverage, Wahiduzzaman slit his throat, and fled the scene after throwing his blood-stained lungi and two soft drink bottles in a ditch by the side of the mosque.

Later, based on the confession, the blood-stained lungi and bottles were recovered as evidence.

ATIA MAHAL GRENADE BLAST

PBI final report says all accused died in anti-militant drives

In its final investigation report, Police Bureau of Investigation (PBI) has confirmed death of two attackers and the key planner of the twin grenade blast on a crowd at Atia Mahal of Shibbari area in Sylhet city on March 25, 2017.

The attackers, Ashraful Alam Nazim, 22 and an unidentified male, 28, were killed in an anti-militant drive at Barahat area in Moulvibazar on March 29-April 1, 2017.

The key planner Lokman Hossain alias Mosaraf Hossain alias Sohel, 38, also died along with his family members in a suicide blast during another anti-militant drive at Nasirpur area of Moulvibazar on March 29, 2017, the report said.

PBI also said all three were active members of Jama'atul Mujahideen Bangladesh (JMB).

Dewan Abul Hossain filed the final investigation report to the court of 2nd Sylhet Metropolitan Magistrate Saifur Rahman.

The court forwarded the report to

after hearing on August 20. The final

report will be presented before the court on October 20. Bangladesh Army led the anti-militant drive, code-named "Operation Twilight", at a militant

hideout in Sylhet's Atia Mahal from March 24 to March 28, 2017. On the evening of March 25, 2017, while the drive was ongoing, two grenades were blasted around 400 metres away from Atia Mahal, which claimed seven lives including Rab intelligence chief Lt Col Abul Kalam

Police filed two separate cases, one regarding the militant hideout and another for the twin grenade On July 22, PBI Inspector blast, with Moglabazar Police Station

Azad and two police officers.

accusing unnamed people after the operation. Following an order of Police

Headquarters on May 9 that year, PBI took over the cases from Moglabazar Police Station and started investigation from May 13. PBI Inspector Dewan Abul Hossain, investigating officer of the grenade

blast case, said, "After thorough investigation of the case, we found that three militants were involved with the attack. They were hiding in two different hideouts at Moulvibazar and came to Shibbari during the drive at Atia Mahal to blast grenades outside to divert the drive." After the drive at Atia Mahal, two

more drives were conducted at two militant hideouts in Moulvibazar, where these three accused died, he

"As all three accused are dead, we submitted the final report to the court", he said.

3 killed, 2 injured in road accidents

At least three people were killed and two injured in road accidents in two districts yesterday, according to reports from our correspondents.

In Dhaka, two people were killed after a bus of SR Plus Paribahan collided with a bus of Ahad Paribahan in Kabirpur area of Ashulia.

The deceased are Abdul Jolil, 33, owner of the Ahad bus; and its driver Zahangir Alom, 32. Fire service, quoting locals, said, Jolil's bus broke down

in the middle of the road, so he called for another bus of the same company to tow it away. When the other bus arrived, Jolil and Zahangir were

outside tying the two vehicles together. At that time, a bus of SR Plus smashed into their bus from behind, killing them both. Two passengers of the SR Plus bus were injured in the accident, he added.

The bodies were sent to a local hospital for autopsy, said police, adding that the buses were seized but the helper

and driver of the SR Plus bus managed to flee. In Chattogram, Gulam Murshed, 35, was killed when a bus hit him while he was crossing the road in Banshbariya area of Sitakunda upazila around 5:30am, said police, quoting locals.

Locals took Murshed to Chattogram Medical College Hospital, where doctors declared him dead, police sources added.

The bus driver fled the scene with the vehicle, and police are trying to catch him.

Indefinite transport strike called in Sylhet division and B'baria from Sept 2

Bangladesh Road Transport Owners and Workers Oikya Parishad has called an indefinite strike in Sylhet division and Brahmanbaria from September 2.

Leaders of the organisation took the decision from a meeting at its office in Sylhet on Wednesday night, to press home their demands -- including transfer of a case against a driver and his helper to a bailable section and a stop to BRTC bus operations on the Sylhet-Sunamganj route.

On March 23, Sylhet Agriculture University student Wasim Afnan was killed as a bus ran him over on Dhaka-Sylhet Highway in Moulvibazar, after he was allegedly pushed off the bus.

The bus driver and his helper were later arrested on the charge of murderm and sued in a non-bailable case.

The transport leaders' other demands include reduction of fine to Tk 50,000 from Tk 5 lakh in section-105 under proposed Road Transport Act 2018; making its section-84, 98 and 105 bailable; and reduction of fine to Tk 30,000 from Tk 3 lakh in section-84 and 98 under the act.

Besides, they demanded police investigation before filing road accident cases, inclusion of their representatives in the probe team and ending police

harassment on highways. Selim Ahmed Folik, joint convener of the Parishad, said, "We had submitted a memorandum to the divisional commissioner and the DIG of police in Sylhet regarding our demands, but to no

avail. That's why we called the strike." BRTC's Sylhet Regional Manager Julfiquar Ali said, "We started the bus service on June 3 this year with eight buses on the route, but we had to reduce the number to four in the wake of pressure from transport

owners and workers." M Kazi Emdadul Islam, deputy commissioner of Sylhet, said, "Their demand for stopping the BRTC bus service is illogical. The service will not stop under any circumstances."

Nupur returns home after groundbreaking surgery

Twelve-year-old Nupur returned home yesterday, after a successful minimally invasive cardiac surgery at the National Institute of Cardiovascular Diseases (NICVD), the first of its kind at any government hospital.

Hailing from Sujanagar upazila in Pabna, Nupur was suffering from Atrial Septal Defect (ASD) -- a hole in the wall between the two upper chambers of heart.

A team of 10 doctors, headed by Dr Ashraful Hoque Sium, conducted the operation at the NICVD on August 25.

They carried out the two-and-a-half-hour surgery, which costs Tk 5,000. After successfully completing the surgery, an elated Dr Sium said, "I am speechless! I used to dream of doing something big for the people... With the support of the honourable prime minister, I've been able to

materialise that dream. I'm very happy and thankful to all." In minimally invasive cardiac operations, surgeons perform heart surgery through small incisions in the chest as an alternative to open-heart surgery. Surgeons do not cut through the breastbone, instead operateing between the ribs, which may result in less pain and a quicker recovery for

many people. It allows surgeons to use techniques that limit the size and number of cuts, or incisions that they need to make. It is typically considered safer

and quicker than a traditional heart surgery. Before NICVD, only National Heart Foundation of Bangladesh (NHFB), a private hospital in the city's Mirpur, conducted such surgeries SEE PAGE 4 COL 4
