# Price tag of Lohalia bridge to double

Ending a suspension of five years, construction work of the bridge on the Lohalia river will resume soon with a modified design accommodating an extended height clearance.

Government Engineering Local Department (LGED) on July 17 issued work orders to two construction firms in this regard.

The fresh work orders of Tk 47 crore will add on to the bridge's previous construction cost of Tk 46 crore and raise its price tag to Tk 93 crore.

On October 1, 2014, when the work of the Lohalia bridge was put on hold over an objection raised about its inadequate height clearance, 55 percent work of the bridge was already

completed. The objection about the bridge's height was raised by Payra Port Authority (PPA) via shipping ministry.

The LGED in 2008 initiated process for constructing a bridge on the Lohalia to connect thousands of inhabitants of Baufal, Dashmina and Galachipa upazilas with the Patuakhali district headquarters.

The construction of a 464-metrelong concrete bridge, on Patuakhali-Dashmina road via Baufal, commenced on November 9, 2011, with its completion scheduled for October 20, 2014. According to the original design, the height of the bridge was set at 9.57 metres, said sources at LGED in Patuakhali.

Till date, LGED has disbursed Tk 29.04 crore -- Tk 25.29 crore to the construction firm while Tk 3.75 crore for land acquisition.

Following the objection raised over the bridge's height, LGED and the shipping ministry jointly decided to put the construction work on hold.

On July 17, 2016, the LGED and shipping ministry decided to raise the height of the bridge's middle columns to 18.30 metres and place a steel span in between the concrete columns, the sources added.

In the absence of a bridge, thousands of locals have been facing immense sufferings as they are having to cross the Lohalia in small boats. Rakibul Hasan, a student of Abdul

Karim Mridha College and a resident of Lohalia village, said he would not have to cross the river in small dinghies every day if there were a bridge on the river.

Raisul Islam, an employee of a nongovernment organisation; and Khokon Mia, a teacher of a private college; echoed the same sentiment.

Executive Engineer Tirthojit Roy said the construction work of the heightened bridge, with a steel span in the middle, is scheduled to be completed within a couple of years.

# Hot spell holding back Aman farming in Lalmonirhat

Aman farmers in Lalmonirhat are facing shortage of day labourers due to a hot spell in the region over the past few days.

While many of the labourers are refraining from working in the open, others are overcharging, said many farmers.

Being unable to find labourers at affordable rates, several farmers said they would shelve their plans to plant Aman seedlings for the time being.

They said the spike in labour rates is a double blow to them as they are still reeling from losses incurred due to falling prices of

Farm labourer Nazrul Islam Hatibandha upazila's Gaddimari, a village by the Teesta river, said the heat has been so intense that they cannot work under the sun without taking frequent breaks in the shade.

"We haven't been planting Aman seedlings due to the scorching heat. Some of us, however, might consider it if the pay is good," he also said.

Another day labourer, Nur Alam, from the same village, said usually a team of seven workers can sow Aman seedlings on five bighas of land in one day. But, due to the excessive heat, they can barely sow seedlings on three bighas now.

#### Raped boy hospitalised Accused madrasa teacher flees

A madrasa teacher, sued for forcibly sodomizing an 11-yearold boy, went into hiding on Sunday night.

The victim, son of a poor rickshaw-van driver, is undergoing treatment at Joypurhat Modern hospital.

The accused, Ayub Ali, 42, son of Nasir Uddin of Kamiadanga village under Dhamoirhat upazila of Naogaon, taught at Hafezia Madrasa at Aramnagar of Joypurhat municipality. Fifteen boys, all belonging to poor families, are students

of the madrasa, said police. "Ayub Ali sodomized the boy at his bedroom a week ago

and threatened him of tough punishment if the matter is disclosed. Afterwards, he committed the brutal act almost every night," the boy's father said in the case statement. On Sunday morning, the boy fled from the madrasa and

As the boy fell sick, he was admitted to Joypurhat Modern Hospital the same day.

The boy was brought with serious anal injuries, said Dr Mubinul Islam, resident medical officer of Joypurhat Modern Hospital.

Demanding arrest and punishment of the perpetrator, the victim's family members said the madrasa teacher allegedly did the same with some other boys too.

"The victim boy's father filed a case on Sunday afternoon and we have started investigation into the incident. Drives are on to arrest the accused teacher," said Raihan Hossain, inspector (Investigation) of Joypurhat Sadar Police Station.

### Sugarcane growers call 20-day demo from Sep 5

Demanding steps to protect Sahebganj agriculture farm of Rangpur Sugar Mills in Gaibandha from land grabbers, labourers and sugarcane growers announced a 20-day agitation programme from September 5.

The programmes include submission of memorandum, human chain, demonstration in Mohimaganj and Gobindaganj, road and rail blockade and a half-day hartal.

They made the announcement at a press conference at the mill's gate on Sunday. Rangpur Chinikal Sramik-Karmachari Union and cane growers jointly organised the conference.

The speakers at the programme also demanded to stop looting in the cane farm, criminal activities and attack on them and preventing government officials from discharging their duties.

At the press conference, Faruk Hossain, assistant secretary of the union, read out a

Six decades ago, the then East Pakistan government acquired 1854 acres of land at Sahebganj for erecting a sugarcane farm just to run the sugar mill smoothly. Accordingly, government


over the acquired lands to the then East Pakistan Industrial Development Corporation (EPIDC). After liberation, the organisation was converted into Bangladesh Sugar and Food Industries Corporation (BSFIC).

Since 2016 a section of grabbers continued instigating innocent Santal community to occupy government land on the plea of getting their forefather's property. They even called Santal families from different areas and occupied around 100 acres of land at Sahebganj cane farm, the paper said.

Since then Santal community started carrying out occasional attacks on farm's office and workers, looting away properties of the farm and damaging tractors, cranes and other equipment. Even they looted firearms from the ansars deputed in the farm, said the speakers.

In this situation, on November 6 in 2016, local administration and law enforcing agencies in an eviction drive recovered the government properties from illegal occupants.

The Santal community still attacked the workers in the cane fields and lifted fishes from the farm's ponds on various handed occasions, said the speakers.
