US Ambassador to Bangladesh Earl R Miller yesterday said Myanmar needs to take action so that Rohingyas can return to their homeland. Myanmar must create the conditions

on the ground so that all Rohingyas can return to their home in a safe, dignified manner, he said. The US Ambassador made the remarks

while talking to reporters after visiting the historic Keane Bridge over Surma River in Sylhet city.

The historic British-era bridge is currently closed to vehicles due to ongoing repair work.

He said the international community

did increase pressure on Myanmar, and the US is working in partnership with Bangladesh to make sure repatriation takes

Bangladesh is now hosting over 1.1 million Rohingyas, most of whom entered the country since August 25, 2017.

Miller on August 24 said they would continue to put pressure on Myanmar to create conditions on the ground for the "voluntary, safe, dignified, and sustainable" return of all Rohingyas to Myanmar's Rakhine State.

Bangladesh and Myanmar signed a repatriation deal on November 23, 2017, but there has been little progress.

Confiscate assets of Bangabandhu's killers

Demands AL-led 14-party alliance

Bss, Dhaka

Leaders of the Awami League-led 14-party alliance yesterday demanded confiscating assets of all involved in the killing of Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

"The verdict against the convicted fugitive killers of Bangabandhu must be executed and assets of all involved in the assassination have to be confiscated soon," AL presidium member and 14-party alliance spokesperson Mohammed Nasim said at a views-exchange meeting in the capital.

Central 14-party alliance organised the event at the AL central office in Bangabandhu Avenue area with Nasim in the chair.

Law Minister Anisul Huq said the government is trying its best to trace locations of the fugitive killers.

"Canada does not extradite convicts who get death penalty due to its Supreme Court order," he said. "We are hopeful of bringing Nur Chowdhury back through diplomatic and legal efforts," Anisul said. The minister said now the USA is showing positive attitude about extraditing another convict Rashed Chowdhury to Bangladesh.

The government has decided to form a commission to unmask the masterminds, the law minister said, adding that it will also probe the killings of four national leaders. Foreign Minister AKM Abdul Momen said whereabouts of three

convicted fugitive killers are yet to be known.

"We are trying our best to bring back the two fugitive killers, who have already been traced and execute them before celebration of the birth centenary of Bangabandhu next year," he said.

Workers Party of Bangladesh President Rashed Khan Menon; Jatiya Samajtantrik Dal President Hasanul Haq Inu; Samyabadi Dal General Secretary Dilip Barua; and former media adviser to the prime minister Iqbal Sobhan Chowdhury also spoke at the meeting.


