Four sued over rape of 4 girls

Four men were sued yesterday for allegedly raping four girls in Jashore, Nilphamari, and Cox's Bazar.

Family members of the victim in Jashore said the girl, student of a government primary school, was playing in a garden nearby her home at a village in Sadar upazila on Monday afternoon. At that time, accused Abdul Mamun, 20, a neighbour of the victim, violated her.

When the girl started screaming, locals rushed there and rescued the girl. But Mamun managed to flee, said the victim's mother.

The mother filed a case against Mamun yesterday, said Nazmul Hossain, officerin-charge (investigation) of Kotwali Police

In Nilphamari, another man was sued yesterday for allegedly raping a 12-yearold speech-impaired girl at a village in Jaldhaka upazila.

The accused, Mostakim, 18, is a neighbour of the victim.

UK PM loses majority in parliament

Tory MP defects ahead of crucial no-deal vote

Prime Minister Boris Johnson yesterday lost his working majority in parliament ahead of a showdown with rebel MPs over Brexit that could lead to a snap election within weeks.

Johnson condemned a plan by lawmakers to block his Brexit strategy as "surrender" and said it would undermine his intention to negotiate a new divorce deal with the EU.

He said the move by opposition MPs and members of his Conservative party to try to delay Brexit beyond October 31 if he cannot agree exit terms with Brussels was like "running up the white flag".

Ahead of a first vote in the House of Commons yesterday evening, Johnson said: "There are no circumstances in which I will ever accept anything like it".

His aides had already warned that defeat would force him to call a snap election ahead of a crucial EU summit on October 17-18 -- and a mere fortnight before Brexit.

The rebels believe they have the numbers to force through the plan, which is backed by the main opposition Labour party and could delay Brexit to January 31.

In the order, the magistrate said the bail petition was rejected, considering the gravity of the statements Mainul made on electronic and print media.
