Myanmar continues to act with impunity

Int'l communities' inertia to blame, says UK's All-Party Parliamentary Group on Rohingya

Inertia at the international level has removed pressure on Myanmar and its allies and enabled impunity despite the country's military being accused of crimes against humanity and genocide, said UK's All-Party Parliamentary Group on the rights of the Rohingya in a report published on Tuesday.

widespread "Despite the recognition that crimes, possibly amounting to crimes against humanity and genocide, were committed, the Myanmar military are yet to experience meaningful consequences either criminally or politically," it said.

Myanmar is not only unable and unwilling to investigate and prosecute international crimes, the international community are enabling them to continue to act with impunity. Members of the UN Security Council are blocking routes to international justice and enabling barriers, the report said.

The report titled A New Shape of Catastrophe was published two years after the Myanmar military crackdown in Rakhine that caused an influx of over 743,000 Rohingyas to Bangladesh.

The All-Party Parliamentary Group (APPG), chaired by Anne Main MP and co-chaired by Rushanara Ali MP, has called for the UK, as penholder on Myanmar at the Security Council, to lead on a Chapter VII UN Security Council resolution, setting out current conditions and the need for referral to the International Criminal Court (ICC). Referring Myanmar's case to the

ICC is the only way that the entirety of crimes that have been committed would come under ICC jurisdiction, the report said. While the ICC has commenced

a pre-examination of crimes related to deportation of the Rohingya now in Bangladesh, this work would be limited in scope and likely fail to address the full range of violations and atrocities, AAPG report observed. The report said raising the situation

at the Security Council could help to change Myanmar government's political calculations as well as isolate and raise the political cost on China, Russia, and other countries that would prefer the status quo of Council inaction on the situation.

"The UK government should impose and expand targeted sanctions on military leaders, including Commanderin-Chief Sr Gen Min Aung Hlaing, and key military-owned enterprises, and impose a comprehensive arms embargo on Myanmar.

Fleeing military atrocities, including Replying to another query, Hasina killings, rapes, tortures and burning of houses in the Rakhine State, more than 743,000 Rohingyas took shelter including Teesta water-sharing, before in Bangladesh since August 25, 2017. They joined the 300,000 others who had arrived earlier.

The second repatriation attempt failed last month.

Bangladesh has said Hasina continued its diplomatic efforts with the international community, including the UN, for the repatriation. Besides, European Union, Australia and United Kingdom have imposed sanctions on

Myanmar military officials. "We have requested friendly states like China, India and Japan for playing the necessary role in resolving the Rohingya crisis. We hope Myanmar

will create a conducive situation in Rakhine and start taking back the Rohingyas soon," she said. The prime minister then reiterated

that Bangladesh gave shelter to the forcibly displaced Myanmar citizens on humanitarian grounds.

She added her five-point proposal at the 72nd UNGA session in 2017 was well accepted by the world leaders. The proposals included Myanmar must unconditionally stop the violence and the practice of ethnic cleansing in the Rakhine State immediately and forever, and the Secretary General of the United Nations should immediately send a

Fact-Finding Mission to Myanmar. All civilians irrespective of religion and ethnicity must be protected in Myanmar. For that "safe zones" could be created inside Myanmar under UN

supervision, according to the proposals. 'AL DOES NOT BELIEVE IN

Answering a query from BNP lawmaker Rumeen Farhana, the PM said had the AL believed in the politics of vengeance, there would have been no existence of the BNP in the country.

DEMOLISHED IN MYANMAR

In a recent visit, BBC Southeast Asia Correspondent Jonathan Head saw four locations in Rakhine where secure facilities have been built on what satellite images show were once Rohingya settlements. One of the locations include

Hla Poe Kaung transit camp, which Myanmar government says can house 25,000 returnees. The camp was built on the site of two Rohingya villages, Haw Ri Tu Lar and Thar Zay Kone, demolished after the 2017 violence, reported BBC on Tuesday.

Another Rohingya village called Myar Zin was bulldozed to clear land for this camp. Speaking off-camera, officials there confirmed to BBC of the demolition.

Just outside the main town, Maungdaw, was Myo Thu Gyi, which once had a population of more than 8,000 Rohingyas. In September 2017, BBC filmed Myo Thu Gyi where many of the houses had been burned, but larger buildings were still intact. But now, there is a large government and police complex.

About three quarters of the population was Muslims in Inn Din, a village notorious for a massacre of 10 captured Muslim men in September 2017. The rest were Buddhists. Today, no trace of the Muslim quarter remains, reported BBC.

The houses, where Muslims used to live, were replaced by barbed-wire fences enclosing an extensive new Border Guard Police barracks. The Rakhine Buddhist residents told BBC they would never accept Muslims living next to them again.

amputated hand. "Where is it? Bring it to me, I'll fix it," said the little girl, leaving his father in tears.

Distraught, Numan wonders how he would take his daughter out on his motorbike like he used to do every day.

"How will I take her on my motorbike?" he asked as his voice cracked.

Numan, an executive member of Mymensingh district Swechchasebak League, further said some villagers of Khodaboxpur gave Tk 1.8 lakh to a local Jubo League leader and his men for 30 electricity connections a year ago. But they failed to arrange power connections from local Palli Bidyut office.

"Later, the villagers made efforts to get electricity connections, and I helped them in this regard. This was my fault," Numan told this newspaper yesterday.

Palli Bidyut officials, along with local policemen, went to the village on September 2 morning to give electricity connections, he said.

"When they were working, those who took money from the villagers tried to stop them. Police then chased them away. They [those who took money] thought I was behind it [arranging power connections]," Numan said quoting villagers.

Around 5:30pm, a group of armed men, led allegedly by Rezaul Karim Sumon, president of Jubo League Joshora union unit, attacked him when he was returning home from Bhaluka upazila by his motorbike.

"I was first hit by stones. When I fell to the ground, they attacked me with machetes, pipes and iron rods."

Numan said among the attackers, he could identify Sumon, Rakib, Akib, Wahid, Faisal, Mahfuz, Olad, Mustakin and Sarwar Jahan Dhanu.

"I could hear them scream 'kill him, kill him' ... Sumon, Mahfuz and Olad started hacking my left hand with machetes. Then I lost consciousness.'

Numan was first taken to Bhaluka Upazila Health Complex. As his condition worsened that night, he was brought to NITOR in the capital.

Hours later, Numan's left hand was amputated. The doctors were struggling to stop bleeding. He needed five bags of blood, said his family members.

Numan's wife Mahmuda filed a case with Gafargaon police station on September 2 against 15-16 people, including Sumon. Nine of the accused were named and the rest unnamed.

"They carried out the attack to kill

him," said Mahmuda.

She said it was beyond her imagination that she would have to see her husband in such a state.

Expressing unhappiness police's role, she alleged that the accused were roaming free in the area but law enforcers were not arresting them. "Police arrested only one of the

accused, but he too was released on

Sub-inspector Ahsan Habib, also investigation officer of the case, said they arrested Sarwar, president of Jubo League Ward-3 unit in Joshora union, for his alleged involvement in the attack on September 2. But he was freed on bail.

Of the accused, Wahid and Akib were arrested for drug peddling in August this year and a Mymensingh court sent them to jail. They were later released on bail, added the official at Gafargaon police station. Asked about the family's allegation

of police negligence, Monirul Islam, inspector (investigation) at the same police station, said the claim was not true, and police were carrying out drives to arrest the attackers. Aminul Islam, a resident of

Khodaboxpur village, said he along with several others had given money to a local Jubo League leader to get electricity connection a year ago but didn't get it.

"Recently, we made efforts on our own to get power connections, and Numan helped us." Demanding immediate arrest of

the attackers, Aminul said it was sad that Numan was attacked for helping them. The Daily Star tried to reach Sumon on his mobile phone several times

yesterday but found it switched off. Talking to this newspaper, Tariqul Islam, chairman of Joshora union parishad, said Sumon was watching a football match on Dowlatpur High

School ground when the incident

took place. "Sumon was not involved in the incident. He may have been implicated in the case out of rivalry in local politics," said Tariqul, member of Gafargaon upazila AL unit.

Asked why no organisational action was taken against the alleged Salahuddin attackers, Polash, convener of Gafargaon Jubo League, said the matter was still under police investigation.

He further said they were "observing" the developments.
