Unidentified criminals killed two fish farmers early yesterday allegedly due to previous enmity over taking lease of a local waterbody in Meherpur Sadar upazila.

Being informed, police recovered the throat-slit bodies of Rokonuzzaman, 36, son of late Idrish Ali, and Hasan Ali, 42, son of Azad Ali, of Darbeshpur village in the upazila from the bank of Shailmari Beel yesterday morning and sent those to Meherpur General Hospital for autopsy.

Lessees Rokonuzzaman and Hasan, who took lease of Shailmari Beel from the government about four years ago, used to guard the waterbody along with some labourers at night, locals said.

Unidentified criminals killed the duo around 1:30am by slitting their throats while they were sleeping inside a thatched hut on the bank of the Officer in waterbody, Charge (OC) of Sadar Police Station Shah Dara

Khan said. Sensing something labourers wrong, room and entered the throat-slit found bodies of the two, the OC added.

Meherpur Superintendent of Police (SP) SM Murad Ali visited the spot and said the slain duo had previous enmity with another group over taking lease of the waterbody.

Azad Ali, father of slain Hasan Ali, said a group of ruling party men of the same area had been threatening for dire son

consequences. They were investigating the reason behind the murders, the OC said.

Underground water in Teknaf, Ukhia receding fast

Locals struggle to source water for daily needs as thousands of shallow tube wells installed in Ukhia and Teknaf upazilas in 2017 to meet the water demands of more than a million Rohingya refugees have been taking a toll on ground water levels. The host community is unable to

secure water from 2,000 tube wells out of around 3,000 tube wells as the water level in the areas has dipped, according to data from the local union parishad (UP). The Roghingyas used to each collect

an average of 20 litres of water a day when they first arrived. As such, demand for daily water for 11 lakh Rohingyas stands at 2.2 crore litres at the Rohingya camps in the two upazilas.

Due to the water crisis, the amount they are able to draw has now reduced to about 15 litres, according to Refugee Relief and Repatriation

Commission (RRRC). According to United Nations High

Worker dies falling from building

A construction worker died after falling from the roof of an under construction seven-storey building in Sutrapur area of Bogura town yesterday.

The deceased was identified as Mohammad Aminur Rashid, 55, son of Mozammel Haque of Nishindhara area of the

Fellow workers and locals rescued Aminul and took him to Bogura Shaheed Ziaur Rahman Medical College Hospital, where the doctors declared him dead.

Recent floods snap road communication

Approach roads of 40 bridges and culverts in Saghata upazila washed away by surging water

Communications have been snapped as approach roads of 40 bridges and culverts on different roads connecting 10 unions in Saghata upazila have been washed away by recent floods, causing immense sufferings to commuters.

Under the disaster management and relief ministry, the village roads, bridges and culverts are being constructed for smooth communication. In July, the prolonged floodwater

has washed away approach roads of 40 culverts and bridges, snapping the road communications, said Mithun Kundu, project implementation officer in the upazila.

Meanwhile, four bridges -- Bati bridge, Kaderdaha bridge, Anata bridge and Jumarbari bridge -- partially collapsed as the surging water hit its pillars.

Ataur Rahman, a resident of Bati village

in the upazila, said the construction work

of a bridge on Trimohoni-Bonarpara road in the area was completed before the rainy

Soon after completion of the construction work, flood hit the area and washed away the approach roads of the bridge, snapping communication, he said.

Road communication of the area with the upazila and district headquarters still remained snapped, said Ataur.

Rafiqul Islam, a rickshaw-van puller, said he was compelled to stop pulling rickshawvan on bumpy roads in the area.

Saidur Rahman, a petty trader of Munshirhat in the upazila, said they face immense problem to carry goods from the district headquarters as any drivers and rickshaw pullers do not want to cross the damaged roads.

Project Implementation Officer Mithun Kundu said the renovation work of damaged roads and bridges will be started soon after the water from damaged points recedes.

TAKING CONTROL OF ILLEGAL SAND STATION

11 injured as two rival groups clash

At least 11 people were injured in a clash between two rival groups over taking control of an illegal sand station on the east end of Bangabandhu Bridge in Bhuapur upazila yesterday.

The injured were admitted to Bhuapur Upazila Health Complex. Of them, four were later referred to Tangail General Hospital for better treatment.

Quoting locals and witnesses, police said the clash took place between the supporters of Abdul Matin Sarkar, chairman of Nikrail union parishad (UP), and men of Noor Alam Mondol alias Nohu, a member of the UP, in Sirajkandi Bazar area that 11 people from both sides injured.

Being informed, police immediately went to the spot and brought the situation under control.

Officer in Charge of Bhuapur Police Station Rashidul Islam said there had been a longstanding rivalry between the two groups over taking control of the sand station.

Locals alleged that some influential people, having political clout, have been running the sand business centring at least 18 illegal sand stations stretching from Palshia to Jigatala on the east side of the bridge. Although sand lifting is prohibited within six-kilometre radius of the

bridge, some unscrupulous traders continue lifting sand illegally from the Jamuna river. Recently the upazila administration launched separate mobile court

drives in the two sand stations and fined two sand traders. They also jailed one of the traders for seven days for lifting sand illegally from near the bridge.

Man killed over land dispute

A man was killed in an attack allegedly over a disputed land in Gafargaon upazila of the district early yesterday.

The victim, Humayun Mia, 28, was son of late Matin Mia of Rauna village in the upazila.

Quoting locals, Officer in Charge (Investigation) of Gafargaon Police Station Monirul Islam said there had been a feud between Humayun and Shahar Ali of adjacent Dhopaghat Namapara village over a disputed land for long.

As a sequel, Shahar's men attacked Humayun's house around 8:00pm on Wednesday night and looted valuables when none of the family members were present at the house, said the OC.

Hearing the news, Humayun and his younger brother went to Dhopaghat Bazar but as soon they reached there some 30 people allegedly loyal to Shahar attacked them with sharp weapons, leaving the two severely injured.

Later, Humayun died while he was on his way to a hospital in the capital around 4.00am, the OC added.
