HC for judicial enquiry into OC's role

The High Court yesterday directed the Rajshahi chief judicial magistrate to conduct an enquiry into the alleged manipulation of the first information report (FIR) of a murder case by Puthia Police Station OC Shakil Uddin Ahammed.

In response to a writ petition, the court also asked the chief judicial magistrate to submit the probe report to it in 45 days.

The HC issued a rule asking the respondents to explain why the OC should not be suspended for manipulating the FIR of the case filed over the murder of workers' leader Nurul Islam on June 10.

Farooq Abdullah, a three-term chief minister of Jammu and Kashmir and five-time parliamentarian, was arrested yesterday under the stringent Public Safety Act (PSA) and his residence was declared

Don't publish news that may impact cases

Press council tells the media

Bss, Dhaka

Bangladesh Press Council yesterday issued instructions regarding court reporting, urging the media not to publish any news or article that may influence under-trial cases.

During the court proceedings, the arguments between judges and lawyers are solely assets of the court and they are not something to be published in newspapers, said a handout of the press council.

Before the delivery of the final judgment, journalists should refrain from publishing any comment or opinion over under-trial cases or issues as these can defame judges or influence verdicts of cases, it said.

Angry bees delay Air India flight

An Air India flight was delayed by several hours after a swarm of bees landed on the cockpit window, attacking ground staff when they tried to remove them, officials said.

The insects landed on the window just before the plane was due to leave the eastern city of Kolkata on Sunday with 136 passengers, including Bangladesh's information minister.


Ground staff tried to shoo the insects off, angering them, and when attempts to use the windscreen wipers failed officials switched to 'plan b' and blasted them off with water. "Fire tenders were deployed to spray water to

dislodge the honey bees and they could be driven away after nearly an hour-long operation," airport official Kaushik Bhattcharya told AFP.

Senior pilots and airline officials said no aircraft is allowed to take off if it has a swarm of insects on the cockpit glass.

'Robber' killed in 'gunfight'

A suspected robber was killed in what police claimed was a gunfight between police and armed cohorts of the suspect in Rajbari's Sadar Upazila early yesterday.

ATTACKS ON SAUDI OIL PLANTS Trump hints at

military action US officials point finger at Iran

citing intel; Russia, China urge restraint; oil prices surge

Oil prices made their biggest jump since the Gulf War yesterday after President Donald Trump warned that the US was "locked and loaded" to respond to attacks on Saudi oil infrastructure that Washington blamed on Iran.

It is the first time the president has hinted at a potential American military response to the drone attacks, which slashed Saudi oil production by half and led both the kingdom and the United States to announce they may tap their strategic reserves.

"Saudi Arabia oil supply was attacked. There is reason to believe that we know the culprit, are locked and loaded depending on verification, but are waiting to hear from the Kingdom as to who they believe was the cause of this attack, and under what terms we would proceed!" Trump tweeted.

China yesterday urged the US and Iran to "exercise restraint... in the absence of a conclusive investigation or verdict".

The Kremlin warned against a hasty reaction to the drone strikes on the oil facilities.

US has issued satellite images and cited intelligence to back its allegation Iran was behind the attacks. Unnamed US officials speaking to US and international media said the direction and extent of the attacks cast doubt on Houthi involvement.
