Can Suu Kyi be legally implicated?

UN investigators call for expert evaluation

UN investigators yesterday called for an expert evaluation of whether Myanmar's civilian leader Aung San Suu Kyi can be legally implicated in the abuses committed against the country's Rohingya minority.

The fact-finding mission to Myanmar, set up by the UN Human Rights Council, said they were not equipped to determine what level of responsibility Suu Kyi should shoulder for the Rohingya crisis.

"It will become a legal issue whether or not there is an element of culpability here," fact-finding mission chair Marzuki Darusman told reporters in Geneva.

The Human Rights Council recently created a panel to prepare criminal indictments over atrocities committed in the country -- the socalled Independent International Mechanism for Myanmar (IIMM) -- which could have the expertise to determine what responsibility Suu Kyi bears in the crisis.

"It is still an open-ended question to what extent she might be implicated," Darusman said.

When asked if the Nobel laureate

might be implicated, he said "that is for the judicial process to address," referring to the IIMM. The fact-finding mission last year

branded the army operation in August 2017 as "genocide" and called for the prosecution of top generals, including army chief Min Aung Hlaing.

Some 740,000 Rohingya fled burning villages, bringing accounts of murder, rape and torture over the border to sprawling refugee camps in Bangladesh, where survivors of previous waves of persecution already languished.

And in a damning report published Monday, the investigators warned that the 600,000 Rohingya still inside Myanmar's Rakhine state remain in deteriorating and "deplorable" conditions and continue to face a

"serious risk of genocide".

The experts told the rights council yesterday that they had a confidential list of some 150 names, including officials, suspected of being involved in genocide, crimes against humanity and war crimes.

'CRIMINAL RESPONSIBILITY'? Darusman said that the investigators

initially shied away from laying blame on Suu Kyi, who spent years in house arrest before her party in 2015 won Myanmar's first fully free vote for generations. He said that the fact-finding team

had taken into account that Myanmar

was "going through a transition, a democratic transition, and therefore in our first report we absolved Mrs. Aung San Suu Kyi from any direct responsibility." But while it was likely that Suu Kyi was not aware in August 2017 of the army's activities, "the issue now is that

"The longer this goes on, the more impossible it is for the civilian side of the government to escape international criminal responsibility for the human rights situation in Myanmar."

The fact-finding mission, which was never granted access to Myanmar, is expected to wrap up its work during the ongoing session of the Human Rights Council, due to end next week.

But the UN Special Rapporteur on the rights situation in Myanmar, Yanghee Lee, should continue monitoring the situation.

'We're being threatened'

Say JU BCL leaders who spoke up about

receiving money from VC

A number of Jahangirnagar University Chhatra League leaders who publicly spoke about receiving a hefty amount of money from JU VC Prof Farzana Islam last night said that they were feeling insecure on the campus after being threatened over phone.

"We got several phone calls from unknown people telling us to leave the campus. Or else we may face consequences," said Saddam Hossain, joint secretary of JU BCL, at a press briefing at Bishwakabi Rabindranath Tagore Hall around 9:30pm.

We received the threats in the afternoon, Saddam said.

Three BCL leaders -- Vice President Niamul Hasan Taz, Organising Secretary Shamim Molla and Saddam -- also claimed that their phone

networks went dead in the evening. A number of teachers who raised

voice during the ongoing protest against alleged corruption on the campus also told The Daily Star that they could not make or receive any calls from their phones from around 7:00pm to 11:00pm last night.

The teachers include Pro-VC Prof Amir Hussain, former VC Prof Sharif Enamul Kabir, Prof Rayhan Rhyne of philosophy department, Prof Sayeed Ferdous of anthropology, Prof Jamal Uddin Runu of environmental sciences department, Prof Tarek Reza and Prof Shamima Sultana of Bangla department. However, Provost

Rabindranath Tagore Hall Provost Prof Abdullahel Kafi said, "As they have received threats over the phone, they should file general diaries with the nearest police station.

We are aware of the ongoing tension on the campus, he added.

An audio leak that went viral following the ouster of central BCL president and secretary also indicates that an exchange of money involving the National Education Day at the the VC's family and JU BCL top brass took place.

Fish dying in Hakaluki haor

When farmers were looking forward to some earnings by fishing, the Hakaluki haor in Moulvibazar has turned into a contaminated wetland with dead fish floating ashore.

According to the district's fisheries department, the deaths have been caused by ammonia released by rotten weeds. The gas is replacing the oxygen dissolved in the water. The Hakaluki haor flows over

28,000-hectare land in four upazilas of Moulvibazar and one upazila of Sylhet in north-east Bangladesh. Sight of dead fishes lying ashore have been visible since Sunday in

Gourkul, Chokia, Dholia, Nagua, Kanli, and Hawabonna swamps. Puti, Tengra, Veda, Bailla, fries of Boal, Pabda, and Rui are among the dead fish emitting stench in the

adjacent areas. Fish is the second cash crop for farmers of Kulaura, Juri, and Barlekha upazilas of Moulvibazar.

Abdul Kadir of Bhuksimoil village of Kulaura told this paper, "This year, I incurred losses after selling Boro paddy through middle men. I thought we will survive by catching fish from the haor. But now fish are dying just like in 2017." After flashfloods in 2017, fish in the

rich haor died posing health hazards. It came as a double blow for farmers as they had lost acres of paddy just weeks ahead of the annual harvest season due to flood. "Weeds have died and started to rot lately. As a result, the fish are

deteriorating," said Moulvibazar District Fisheries Officer Emdadul Haque. When asked what measures the authorities were taking, Sultan

chapter, said, "At this time of the year, mother fish produce millions of fries in swamps of Hakaluki. But this time they are dying. This might lead to scarcity of fish in upcoming days." Besides, the haor was home to

many animals, birds, and a large variety of flora and fauna, he added. "The water has become polluted

by the rotten weed and dead fish. Usage of this water may cause skin diseases and respiratory problems," said Partho Sarathi Datta Kanungo, superintendent of 250-bed Moulvibazar District Hospital, asking people not to consume the water or the fish.

Marufatuzzahan, chairman of the Animal and Fish Biotechnology Department at Sylhet Agricultural University, said, "Rotten weed could be partially responsible for increase of acid levels in the water, but studies need to be done to determine what actually cost the lives of the fish."

"In the past, a group of importers in league with Clearing and Forwarding (C&F) agents earlier took delivery of such hazardous and contraband fish and poultry feed through irregularities such as changing samples and forging officer at the BCSIR, said, "In no way available. lab reports.

Some customs officials helped them," said Akbar Hossain, additional commissioner of Chattogram Customs House.

"We took some strong steps in collecting, sealing and transporting samples, and changed the laboratory when we learned about the forgery," he said, adding that after taking the new measures, they found MBM and animal by-products in the poultry and fish feed.

In the last two and a half years, they sent samples of imported goods to several laboratories but did not get any hazardous and banned items in their

reports, he said. All imported goods have to go through physical or lab examinations before they are released from the Chattogram Port. According to officials, more than 4,500 types of products enter Bangladesh through this port, and about 1,000 of them go through lab

Prof Dr Mukhles Uddin, a cancer specialist at Chattogram Medical College Hospital, said bacteria and virus can infest animal bones, which are left out in the open for a long time. They

may cause cancer in humans if ingested. "It will not leave any adverse impact immediately, but the consumers can get cancer after 10-15 years."

According to the customs documents, the seized feed were imported by 12 firms -- Aisha Corporation, VNF Agro Ltd, Spectra Hexa Feeds Ltd, Promex Agro & Feed Products Ltd, Fishtech BD Ltd, Aquatech Agro (BD) Ltd, Advance Agrolek Bangladesh, Quality Feeds Ltd, RRP Agro Farm, Inter Agro BD Ltd, Magnify Agro Ltd, and MKA Hatchery.

Talking to The Daily Star, VNF Agro Managing Director AKM Khairul Islam Chowdhury said, "We were not aware of the existence of hazardous ingredients in the imported feed." Documents show that Aisha

Corporation imported 601 tonnes of fish feed worth about Tk 1.7 crore from Vietnam in early July. The authorities gave clearance for the release of their goods based on a report of the BCSIR, and the importer took the delivery of around 322 tonnes. However, the customs seized the

rest as hazardous substances were found when they re-collected samples on information and sent those to the icddr,b and Poultry Resource and Training Centre for retests.

But the responsibility lies with the laboratory authorities," he said, adding that BCSIR would look into the matter if a specific complaint was lodged by the customs authorities.

Chattogram Customs Commissioner Fakhrul Alam said they would write to the labs for an explanation of the process they applied for sample analysis.

In the last two months, more than 5,000 tonnes of fish feed were imported to Chattogram Port. But most importers have not received them yet, fearing that tests might detect hazardous elements in them, said officials.

"We are issuing letters to the importers to take their goods away from the port. If they don't do so, the products will be destroyed as per rules," the customs commissioner said.

Mahbub Kabir, member Bangladesh Food Safety Authority, said MBM was banned because it is made from bones and waste of animals including cow, pig and goat. It can carry virus, bacteria and other ingredients harmful for human health. "We had collected samples of fish

and poultry feed from the market. We had also collected chickens and fish, which consumed the products, to conduct the research," he said. Findings showed that

from creating antibiotic resistance, consumption of these chickens and fish might cause cancer in human bodies, Kabir said. He said the government banned

MBM last year after the Food Safety Authority found such hazardous elements in samples collected from the market at different times. Elias Hossain, manager (marketing) of Promek Agro & Feed Products

Ltd, said the seized consignment was certified by exporter as fish feed. "The first BCSIR lab report also mentions that the consignment was safe." He alleged the customs authorities
