This capped langur (hanuman) was spotted recently at Munshiganj's Sirajdikhan locality. This species of langur has been enlisted as "vulnerable" by IUCN. Forest officials have advised people not to disturb the feral animal.

Assailants kept track of Savar AL leader's movement: investigators

Wife of prime accused in murder case gives confessional statement to court

Wife of the prime accused in a case filed over the killing of Savar Awami League leader Abdul Mazid in a confessional statement before a Dhaka court has said Mazid was killed in a planned way, according to investigators.

Afroza Begum, 27, wife of Mikail Mollah, 60, gave the statement under Section 164 of the Code of Criminal Procedure on Monday, said Saiful Islam, inspector (investigation) of Savar Model Police Station.

"We believe it was a pre-planned murder, and took place over establishing supremacy in the area," said Saiful, also the case's investigation officer.

According to police, criminals shot Mazid in the head near his home in Baktarpur area on Saturday night while he was returning from Dhaka. He was declared dead at Enam Medical College Hospital.

Mazid, 37, was the assistant public affairs secretary of Savar municipality unit

A few days ago, Mazid and his neighbour Mikail had an altercation that led to Mazid slapping him. Since then, Mikail and his associates had been plotting revenge, said the IO quoting Afroza. "She said they kept track of when Mazid left and returned

home," the IO added.

He did not disclose how many people were involved in the incident for the sake of investigation.

During the attack, another local AL activist sustained bullet injuries. He is

receiving treatment at a hospital. Rahman, additional Saidur superintendent (crime) of Dhaka district police, said Mazid's father filed the murder case with Savar Police Station against nine named and eight to nine

unnamed people. The accused are Mikail, Anwar, 60; Morin Hossain, 45; Moktar Hossain, 40; Swapan, 38; Sujat, 38; Babu, 26; Munir, 20; and Ripon, 20. All of them are neighbours of Mazid.

The IO said police detained Afroza, who is the second wife of Mikail, and Moktar for questioning. They were shown arrested and produced before the court, which sent Afroza to jail after hearing her statement. It also placed Moktar on a twoday remand.

Abul Kashem, father of Mazid, told The Daily Star yesterday that his son was murdered as he was vocal against Mikail and his associates' narcotics business. He demanded a fair investigation and capital punishment for the killers.

'ILLEGAL ENROLMENT FOR DUCSU'

Our admission was valid: BCL leaders

Those who were elected from Bangladesh Chhatra League's (BCL) panel in Dhaka University Central Students Union (Ducsu), yesterday echoed the dean of Business Studies faculty regarding the enrolment of 34 former and incumbent BCL leaders in an evening programme of the Faculty of Business Studies without admission test.

At a press conference held at the Ducsu building, the leaders claimed that those who completed graduation and post-graduation from DU can be enrolled in any evening programme only through a viva-voce.

"Those who were elected in the Ducsu election, got admitted following the university's rules and regulations. A specific student organisation is being blamed for it and it is being said that special treatment was given to the activists of that student body. This is not true, leaders and activists of other active student organisations were also enrolled in the same way," said Ducsu assistant general secretary and DU unit BCL general secretary Saddam Hussain.

A media report which unveiled that the 34 BCL leaders got enrolled in the university ahead of the election without any admission test or viva voce. Eight of them were elected in Ducsu and hall unions.

After announcement of the polls schedule on February 11, these former and current leaders of BCL got enrolled under Masters of Tax Management programme to carry on their studentship; the admission test was held on November 30, 2018, according to the media report.

'We must change our feudal mindset'

Mujibul Haque says on ending child domestic labour

The practice of employing children as domestic workers will never stop in Bangladesh if people do not change their mindset, speakers said at a discussion yesterday. The mindset of keeping a child,

particularly female, to do household work will not change easily if there are no strict rules and regulations, so the government should formulate a separate act regarding this issue, they added. Bangladesh Shishu Adhikar Forum

(BSAF), a coalition of 269 non-government organisations, in association with Terre des Hommes Netherlands and Global March Against Child Labour, organised the discussion on rights of child domestic workers at The Daily Star Centre in the capital.

"Child domestic workers become victims of physical, mental and sexual abuse almost every day," said Abdullah Al Mamun, a director of Save the Children.

They are also exploited by their employers, not even given sufficient breaks, and most often don't have access to education, medical treatment and entertainment, he

said in a keynote presentation. "We have to change this mindset of employing children for domestic work... do

In 2015, the government approved a policy for protection of domestic workers, setting 12 years as the minimum age for the work. But it eventually failed to protect them, he said. The child rights specialist

The returning officer allocated symbol "wooden plough" for Jatiya Party (JP)nominated candidate Rahgir Al Mahi Saad Ershad, "sheaf of paddy" for BNPnominated candidate Rita Rahman, "motor bus" for independent candidate Hossain Mokbul Shahriar Asif, "mango" for National People's Party candidate Shafiul Alam, "fish" for Gono Front candidate Muhammad Shahidullah and "wall clock" for Tauhidur Khelafat Majlish-nominated candidate Rahman Mandal Raju.

After getting their respective symbols, most contesting candidates and their supporters started election campaigns

through bringing out rallies and visiting door-to-door, seeking votes for their

respective candidates and symbols. Talking to the news agency yesterday, the returning officer said a total of 4,41,224 voters are eligible to cast their votes in Rangpur-3 by-election, slated for October 5. Voting of the by-election will be held using the electronic voting machines (EVMs) at all 1,023 booths of 175 polling centres across the constituency from 9am

to 5pm on the day. "A total of 3,244 election officials, including 175 presiding officers and 3,069 assistant presiding officers and polling officers will conduct the voting process at all 175 polling centres in the constituency," Sahatab said.
