## Police wake up, finally

Raid illegal casinos in 4 sports clubs run for several years, hardly 300 yards off Motijheel Police Station

It apparently took Motijheel police years to even learn about the four "casinos" operating in the very same block as the police station. As part of the crackdown against illegal "casinos", police

simultaneously raided the four gambling dens housed inside Mohammedan Sporting Club, Arambagh Sporting Club, Dilkusha Sporting Club, and Victoria Sporting Club yesterday.

All the clubs are located within a few hundred yards of Motijheel police station. But the illegal operations within them managed to remain hidden in plain sight.

Till yesterday, that is, when the raids began at 2:30pm. Deputy Commissioner of DMP (Motijheel Division)

Anwar Hossain said that they had been unaware of any casino in the clubs, adding that they conducted the drives based on a tip-off. Mishu Biswas, assistant police commissioner (Motijheel

zone), told The Daily Star that they had heard of illegal gambling taking place on a small scale in these locations and mentioned previous raids there without going into the specifics. He said they did not know how much they had grown

over the years. There was, however, no answer as to why the police had

not known what was happening in their own backyard.

Fakirerpool Young Men's Club and Dhaka Wanderers Club, which had been running "casinos", are just behind the Motijheel police station, separated only by the walls of a police barrack. But they came to the nation's attention during the crackdown against "casinos".

About 100 feet further ahead, two more "casinos" at SEE PAGE 2 COL 2

#### Samrat digs in at office fearing arrest

Samrat has allegedly dug himself in at his office in Kakrail to avert arrest and is desperately looking for ways to leave the country, his party men told

The Daily Star yesterday. They said Samrat deployed his security men and supporters to surround the building in the wake of law enforcers' crackdown on "casinos" at sporting clubs in the capital.

The party men, refusing to divulge their posts in the ruling-party youth front, said that since the arrest of Jubo League leader Khaled Mahmud Bhuiyan on Wednesday, in connection with running a "casino" at a football club in Fakirerpool, Samrat has been staying at his office.

The Daily Star correspondent visited Samrat's office around noon yesterday and stayed there for around three hours. This paper could not independently verify whether he was actually inside the office.

Samrat's supporters had virtually cordoned

# Dead man talking

former union parishad chairman in Brahmanbaria died on November 2 last year, but documents placed before a district court show he "gave statement" to a police officer as a witness in a murder case nearly three months after his death.

The documents also show that PBI Inspector Harunur Rashid, the investigation officer of the case, recorded deposition of a retired

government official as a witness on a date when the man was in India for treatment. The inspector submitted a four-page

supplementary charge sheet on April 9, mentioning that he recorded statements of 50 witnesses. Later, 24 of the witnesses filed affidavits with the court stating that they did not give any depositions as witnesses. Such big flaws and discrepancies in the

investigation came to light when former chairman of Biddyakut Union Parishad Abdul Hannan Bhuiyan addressed a press conference on September 8.

one of the 10 accused. Hannan alleged that Inspector Harunur Rashid

demanded a bribe of Tk 20 lakh from him on March

21. As he refused to pay, his son and a nephew were named in the charge sheet.

Following Hannan's allegation, The Daily Star analysed relevant documents and talked to a dozen people.

The papers show the PBI inspector recorded statements of former Biddyakut UP chairman Abdur Rouf and Ajanta Kumar Bhadra of Merkuta village in Nabinagar upazila on January 31. Rouf and Ajanta are witness No 36 and 37.

> Rouf's elder son Moniruzzaman said his father died of heart attack on November 2 last year.

After the man aged 73 complained of chest pain, they headed for Dhaka for his better treatment. As his condition deteriorated on the way, he was taken to a hospital in Sonargaon in Narayanganj, where he breathed his last.

Moniruzzaman showed a copy of his father's death certificate they collected on December 4 last year from Biddyakut Union Parishad. The Daily Star obtained a copy of the death certificate.

According to locals, Rouf was a respected person In the supplementary charge sheet, Hannan is in the area and four-time UP chairman. Many of them attended his Namaz-e-Janaza.

NID FORGERY IN CHATTOGRAM EC OFFICE

## 50 outsourced staffers under scanner

4 data uploaders held for quizzing

Some 50 staffers, mostly data entry operators, of different projects of the Election Commission's Chattogram office are under the scanner, after investigators found their involvement in making Bangladeshi National Identity (NID) cards for the Rohingya people, police said.

Members of the Counter Terrorism (CT) unit yesterday detained four more data entry operators for interrogation in a case filed over the NID forgery.

Earlier, police arrested technical expert Mostafa Faruq with an official laptop of the EC, voter signature pads, an internet modem, and flash drives containing information about some Rohingya people.

The latest detainees are: Md Shahin, Fahmida, Pavel Barua and Md Jahid, said sources in the CT unit.

Of them, Shahin and Fahmida are data entry operators of the Kotwali thana Election Commission office. Pavel and Jahid are data entry operators of Double Mooring and Bandar thana EC office.

The four were picked up from their workstation at the district Election Commission office around 1:00pm, said Mohammed Shahidullah, deputy commissioner (CT unit) of the Chittagong Metropolitan Police.

"We are trying to verify some information gleaned from the other

arrestees," he said. "Joynal, who was arrested earlier, and Mustafa gave some information

### Restrictions for lower court judges

The Supreme Court administration yesterday issued a set of directives for the lower court judges on using social media, asking them not to upload images and video clips of SC judges and also not to publish information or make comments that go against the national unity and spirit.

The instructions were issued through a notification that said the lower court judges have to stop using social media during their working hours from 9:30am to 4:30pm.

The notification, signed by SC Registrar General Md Zakir Hossain, said if the instructions are defied, it will be considered misconduct and Bangladesh Judicial Services (Discipline) Rules-2017 alongside other relevant existing laws and rules will be applicable in this regard.

The laws and rules will be applied to ignore the directives, an SC official told The

### Rohingya couple killed in 'gunfight'

A Rohingya couple was killed in a "gunfight" with police in Cox's Bazar yesterday, hours after they were detained by the law enforcers.

The incident that claimed the duo -- Dil Mohammad, 32, and Zaheda Begum, 27 -happened at a refugee camp in Hnila union of the district's Teknaf upazila.

Pradip Kumar Das, officer-in-charge of Teknaf Police Station, said they detained the duo with a gun.

On their information, a police team, along with the duo, conducted a raid in the camp to recover firearms, the OC claimed.

As soon as they reached the area, a group of criminals opened fire, forcing the law enforcers to retaliate. At one point of the "gunfight" the duo caught in the line of fire, he added.

Police rushed them to Cox's Bazar Sadar Hospital where doctors declared them dead, he further said, adding that the bodies were sent to the hospital morgue for autopsies.

Three policemen were also injured during the "gunfight", the OC said. Police claimed to have recovered three

rifles, eight cartridges and 12 bullet shells from the spot. The Daily Star, however, could not

independently verify the police claims. Including the duo, a total of 41 Rohingyas have been killed in "gunfights"

so far.
