# DNCC knocks down offices of AL associate bodies in Uttara

Dhaka North City Corporation (DNCC) officials yesterday found and demolished two offices of the ruling party's associate organisation, that were encroaching footpaths in Uttara.

The offices of Uttara-Purba Paschim Thana Swecchasebak League and Jubo League units were constructed temporarily, according to leaders of the respective organisations.

During an eviction drive to free the footpath from illegal encroachment launched yesterday, DNCC also demolished more than 300 other illegal structures, including tea stalls and parts of restaurants extending on the footpath.

The drive started at around 11:30am from Sonargaon Road and continued through different parts of Uttara, including Garib-e-Nawaz Avenue, Rabindra Sarani and the rear side of Mascot Plaza till 3pm.

Mostafa Sardar, assistant publicity affairs secretary of Uttara-Purba Paschim Thana Swecchasebak League, said, "It has been seven to eight years that the office has been here; since we didn't have permanent office, we used it as our meeting place after office

A day before the drive, DNCC officials announced the eviction drive on loudspeakers. While most of the footpaths in Uttara were free from hawkers yesterday morning, some stalls were left closed on the footpath.

On the first day of the drive, DNCC's Executive Magistrate Sajid

# Establish democratic control over defence forces: M Sakhawat

The security expert urges govt to develop civil-military relationship

Noted security analyst Brig Gen (retd) M Sakhawat Hossain yesterday urged the government to establish democratic control over defence forces to develop relationship between the military and civilians.

In doing so, he proposed formation of an independent defence ministry headed by a public representative instead of the prime minister, reconstruction of the parliamentary standing committee on the ministry, and implementation of the national defence policy.

He also stressed on ensuring independence of the military within the sphere, and checking political and bureaucratic interference in their functions and duties.

Sakhawat, also a former election commissioner, made the proposals while delivering a lecture on civil-military relationship, organised by Asiatic Society of Bangladesh at its office in the capital.

Unlike other countries around the world, civilian control over the military is yet to be established in Bangladesh, which is necessary,

Sakhawat said. "It is high time that we establish civilian control as enshrined in the constitution," he said, mentioning previous military regime.

He also suggested to improve coordination among the defence forces to increase their efficiency.

About defence education, he urged the authorities concerned to introduce subjects on military history and strategy at public universities. "We need more experts, who are civilians, for military strategy," he

Asked whether the proposals are implementable in the current context, the security expert replied in the positive.

"It is all about political intention. If they [the government] have the intent, the proposals can easily be implemented," said Sakhawat Hossain.

National University Vice-chancellor Prof Harun-or-Rashid and Asiatic Society Secretary Abdur Rahim also spoke at the programme.

Asiatic Society organised the lecture in memory of Shaheed Colonel Jamil Ahmed, who sacrificed his life while trying to protect Bangabandhu Sheikh Mujibur Rahman on August 15, 1975.

2005 Series Bomb Blast

### 5 JMB men handed 12 years' imprisonment

A special tribunal in Dhaka yesterday sentenced five JMB members to 12 years' rigorous imprisonment in connection with a blast in Dhaka's Khilkhet area as part of the series bomb blast in 63 districts of the country on August 17, 2005.

Judge Md Al Mamun of Special Tribunal-2 of Dhaka handed down the sentence in presence of three convicts --Abdullah Al Sohail, Abdur Rahman Masud, Nurul Islam alias Uzzal.

Two other convicts -- Habibur Rahman Habib and Md Musa alias Mostafizur Rahman -- are absconding.

The tribunal also fined them Tk 30,000 each, in default of which they will have to serve six more months in jail.

The tribunal ordered that the punishment of the fugitives will be effective from the day of their arrest or surrender.

The banned militant outfit Jama'atul

Mujahideen Bangladesh (JMB) on August 17, 2005 simultaneously blasted bombs in 63 districts of the country. Around 500 bombs went off at 300

locations in the 63 districts. The bombs exploded within half an hour. JMB claimed responsibility for the blasts.

The blast in Dhaka's Khilkhet area took place near an over-bridge in front of Rajuk Market around 11am that day. A case was filed after the blast the same day in this connection.

The charge sheet of the case was submitted on November 20, 2005. The tribunal framed charges against the accused on June 12 of 2006.

After cross-examining 19 prosecution witnesses, the tribunal handed down the sentence.

# Apt skills training could reduce abuse overseas, experts say

Proper skills training of female migrant workers can be a way to reduce their abuse in the hands of employers, speakers said at a views-exchange meeting yesterday.

Besides, before departing the country, migrant workers should have adequate knowledge of the type of jobs they are going to be recruited in and other professional responsibilities, they said. Bangladesh Mahila Parishad arranged the meeting

These complaints were filed with Bangladesh embassy in Saudi Arabia; Expatriate' Welfare and Overseas Employment Ministry; Bureau of Manpower, Employment and Training; Bangladesh Association of International Recruiting Agencies; Wage Earners' Welfare Board and different non-government organisations, she said, reading

out a written statement. The country also received 311 bodies of women migrant workers over the past three and a half years, most of whom were working in Saudi Arabia, she added.

Referring to a recent survey, migration expert Prof Tasneem Siddiqui said some 30 percent of women migrant workers were either divorced or separated from their

financial condition and educational status were also lower than those of garment workers, she said, adding that predeparture training for such migrant workers could ensure their safety abroad.

They went overseas in desperation while their average

Lily Jahan, chairman of Bangladeshi Obhibashi Mohila Sramik Association, said women migrant workers often face abuse abroad because of lack of information.

Safe migration for them is possible if they can learn "the truth" about their jobs before departure, she said.

Rownaq Jahan, secretary, Expatriates' Welfare and Overseas Employment Ministry, said they have been working to ensure safe migration through developing both work and language skills of migrant workers.

BMET Director Nurul Islam said they have a one-month training facility but many women migrant workers do not want to avail such opportunity.

Ayesha Khanam, president of BMP, and Nadim Rahman, programme officer, migration and local government, Swiss Agency for Development and Cooperation, among others, spoke at the event.

# Chhatra Dal, BCL face off at Madhur Canteen

Slogans and counter slogans sparked an aggressive face-off between activists of Bangladesh Chhatra League (BCL) and Jatiyatabadi Chhatra Dal (JCD) yesterday, as JCD activists went to Dhaka University campus for the first time with their newly-elected leadership. Accompanied by over 200 JCD activists, Fazlur

Rahman Khokon and Iqbal Hossain Shyamol -- elected president and general secretary on September 18 -- entered Madhur Canteen at around 11am.

Hundreds of BCL activists -- led by its central unit acting general secretary Lekhak Bhattacharjee and DU unit president Sonjit Chandra Das -- were also present at the canteen at that time.

Lekhak exchanged greetings with leaders of the pro-BNP student organisation.

JCD activists then started shouting slogans in support of Khaleda Zia and BCL men shouted counter slogans against the incarcerated BNP chairperson. BCL activists were also seen taking position at

different areas of the campus. After staying at Madhur Canteen for an hour,

the JCD men left the venue alleging that political coexistence is yet to be ensured on DU campus

"We came to Madhur Canteen for the first

time after taking charge. We expected decorous behaviour from them [BCL] but they shouted inciting slogans. We would like to say coexistence is yet to be ensured," JCD general secretary Iqbal Hossain Shaymol told reporters.

Asked about the allegation, BCL acting general secretary Lekhak Bhattacharjee said, "The allegation is baseless. We only asked them not to shout 'zindabaad' slogans when they came to meet us." Later, the JCD men brought out a procession on

campus, demanding release of BNP chairperson Khaleda Zia from jail. Wielding a banner, they paraded the streets on DU campus and met the Vice-chancellor Prof Md

Akhtaruzzaman, seeking his cooperation. After the meeting, Chhatra Dal president Fazlur Rahman Khokan said, "We met the VC and asked for the authorities' cooperation to carry out our

political activities. He assured us of cooperation." BCL vice-president Al Nahian Khan Joy and joint general secretary Lekhak Bhattacharjee were given the charges of president and general secretary on September 14 after Rezwanul Haque Chowdhury Shovon and Golam Rabbani were removed from

the respective posts. Jatiyatabadi Chhatra Dal held polls for electing its president and general secretary after 27 years, in line with a court injunction regarding its council.

# 430 new dengue patients admitted to hospitals yesterday

Dhaka North City Corporation (DNCC) yesterday found Aedes mosquito larvae in 17 houses after visiting 9,868 houses. Mobile courts of DNCC also found favourable places

for Aedes breeding at 5,737 houses during the drive, said an official of the DNCC. They destroyed the larvae and breeding sources during

the drive, he said. Meanwhile, 430 new dengue patients were admitted to hospitals and clinics across the country in 24 hours till

8am yesterday. Of them, 298 are outside Dhaka.
