Promising malta cultivation in plain land

Rows of trees, six to seven feet tall, heavy with green malta fruit is a rare sight to behold at Satoti village in Mymensingh.

For the first time in Gouripur upazila, Abul Mansur Ahmed, an award winning agriculturist, has been able to successfully grow an orchard of the citrus fruit on 33 decimals of his ancestral land. Mansur, who retired as assistant

agriculture extension officer from the

Department of Agriculture Extension (DAE) in Mymensingh in 2017, said he wanted to experiment with large scale farming of malta in the plain land of Gouripur although the fruit usually grows in mountainous areas. "I collected some 90 malta saplings of BARI-1 variety from Gouripur Upazila

Agriculture Office in 2017 and started the orchard using my previous agricultural experiences," Mansur said. Two years later, he earned a profit of

about Tk 1 lakh by selling malta at Tk 4,400 per maund, he informed. "Around 60 trees bore fruits this year and there are about 60 fruits in each tree," he said, adding that the estimated

yield of his orchard was sold for Tk 1,60,000 and he has spent about Tk 60,000 behind his venture. Orchard owners usually sell out their estimated yield when the trees bear fruits

and take care of the fruit-bearing plants

until harvest and collection by traders. Mansur, who received the Bangabandhu National Award in 1999 for his contribution in the agricultural expansion of mukhi kachu (arum) and challisha potato (a local variety of potato), hoped that the rest of the malta trees will also bear fruit next year and the total production will increase as the trees attain maturity.

Firoza Begum, a sub-assistant agriculture officer in Gouripur, said malta trees start to bear fruits within a year and a five-year-old malta tree can bear around 400 malta fruits in a year.

Gouripur Upazila Agriculture Officer Lutfunnahar said malta, enriched with Vitamin-C, is a cash crop and it can become a good source of income for small farmers. However, malta cultivation needs proper

care so that the field is not affected by virus

and bacteria, added the official. After visiting Mansur's orchard, Farhana Karim, Gouripur upazila nirbahi officer (UNO), hoped that Mansur's success will

inspire other farmers of the upazila. Praising Mansur's success, Mymensingh DAE Deputy Director Mohammad Abdul Mazed said farmers should go for different types of fruit farming to meet the demands of the country's fruit markets.

Protests against use of expired saline

Nilphamari DC forms 5-member inquiry committee, medicine store sealed

deputy commissioner (DC) of Nilphamari yesterday formed a five-member inquiry committee, following Sunday's public agitation in front of the district's civil surgeon's (CS) office in protest against using expired intravenous saline for patients in Nilphamari 250-bed Modern Hospital. The committee headed by

ADC (General) Azaharul Islam sealed the medicine store of district health department attached to the CS office and started quizzing persons concerned in connection with the incident.

Locals formed a human chain at Chowrangi intersection

in the district town yesterday protesting various irregularities and corruption in the 250-bed hospital. On Saturday night, hospital staff pushed expired

intravenous saline to several patients in female ward, worsening their condition. The product had expired in May 2019, said the patients'

relatives, referring to the imprint on the packet. Of the affected patients, Mollika Begum, 45, of Natun

Bazar area was under treatment with chest pain and Prinka Rani, 14, of Baroipara area with stomach pain. "After my mother was taken to hospital, the on-duty

doctor asked me to get her ECG done at a diagnostic centre outside although the hospital is equipped with the facility," Mollika's son Sanwar Hossain alleged at yesterday's human chain. "After nurses pushed saline, my mother's condition

deteriorated. Checking the imprinted information, I found that the product had expired," he said.

"A syndicate controls different matters of the hospital. A particular food contractor, using different names, has continued supplying diet for patients at the hospital for long 32 years while a selected group have been supplying medicines and surgical instruments for 20 years," Parvez Hossain, a leading member of Nilphamari blood bank, a voluntary organization, said at the programme.

In most cases, substandard diet and medicines are provided, he added.

Speakers alleged that the hospital storekeeper with the consent of his higher authorities receive expired saline and medicines from drug companies through bribery although there is a committee comprising doctors and administrative officials to check the supplied medicines. They warned of tougher programmes if the culprits

behind the use of expired saline and medicines and other irregularities are not brought to book.

Two to die, six get life term for murders

Two people were sentenced to death while six others got life term imprisonment for murders in three districts yesterday.

A Sunamganj court sentenced a man to death and three others to life term imprisonment for killing a rickshawvan puller, reports our Moulvibazar correspondent.

The death sentence awardee is Abdur Noor of Shimultola village in Tahirpur upazila while the lifers are Shahnur Mia, Idris Ali and Habibur Rahman of the area.

Judge Mohammad Abdullah Al Mamun of Additional District and Sessions Judge's Court also fined the lifers Tk 20,000 each. In default, they are to suffer another three months in prison.

According to the prosecution, there in 2014. was longstanding conflict between victim Tabirullah and his neighbor Abdur Noor over a piece of land. As a sequel to the conflict, Abdur upazila.

Noor along with his men attacked Tabirullah with sharp weapons, leaving him critically injured on April 21 in 2016. He later died on way to a hospital in Sylhet.

Later, a case was filed in this connection. 2014. examining witnesses and evidences, the judge found the four guilty and pronounced the verdict.

Meanwhile, three men were sentenced to life term imprisonment in a case for Mathbaria Police Station against some killing a journalist of Nabiganj upazila unidentified people.

A 19-year-old girl, who went missing around nine years ago, got reunited with her family on Saturday.

An emotional reunion with her parents took place at the conference room of the deputy commissioner's office in Noakhali.

Her foster parents, Didarul Alam and Sanwara Begum, husband and DC Tonmoy Das, among others, were present at the time.

The reunion has become possible because of a noble effort by Didarul and his wife Sanwara of Chattogram, who not only gave Shirin Akhter Selina shelter, but also brought her up with great care and arranged her marriage, said local journalists.

Selina is the daughter of fisherman Md Abul Kashem of Surjomukhi Ashka Bazar area in Noakhali's Hatia upazila.

Nine years ago, Selina went to Noakhali General Hospital with her ailing maternal grandmother and went missing from there.

When she started screaming, a fraud woman came to her and offered her to take to her residence. But she took Selina to Chattogram's Halishahar and sold her off to a resident of the area as a domestic help.

Selina was tortured in many ways at the residence. In 2013, she fled from the house and took shelter to an unknown woman named Swapna Begum in the same area.

After hearing the girl's sufferings, Swapna took her to the local police station. Police then requested her to give Selina shelter.

Few days later, Swapna's elder sister Sanwara Begum, 45, took the girl to her residence and started bringing her up with great care. In the meantime, Sanwara and her husband started searching for Selina's family in different ways.

The couple married Selina off to a man in June this year.

In August, the couple were able to communicate with her family through journalists Md Shafiqul Islam Khan and AKM Mostofa.

Selina finally got reunited with her family on Saturday.


Sadar upazila after she informed them of killing her husband early yesterday morning. Maleka Begum, 28, Mozibar Rahman from Khochabari

body from the couple's rented house in Barabalia Bagurapara village, police sent the body to Thakurgaon Sadar Hospital morgue for autopsy and arrested Maleka.

Maleka was Shariful's third wife and the couple's marriage had been troubled over his other marriages, police said, adding that his first wife died in 2008.

Shariful's father filed a case with the police station, accusing Maleka and four others.
