## Long way to go for ensuring people's right to information

Says chief info commissioner

Speakers at a discussion yesterday noted that right to information is required for maintaining continuity of development in the country, and there is no alternative to ensuring right to information to improve the quality of life. The comments came at a discussion arranged by the

Information Commission marking International Day for Universal Access to Information 2019 at the Jatiya Press Club. Speakers, including government officials and

mediapersons, agreed that implementation of the Right to Information Act is essential for ensuring transparency and accountability of the government. Presenting the keynote paper, Chief Information

Commissioner Martuza Ahmed said they are yet to ensure right to information for everyone in the country. "We still have a long way to go to ensure everyone's right to information... Public awareness should be raised with

the help of the mass media for promotion of the Right to Information Act," he said. Martuza noted that it is not possible for the Information

Commission alone to achieve the goal. "The commission is already implementing various programmes... The Right to Information Act has to be

implemented at all levels of the society," he added.

Jatiya Press Club President Saiful Alam said the incumbent government enacted the Right to Information Act to ensure free flow of information. "We, as media workers, always want that," he said.

#### SCC mayor files GD for death threat

A general diary was filed yesterday as Sylhet city Mayor Ariful Haque Choudhury received death threats over phone call in the morning.

Shahab Uddin Shihab, public relations officer of Sylhet City Corporation (SCC) filed the general diary with Kotwali Police Station in Sylhet, mentioning two phone numbers.

In the general diary, he stated that the mayor received two calls at around 10:05am. On the other side, there were male voices, who verbally abused and threatened the mayor.

The public relations officer said, "The mayor is now fearing for his safety. He asked the police to trace the phone numbers and

find the culprits." Selim Miah, officer-incharge of Kotwali Police Station, said, "The general diary has been recorded with the police station and we will be taking action regarding the matter".

# HC compensation order in limbo for 28 months

Victim families of a tragic 2003 launch accident in Meghna river are yet to get any compensation, nearly 28 months after the High Court directed

authorities concerned for doing so. An appeal against the HC verdict is pending with the Appellate Division of the Supreme Court in this regard, but there is no stay order on the HC judgement.

Launch MV Nasrin-1 capsized on July 8, 2003 at the confluence of Padma, Meghna and Dakatia rivers in Chandpur, leaving 110 people dead, about 200 missing and many others injured, according to a government

investigation report. The "unfit" triple-decker was on its way to Bhola from Dhaka with about 700 passengers. The launch owner

also died in the accident. On June 5, 2017, the HC upheld a lower court verdict that ordered Bangladesh Inland Water Transport Authority (BIWTA) and a launch owners' association to pay out Tk 17.11 crore in

compensation to victim families. The family of each deceased would

get Tk 10 lakh, and every injured victim compensation until the apex court would get Tk 1 lakh, the HC ruled.

Advocate ZI Khan Panna, a lawyer for Bangladesh Legal Aid and Services Trust (BLAST), which is a party in the case, told The Daily Star on Thursday that BITWA and launch owners' association have not given any compensation to victim families, as an appeal filed by them is pending with the SC's Appellate Division.

"We will fight for upholding the High Court verdict when the Appellate Division holds hearing on the appeal, although victim families have not communicated with us," he said. BITWA and the launch owners'

association jointly filed a leave-toappeal petition with the Appellate Division this year, seeking a stay on District Judge's Court in 2012. the HC verdict.

Following the launch accident, the deputy commissioner of Chandpur published a list of 400 people who were affected by the incident. Accordingly, the shipping and disaster trustee boards gave Tk 15,000 to Tk 20,000 to the deceased and injured person's families.

In 2004, on behalf of the victims, BLAST filed a case with the 3rd Joint District Judge's Court of Dhaka, claiming that the compensation was not adequate. More than Tk 28.93 crore was demanded in the case, where number of the deceased was mentioned as 171. The case was sent to the 7th Joint

## Bangladesh a shining example of communal harmony: info minister

Information Minister Dr Hasan Mahmud yesterday said Bangladesh has set an example in the world by establishing inter-community coherence across the country.

## More patients getting admitted outside Dhaka

Hospitals outside Dhaka saw more patients taking admission than the capital in the last 24 hours till 8am yesterday, as some 278 out of the 360 dengue patients were from outside Dhaka, according to Directorate General of Health Services (DGHS).

Meanwhile, yet another dengue patient died yesterday while undergoing treatment at Faridpur Medical College Hospital, taking the unofficial death toll to 158.

The victim was Sirazul Islam, 40, son of late Sheikh Falu of Narandia village under Saltah upazila in Faridpur. He was a fruit seller and lived at Shibchar upazila in Madaripur with his wife and son, reported Faridpur correspondent of this newspaper.

Kamoda Prosad Saha, superintendent of Faridpur Medical College Hospital (FMCH), said, "Sirazul was admitted to the hospital on September 24 with dengue fever. He died while undergoing treatment around 7am on Saturday".

Anamul Haque, civil surgeon of Faridpur, said a total of 2,795 dengue patients got admitted to different hospitals in Faridpur, including FMCH, between July 20 and September 28. Of them, 203 patients are taking treatment in different hospitals, and 10 patients had died, he said.

Meanwhile, since January, the Institute of Epidemiology, Disease Control and Research (IEDCR) received information about 231 dengue-related deaths. So far, it has reviewed 136 cases and confirmed 81 deaths.

#### Students demand punishment of teacher

Students of Jahangirnagar University yesterday formed a human chain on campus, demanding punishment of a teacher who allegedly sexually harassed a female student of government and politics department.

The demonstrators, under the banner of Bangladesh Sadharan Chhatra Adhikar Sangrakkhan Parishad, gathered in front of the university's Shaheed Minar around 2pm, looking to press home their demand.

At the programme, they demanded exemplary punishment of Sanwar Siraj, an assistant professor of the government and politics department.

Shakil-uz-Zaman, one of the protesters and the convener of the platform, said there are multiple accusations against Sanwar Siraj. "Such an immoral person cannot be a guide for students and the nation," he said.

Prof Jamal Uddin Runu of environmental sciences department said, "We feel ashamed for Sanwar's behaviour as a teacher."

## College student among two killed in road crashes

Two people were killed and two injured in road accidents during the last two days, according to reports from our correspondents.

In Dinajpur, a college girl was killed on the spot as a speeding bus hit her in Rangpur city yesterday. The deceased -- Ity Begum, 20, daughter of Dulal Hossain from Mirganj

area in Rangpur city -- was a student of Begum Rokeya Government College in Rangpur. She was crossing Dhaka-Rangpur road in Panchmile area while she was

on her way to the college, police quoted the family and witnesses as saying. Following the accident, locals seized the bus, said Anwar Hossain, inspector (investigation) of Tajhat Police Station.

In Faridpur, a man was killed when a motorbike carrying two people hit him in Baganbari area of Saltha upazila on Friday. The identity of the deceased could not be known immediately.

The two injured -- who were on the bike -- are Hasan Mia, 35, from Sihipur; and Md Rasel, 30, from Gorgardia in Saltha.

Of them, Hasan was undergoing treatment at Faridpur Medical College Hospital and Rasel was referred to Dhaka, as his condition deteriorated,

said SM Siddik Hossian, station officer of Saltha fire service.
