Battle of cousins heats up

With only a few days left for the byelection to Rangpur-3 constituency, aspirants are passing busy days in electioneering. The by-election is slated to be held on October 5.

The parliamentary seat fell vacant after Jatiya Party (JP) chairman and also opposition leader of the House HM Ershad died on July 14.

A total of six aspirants from different political parties are contesting the by-polls. Among them, three are actively campaigning. Of the candidates, two are

Ershad's family members -- his son and JP candidate Rahgir Al Mahi Saad Ershad and nephew Hossain Mokbul Shahriar Asif.

Asif, who is contesting as an independent candidate, had been expelled from the party for violating

Rita Rahman of BNP is also active in the race.

On Saturday and Sunday, the candidates were seen visiting different neighbourhoods in the constituency and trying to woo prospective voters.

Saad was seen campaigning in Mulatol, Sen Para and Lal Bagh areas. While speaking to locals, he promised to continue his father's development work in the area.

Though no JP leaders in Rangpur were seen with him, Saad said "everyone was working for

TROUBLE IN JP STRONGHOLD The constituency (Sadar upazila) is considered the stronghold of JP, the main opposition in parliament. Ershad won all Rahman. elections he took part in from military rule in 1990.

Ershad first got elected in 1991. He was also elected in 2008, 2014 and 2019. Besides, his brother GM Quader and widow Raushan Ershad she has been facing obstacles in us, instead of living in the capital," were also elected MPs in 2001 and 2009 by-elections respectively.

But Saad is rarely getting any support from grassroots leaders, according to party insiders, even though JP Chairman GM Quader has urged party leaders to work for whoever is the nominated candidate.

Early this month, Mostafizar Rahman Mostafa, mayor of Rangpur City Corporation and presidium member of JP, said local leaders will not campaign for Saad if he is nominated.

According to political analysts, both JP and AL are divided over the issue. Some of their party leaders are working for Saad, some for Asif while others have decided to remain silent.

Awami League had nominated its Rangpur district General Secretary Rezaul Karim Razu as its candidate for the by-election. But On September 16, the ruling party candidate quit the race, following directives of party high-ups and is now backing JP candidate Saad.

AL sources said Razu's decision had disheartened the local party men.

HINDU VOTES UNCERTAIN

Hindu community of Rangpur Sadar upazila has been demanding that the Election Commission defer the date of Rangpur-3 by-election, as the announced date of polls falls on the day of Maha Saptami.

The election is scheduled for October 5, while the five-day Durga Puja festivities begins October 4.

Bhowmik, vice Sushanta president of Hindu-Bouddha-Christian Oikya Parishad's Rangpur unit and joint general secretary of the city's Puja Udjapan Parishad, said Hindus will not get enough time to cast their votes as the bypolls coincides with Saptami.

Also, there will be a risk of chaos in the polls, he said. There are 70,000 Hindus in Rangpur Sadar upazila.

Durga Puja to be celebrated at 31,398 mandaps

The Hindu community's largest religious festival Durga Puja will be celebrated at some 31,398 puja mandaps across the country, said community leaders.

The number of Puja mandaps were raised by 483 from previous year, according to the statistics of Bangladesh Puja Udjapan Parishad.

Of these, the festival will be celebrated at 7,271 mandaps in Dhaka division, 4,456 mandaps in Chittagong, 2,546 in Sylhet, 4,936 in Khulna, 3,512 in Rajshahi, 5,304 in Rangpur, 1,741 in Barishal and 1,632 in Mymensingh, statistics said.

The parishad yesterday presented the data at a press conference at Dhakeshwari National Temple's conference room in the capital.

Reading out a written statement, the parishad's general secretary Nirmal Kumar Chattarjee said the rising number of mandaps clearly reflects the economic progress of the Hindu community as well as the whole nation.

Earlier on September 22, hundreds from the Hindu community of Rangpur Sadar upazila observed a daylong token hungerstrike, demanding deferment of the byelection.

The leaders also placed a 12-point demand, which included declaring three days of national holiday for Durga Puja, recovery of vested properties, legislation of conservation law, building model temples in each upazila and so on.



HC asks Aman to surrender in 6 weeks

The High Court yesterday directed BNP leader Amanullah Aman to surrender within six weeks before a lower court, in connection with a case filed over issuing death threat to Prime Minister Sheikh Hasina.

The court also asked law enforcers not to harass or arrest Aman, a vice chairman of BNP, by this time.

The HC bench of Justice Jahangir Hossain Selim and Justice Md Kamrul Hossain Mollah passed the order after hearing a petition filed by Aman, seeking anticipatory bail in the case.

Earlier in the day, Aman appeared before the HC bench for bail. Advocate Zainul

Abedin and Advocate Sagir Hossain Leon appeared for Aman while Deputy Attorney General Aminul Islam represented the government.

Earlier on August 6, the HC ordered four other

Public Service Act-2018 contradicts constitution: TIB

Transparency International Bangladesh has urged the government to not enact the Public Service Act-2018 as it contradicts the constitutional provision of "all citizens are equal before law".

Issuing a statement, TIB expressed deep concern as the government has taken decision to enact the law, which has a provision stating that government permission will be needed to arrest

government officials and employees accused in criminal cases or corruption cases before

a court accepts charge sheets against them. By including the discriminatory provisions, government's decision to enact the Public Service Act-2018 is contrary to the constitution, TIB Executive Director Dr

Iftekharuzzaman said. He said the prime minister's firm statement that ongoing anti-corruption drive will be continued, will be questionable if the law is enacted.
