## BU admission test begins on October 18

An average of 25 admission seekers will vie for one seat at Barishal University (BU), the 33rd public university in the country and only such university in the division.

The admission test will be held on October 18-19, informed Assistant Professor Rahat Hossain Faisal of computer science and engineering department and convener of the intake test (for 2019-2020 session) committee.

He said 36,685 candidates will sit for the admission test. A total of 1,440 seats are allocated for 24 subjects under six faculties divided into "Ka", "Kha" and "Ga" units.

Applications for the admission test were received from September 1-25 through SMS.

Distribution of admit cards started from October 1 through BU website: admission.eis.bu.ac.bd

fell sick on the way to France, and went missing in a forest in Slovakia.

Later on September 9, they learned from a Slovakian online news portal that the police recovered a body from the forest.

Farid's family members and relatives then contacted Slovakian Police and identified the body. They also visited Slovakia to complete all formalities.

After a long and arduous process, with help from foreign ministry of Bangladesh, the body was returned home.

Farid's brother Alauddin was at the airport to receive the body. He alleged that the agents intentionally killed Farid on the way and assured them that he was alive until they got confirmation of the death.

"We want the agents to be punished," he said. Farid will be buried in the graveyard of his home village today, his family members said.

"Assisted by a local ward councillor, we called him to our police station and sent him along with three other villagers to Rajshahi in a microbus," he said.

In January this year, Liza Rahman, an 18-year-old HSC student of Rajshahi Women's Government College secretly married Shakhawat Hossain, 19, an HSC student of Rajshahi City Government College.

Since learning of their marriage, Shakhawat's family members had been pressuring them to divorce each other. On Saturday, Shakhawat finally gave in to his parents' pressure and asked Liza for divorce.

Becoming upset, Liza went to the police, asking them to intervene to protect her marriage.

When the police denied her assistance, as claimed by the family members, she decided to set herself on fire near the police station. Locals and police took her to Rajshahi Medical College

Hospital. That afternoon, a police team took her to Dhaka Medical College Hospital, where Liza lost the battle for life on Wednesday morning.

The autopsy was performed at DMCH morgue and then her family members took her body to their village home in Boalia under Govindaganj in Gaibandha. She was buried at their family graveyard beside Boalia Mosque yesterday

A two-member committee headed by Rajshahi Metropolitan Police's Additional Commissioner Salma Begum is investigating into the incident.

A committee of National Human Rights Commission is also investigating into the incident. Al-Mahmud Faizul Kabir, a director of the commission, is heading the fourmember committee.

Tofazzal Sohel, general secretary of Bangladesh Poribesh Andolon, Habiganj unit said, some professional and seasonal bird hunters are active in the district. "Some dishonest and greedy people have been hunting migratory birds. The authorities are not conducting enough raids to stop this practice."

Narayan Saha, former head of the department of forestry and environmental science at Shahjalal University of Science and Technology said, "Birds help maintain the balance of the environment, and hunting them is a punishable offence."

"Widespread awareness is needed to stop this terrible practice of killing birds. Law enforcers have to be strict about punishing the poachers," said Saha.

### Growing use of e-cigarettes

Thirty countries including India, Sri Lanka, Nepal, Thailand and Singapore have already banned e-cigarettes, he said.

According to CDC reports released on September 27, 2019, as of September 24, 805 confirmed and probable cases of lung injury associated with e-cigarette use or vaping have been reported to CDC by 46 states and the US Virgin Islands.

Those cases included 12 deaths in 10 states. More than two-thirds of the patients are male. The median age of patients is 23, with about 62 percent of patients aged between 18 and 34, according to the report.

enforcers conducted raids at his office and residence in Gulshan and Banani for nearly 20 hours.

During the raid, law enforcers seized around Tk 29 lakh in cash, foreign currencies of 23 countries amounting to Tk 77.63 lakh, 32 cheque books of three banks, five electronic transaction cards, two pieces of spotted deer hide and 48 bottles of foreign liquor.

One network server, four laptops and a desktop computer used for the gambling operations were also seized during the raids.

Md Akhtaruzzaman, who was in-charge of the gambling site, and Md Roman were also arrested. Later on October 2, two cases -- one for possessing

liquor and another for laundering money -- were filed with Gulshan Police Station. Salim and two others were made accused in the drug case while Salim and seven others were accused in the money laundering case. In the money laundering case, three accused are Korean

nationals.

Meanwhile, Executive Magistrate Md Sarwoer Alam sentenced Salim, Akhtaruzzaman and Roman to six years' imprisonment for keeping spotted deer hide in their possession.

### ALCOHOL SOLD AT MOHAMMEDAN CLUB ON LOKMAN'S DIRECTIVE

Police yesterday told a Dhaka court that foreign liquor was sold to Mohammedan Sporting Club as per directive of its director in-charge M Lokman Hossain Bhuiyan.

Investigation officer of the case Sub-inspector Mohammad Kamrul Islam of Tejgaon Police Station, made the comment while producing Lokman before a Dhaka court yesterday with a five-day fresh remand prayer. After the hearing, the court placed Lokman on a two-

day remand in a case filed for possessing narcotics at his Monipuripara residence.

Lokman was earlier remanded for four days in two phases.

On Monday, an audio clip of a conversation between the pro-VC and wife of Nurul Huda surfaced on social media, where Prof Zakaria is heard talking about money for a job recruitment. In a written statement, Prof Zakaria

had acknowledged that he had the conversation, saying, "I made the call to verify information that the job seeker was involved with some people to get the job through illegal dealing. RU VC Prof Abdus Sobhan said a probe

committee would be formed immediately to look into the matter. Meanwhile, speaking at an international conference at the university's senate

building on Saturday, the VC said "Jai Hind", alongside "Joy Bangla" and "Joy Bangabandhu", which drew strong reaction on social media.

While talking to journalists, Prof Sobhan claimed that he did not make any remark against the country's independence. He said he only said those words expressing gratitude to Indian delegates at that conference. "I heard many people of top authorities shout such slogans before," he added.
