"As far as I know, such activities [ragging and torture cell] have been going on there even before the

existence of Chhatra League," the minister said.

Asked about another demand of banning student politics in Buet, she said the prime minister had already made it clear on Wednesday.

"Ragging and bullying are common in all over the world, but these do not go with the social values and education system of Bangladesh," the minister also said.

"We all will have to launch a social movement against it," she added.

Abrar, a second-year student of electrical and electronic engineering at Buet, was beaten to death by some Chhatra League men in the university's Sher-e-Bangla hall on Monday, sparking countrywide outrage.

Leave halls in 15 days

allowed to stay in the halls without the authority's permission, reads a press release of the university.

"Punitive measures will be taken if anyone breaches the rules," the press release said.

It also said that a committee of experts from DU and Bangladesh University of Engineering and Technology (Buet) has been formed to assess the feasibility of using bunk beds in rooms for multiple students, in case of an accommodation crisis.

THREE MORE ARRESTED

Yesterday, detectives arrested three Buet students, including Bangladesh Chhatra League leader Amit Saha, Abrar's roommate Mizanur Rahman Mizan, and Hossain Mohammad Toha in connection with the murder.

Amit was arrested at Dhaka's Sabujbagh around 11:00am, Mizan at Buet campus around 12:30pm, and Toha at Mawna of Gazipur around

Before Abrar was called out of his room allegedly by BCL men, Amit reportedly enquired about his whereabouts via text messages with

other students, said police sources. Amit, a student of 16th batch of Buet's civil engineering department, is the deputy law secretary of Buet BCL unit. Abrar was tortured in Amit's Sher-e-Bangla Hall room (room-

DMP Additional Commissioner Monirul Islam at the DMP media centre yesterday said Amit was arrested following information gleaned from other arrestees.

So far, police arrested 16 suspects including four who were not named in the first information report.

"Arrest of so many suspects in quick succession was possible due to Abrar murder case would be pressed the sincerity of police," Monirul said,

adding that 10 were arrested even before the case was filed.

He said many of the accused were willing to confess and police were scrutinising their statements.

Asked why police did not contact the Hall administration knowing there was an injured person inside, Monirul said, "Police had no information about anyone ill or grievously injured

'REMOVE VC'

Buet Teachers' Association yesterday reiterated its demand for the removal of the university's Vice-Chancellor Prof Saiful Islam for his "failure to ensure safety of students on campus".

It urged the government to force the VC to resign if he did not do so willingly.

Association President Prof AKM Masum said, "The VC's continuous careless attitude towards students' torture and his failure to ensure their safety encouraged the killers to murder Abrar."

He was talking to reporters in front of the Central Shaheed Minar after placing their seven-point demand, which included a ban on party-based politics on Buet campus.

Speaking to journalists on Wednesday, the association had voiced the same demands.

"The trial will be completed and justice will be served," he said while speaking at an inauguration programme for a building of the Chief udicial Magistrate Court in Noakhali.

The minister said the government has taken measures for completing the investigation fast.

NHRC MONITORING

National Human The Commission yesterday sought speedy trial of Abrar murder and demanded exemplary punishment of the killers.

"We deeply condemn the barbaric murder of Abrar Fahad and we have been closely observing the government's actions taken in this regard," a NHRC press release quoted its chief Nasima Begum as saying.

The commission members also observed a minute of silence in remembrance of Abrar.

Risha's killer

Before committing the offence, he bought a knife from Hatirpool Bazar and he used it to stab the victim.

Three people, including a student of the same school, saw Obaidul stabbing Risha and fleeing the scene. They tried to catch him but could not, says the judgment.

Risha lost her battle for life at the ICU of Dhaka Medical College Hospital four days after she was attacked.

Her mother Tania Hossain filed a case against Obaidul with Ramna Police Station under the Women and Children Repression Prevention Act.

The death of Risha, eldest child of Ramzan Hossain and Tania Hossain, sparked protests across the capital. Students of the institution held rallies blocking the road and demanded

Obaidul was arrested in Nilphamari with the help of locals a week after incident. Obaidul, of Dinajpur's Miradangi village, used to work at a tailor's shop on Elephant Road.

On September 5, 2016, he gave his confessional

statement before a magistrate. He said he stabbed the girl with an intention to kill her. As she refused his love, he planned to kill her.

On November 14 that year, Ali Hossain, inspector of Ramna Police Station, submitted the charge sheet against Obaidul.

The court framed the charge against the accused on April 17, 2017.

Additional Public Prosecutor Tapash Kumar Pal appeared for the state while Faruque Ahmed defended the accused.

Activists of the ruling party's student wing would then abuse, torture and even kill their rivals without ever having to face trial or sentence.

From 1991 to 2006, we saw power alternating between the BNP and the AL with the control of the university dormitories alternating between their student wings. Since Awami League has been ruling for the last 10 years and has retained power for a third term, its student front's control over public universities has become "quasipermanent" with the concomitant changes in their behaviour, lifestyle and attitude towards fellow students.

Most of the top Chhatra League leaders own flats, cars and businesses with signs of opulence literally oozing out from their every move including dishing out favours and cash to their sycophants. As and when they visit the campus, riders on motorbikes clear the road in advance so their leaders' journey is not hindered by the commoners.

According to Buet students, Chhatra League leaders would regularly beat up or "punish" students for not showing due "respect" to them by standing up when they passed or greeting them with proper salutation.

Beatings were inevitable if any student -- especially the newly admitted ones -- did not join any Chhatra League rally or event. One or two slaps was the "kindest" of treatment. They ran a virtual fiefdom right in front of the university administration and the latter did not have the courage to impose the minimum of institutional discipline.

And then the VC has the gall to say "why should I resign? I have done nothing wrong". He has failed to provide the basic security to his students and protect them, as is now revealed, from regular abuse and even death. Obviously, this learned teacher has not heard of "moral responsibility" or "ethical role" of any head of an educational institution. If we care to read, there is so much

'written" in Abrar's murder -- the sheer cruelty, the depth of depravity, the gruesomeness of the act, the extent of lawlessness, the sense of being above the law, the world of criminality in which the perpetrators lived and

and death of anybody they laid their The cruelty of the act was

mindboggling to say the least. I read and reread the autopsy report which said the "death was caused by internal bleeding and excessive pain." It was the last two words, "excessive pain", that have been haunting me from the moment I read them. I pictured Abrar screaming in absolute pain. Did nobody hear him? Inside the university? Impossible. It appears that some did at the beginning and was dissuaded from entering the room. After that Abrar was gagged so that his screams were muffled and nearly inaudible. Even then many must have heard but nobody dared to intervene fearing a similar fate for themselves. Such was the killers' writ spread over the most prestigious educational

institution in the country. We can picture in our mind's eye Abrar pleading with his tormentors to stop the incessant beating and give him a moment to breathe. When he could not bear the pain any longer, he must have begged for mercy and for his life. But all his cries, pleading and begging went in vain. And in response, his killers commented "... he is pretending. We can beat him for another two hours.

Sub-Inspector Delwar Hossain visited the hall but was kept waiting for 45 minutes and not allowed to come to Abrar's aid which could have saved his life.

Delwar spoke to his boss who also did not instruct him to force his way into the room where Abrar's killing was taking place. Would the police have listened to anyone else but the BCL general secretary? This illustrates how "law takes its own course" and speaks of the power of the killers and the powerlessness of police. It could happen only because police knew well that to move against Chhatra League needed clearance.

Of them, Anik Sarkar is said to have struck Abrar 200 times with a cricket stump till it broke. For these Chhatra Leaguers beating Abrar mercilessly seemed like a "festivity" of which they all had to have a share. As the beating continued, some went out for a while and returned to resume. It is relevant to remember that the bleeding was not in the brain in which case death would have occurred sooner. The bleeding was internal, which took time to make the vital organs fail.

Two sets of questions must immediately be addressed -- one dealing with the wider social and political atmosphere and the other internal to the universities themselves.

We must ask what has happened to our glorious tradition of student movements that lay at the heart of all our democratic struggles? We knew that military dictatorship perverted our students, but why should such aberration occur under civilian rule?

What sort of political environment turns high-performing students into butchers? How long are we going to allow the "culture of impunity" to destroy the fundamental institutions of governance? How long will we allow our basic social and human values to be torn to shreds?

Internal to the universities, the questions we must ask is what sort of educational institutions have we created that bring out the worst in our young instead of the best? What education can these institutions provide when basic humanity is lost?

What has happened to the conscience of our teachers who do nothing and do not have the minimum guts to raise their voice even after seeing such brutalities and perversities every day? What can be expected from such givers of "knowledge, wisdom and ethics" when all they can think of is their jobs, promotions, foreign scholarships and possible lucrative consultancies? (The burden of collective shame must haunt all teachers). What can we expect from university administrations that are not willing to guarantee the minimum academic atmosphere for students to study and excel?

As we had said earlier, Abrar's life was taken away by a few "demons"

masquerading as students, but he was actually killed by the system -- a system of impunity, lack of accountability, corruption, abuse of power and flouting of the law.

S Korea may acquire nuclear submarines after North's test

South Korea's Navy is considering acquiring nuclear-powered submarines, it said yesterday in a surprise announcement which would change the balance of power in northeast Asia and is likely to upset several

of its neighbours. Seoul is surrounded by three nuclear powers -- China, Russia, and North Korea, which invaded its neighbour in 1950 -- while it and neighbour Japan, both of them US allies but with difficult relations between them, rely on Washington's

nuclear umbrella. Pyongyang last week tested what it said was a submarine-launched ballistic missile, although the US said it seemed to have been fired from a

'sea-based platform". A proven submarine-based missile capability would take the North's arsenal to a new level, allowing deployment far beyond the Korean peninsula and a second-strike capability in the event of an attack on its military bases.

In a report submitted to parliament the South Korean Navy said it had set up a task force headed by a commander-level official to examine procuring nuclear-powered submarines in the long term, the South's Yonhap news agency reported.
