Migrant workers in Greece face abuses

Around 12,000 Bangladeshis working in the strawberry farms in Greece are facing various forms of labour abuses, including low wages, long working hours and sub-standard living conditions with little amenities.

The employers, who earn huge profits out of the cheap migrant labour, also threat them of deportation as they are undocumented in Greece, the country which the workers consider a transit point to other European countries.

"We earn huge profits for farmers who treat us worse than animals. We want people to learn how we live a rough life in Barangas [small shanties built for workers]," a group of 25 Bangladeshi farm workers in Nea Manolada, a village of southwestern Greece, said in a statement.

Reena Kukreja, assistant Professor of Global Development Studies at the Queen's University in Ontario, wrote an article based on her research on the migrant workers. It was published in The Conversation, an Australia-based news magazine,

yesterday. "Look how they live in comfort --

all due to our hard work. What do we get in return? Discarded plastic sheets as our roof," a Bangladeshi migrant in his early 20s told the researcher when she visited them in last summer in Nea Manolada.

"Strawberry farmers give the migrants long work hours, high targeted outputs and depressed wages. The conditions of work can be described as forced or unfree labour. Withholding of wages is a common practice here and tie the workers to the farmers," writes Kukreja.

In 2013, protests by Bangladeshi workers against delayed wages led to Greek farmers shooting at them. Later, the workers won a landmark human rights case, and Greece was forced to pay more than US\$648,000 to 42 of them.

According to the article, each growing season of strawberry, from October to May, as many as 12,000 undocumented Bangladeshi migrants work in the farms in Greece, the 10th biggest exporter of strawberries in the world.

The workers are forced to rent unused farmland and build highly inflammable makeshift shacks called SEE PAGE 10 COL 5

Sinking into the depths of despair

Rickshaw-van puller father devastated as his Buet student son held in Abrar murder case

In a remote village of Joypurhat, Atiqul Islam drives a rickshaw van to make ends meet. A father of three, it was always difficult for him and his wife Nazma Begum to get by on the meagre income. But the family was close to a dream come true.

Their eldest son, a student of the Bangladesh University and Engineering and Technology (Buet), would soon take on the family responsibility.

"We practically starved for days on end just to make sure that our son gets a good education," said the middleaged rickshaw-puller.

He had thought his days of hardship would be over soon. "My son would graduate in two years and get a job and then look after the family," he said.

"I could never spend a penny for private tuition, and yet my son managed to ace all his exams and get into Buet. He really made me proud. I could stand with my head held high anywhere."

Atiqul's dream has fallen apart. His son Akash Hossain is among those arrested for murdering Abrar Fahad, a second-year student of Buet.

The poor man said it feels like the sky has crashed down upon him. "I had thought my son would take the burden off my tired, old shoulders. But now it seems I have to take even more burden for him."

With anguish, he said that if the charges are proven, his son must be punished. "And I will tell myself that

in his upbringing."

His wife Nazma Begum said, "That other kid who was killed, was my son too. The only thing I ask is that such a brutal incident does not happen again."

Akash on Sunday evening. But in the early morning of Tuesday, Akash's grandfather called her and told that violence broke out at Buet.

Nazma phoned her son and queried about his involvement. "My son said he was not involved with the incident and that he is innocent."

Yesterday's meeting started at Buet auditorium around 5:30pm. At the beginning, VC Prof Saiful, deans of different faculties and the students observed a minute of silence in Abrar's memory.

Shortly after that, Prof Saiful started reading out the 10-point demand raised by the agitating students. On banning organisation-based

politics on the campus, he said, "I, with the authority vested in me, announce that all political organisations and their activities are now banned at Buet." On the demand for the maximum

punishment for Abrar's killers, he said he already discussed the matter with government high-ups and that they promised all sorts of assistance in this regard. About the demand for expelling

all the murder accused from the university, the VC said they expelled students on many occasions in the past, but the students returned to classes with stay orders from court.

"Based on that experience, we have formed a committee to investigate Abrar murder. We've suspended the 19 accused and will take further action based on the probe report. The committee will submit its report within 10 days," he said.

Reading out the demand for providing compensations to Abrar's family and helping it run the

On stopping ragging on the campus, he said a website would be launched for making complaints. The university's Directorate of Students' Welfare (DSW) would directly receive the complaints, he said.

He assured that ragging would stop at Buet.

The VC then said the university authorities would soon install CCTV cameras on both sides of the wings of the dormitories. Speaking on the other demands,

Prof Saiful said they would write to the government so that the trial of the Abrar murder case is held at a speedy trial tribunal. About the allegation of his failure

questions to the VC, the deans and DSW Director Mizanur Rahman about implementation of all the demands.

FIFTH DAY OF DEMO

They chanted slogans calling for the maximum punishment for the more accused -- Majedul Islam, 21, a

Talking to reporters around 11:00am, one of the protesters said, "We've not seen any visible steps in engineering -- in Sylhet and Satkhira. implementing our demands."

The agitating students also drew graffiti and performed a street play depicting Abrar murder.

He said they will not foil Monday's exams if the authorities meet the demands immediately.

"We made the decision at the request of the vice chancellor and the examinees," he said.

The five demands include issuance of notices on expulsion of all the charge-sheeted accused, compensation to Abrar's family, eviction of outsiders from halls and sealing of offices of all political organisations at the dormitories.

ARRESTEE CONFESSES; TWO MORE HELD

At one stage, Anik went out of the room. He returned there within 20 minutes, and again beat up Abrar indiscriminately.

Zion then slapped Abrar and hit him with a stump in his knee.

After recording the confessional statement of Zion, Metropolitan Magistrate Sarafuzzaman Ansary ordered the authorities to send him to Dhaka Central Jail in Keraniganj.

Abrar's father filed the murder case against 19 Buet students and several other unnamed ones with Chalkbazar Police Station on October 7. TWO MORE ARRESTED

Meanwhile, detectives yesterday arrested accused Majedul Islam from Sylhet and Shamem Billah from Bhomra land port in Satkhira.

With them, 18 students, including 14 FIR-named accused, have so far been arrested in connection with the murder.

Majedul is a student of materials and metallurgical engineering and Shamem Billah of naval architecture and marine engineering.

Besides, two other accused Amit Saha and Hossain Mohammad Toha were placed on five-day remand each

by a Dhaka court yesterday.

Amit is a student civil engineering and also the deputy law secretary of Buet Chhatra League, and Toha is a student of mechanical engineering.

Shakal, a student of biomedical engineering, in his confessional statement said he took part in the beating.

He told the court that Abrar was taken to room-2011 of Sher-e-Bangla Hall sometimes after 8:00pm on October 6. His two mobile phones and a laptop were also taken there. Buet BCL deputy office secretary Mustaba Rafid and mechanical engineering student Khandakar Tabakharul Islam Tanvir checked the mobile phones.

Muntasir al Jemmy of the same department checked the laptop.

In his statement, Shakal also said when they were checking Abrar's devices (mobile and laptop), Mehadi Hasan Robein and Zion came to the room. Robein asked them to press Abrar to know the names of those involved with Shibir at Buet. At that time, Robein slapped Abrar several times.

He told the court that there was no cricket stump in the room where Abrar was beaten up. Someone brought

stumps from outside.

Shamsul Arefin alias Rafath, a second-year student of mechanical engineering department, gave him a stump and he hit Abrar four to five times with it. The stump broke.

At one stage, Robein contacted Buet BCL General Secretary Mehedi Hasan Rasel over the phone.

Shakal also told the court that he went to the canteen to have dinner around 10:30pm. He found Abrar was very sick and lying on the floor when he returned to the room around 20 minutes later.

He scolded Abrar and forced him to stand up and slapped him several times. Then Muzahidur, a third-year student of electrical and electronics engineering department, started whipping him with a skipping rope. Shakal again hit Abrar in his legs and knees with a cricket stump. At that time, Tabakharul slapped him.

Around 11:00pm, Anik again entered the room and hit Abrar around 100 times with stumps. Everybody in the room was frightened seeing the way Anik beat him up. Anik left the room around midnight.

As Abrar complained of breathing problem, Shakal put a pillow under

his head. Minutes later, Abrar started vomiting. As Shakal informed Anik of the matter over the phone, Anik told him to give Abrar a bath and rub ointment in the wounds. Abrar vomited again. Then Robein said he

was "feigning". Abrar was then taken to room 2005. Amit sent a text to continue torturing Abrar to get information.

Knowing about Abrar's bad condition, Amit asked them to drive him away from the hall. After that, Robein and Anik came to the room. Seeing Abrar, they said he was all right and left the room.

Shakal said as Abrar vomited again, Robein asked them to bring him downstairs to hand him over to police. Some students tried to take him to the ground floor. As they failed, he was carried to the staircases between the second and the ground floors.

Then Abrar said he was feeling very

Rasel talked to policemen at the hall gate.

Ismail and Monir called for an ambulance. As the ambulance was late, Tamim brought in the doctor of Buet medical centre on a motorcycle. The physician checked Abrar's pulse and declared him dead, said Shakal.

US aviation authority blasted over The surprising. Awami League to impunity. redesign of 737 MAX aircraft Demand for change

US aviation regulators were yesterday slammed for allowing design changes to Boeing's 737 MAX aircraft that have been implicated in two crashes causing the deaths of more than 300 people. The Federal Aviation Administration failed

to stick to its own rules, followed out-of-date procedures and lacked the manpower and expertise to properly oversee the alterations, a panel of worldwide experts found. The Joint Authorities Technical Review (JATR)

was put together in March after a 737 MAX run by Ethipoian Airlines crashed killing all 157 onboard.

and a step-up in oversight of Boeing from the FAA and international regulators.

But the FAA came in for harsh criticism from the JATR, which said there was "an inadequate number of FAA specialists" in place to oversee a new design of the 737 MAX and they "had inadequate awareness" of the system implicated in the crashes.

It said officials oversaw design changes "in a way that failed to achieve the full safety benefit."

Their damning 69-page report also found that Boeing had put pressure on some of its staff who

had FAA authority to pass the updated designs. The JATR panel included members of the FAA as

well as Nasa and other regulators from around the In response to the report, FAA Administrator

Steven Dickson said: "Today's unprecedented US safety record was built on the willingness of aviation professionals to embrace hard lessons and to seek continuous improvement.

"We welcome this scrutiny and are confident that our openness to these efforts will further bolster aviation safety worldwide. The accidents in Indonesia and Ethiopia are a somber reminder that the FAA and our international regulatory partners

must strive to constantly strengthen aviation safety."
