### Man held, looted cash recovered

Police arrested a youth yesterday in connection with the case for killing a pregnant woman and her four-year-old

daughter in the town early Sunday. The arrestee, Raiz Uddin, 36, is a resident of Bhallukkandi area under ward No 9 in Tangail municipality.

Police recovered throat-slit bodies of Lucky Begum, 22, wife of Al Amin, and their daughter Alifa from her house early Sunday. Al Amin, a mobile recharge shop owner in Bhallukkandi area, said he found the two dead bodies at the yard after returning home from his shop Sunday late night.

Slain Lucky's father Hasmot Ali of Ramnagar village filed a case with Tangail Model Police Station accusing some unidentified criminals the same day.

Tangail Superintendent of Police Sanjit Kumar Roy at a press briefing yesterday said they detained Raiz, suspecting his involvement in the murder.

During interrogation, Raiz admitted that he committed the murders for looting money from the house.

Later, following his confession, police recovered Tk 8 lakh looted money and a knife used in the killing.

# 20 fishermen jailed in 2 dists

Six injured in clash between fishers, cops in Chandpur

Mobile courts in Manikganj and Barishal districts jailed 20 fishermen for different terms for violating the ongoing temporary ban on hilsa fishing while six people were injured and 17 fishermen detained during a clash in Chandpur, reports our correspondent. In Chandpur, at least six people, including three

policemen, were injured during a clash between a group of fishermen and members of river police yesterday when the latter conducted a drive against illegal fishing in Rajrajeshwar area in Sadar upazila during the ongoing ban. The law enforcers fired four rubber bullets to bring the situation under control.

After the incident police detained 17 fishermen from the spot and seized 50,000 metres of current nets and 21 kg hilsa from there.

All the injured are now undergoing treatment at Chandpur General Hospital.

Our Manikganj correspondent reported that a mobile court in Shivalaya upazila yesterday detained 15 fishermen from the Padma and Jamuna rivers and sentenced them to one year imprisonment for netting hilsa defying the 22-day ongoing ban.

Upazila Fisheries Officer Atiar Rahman said the court, led by Shivalaya Upazila Nirbahi Officer (UNO) AFM Firoz Mahmud, conducted separate drives in the two rivers from 12:00am and arrested 15 fishermen from deferent points of the rivers.

In Barishal, law enforcers conducted a drive in the Kirtankhola river in Sadar upazila yesterday and detained 11 fishermen for defying the ongoing ban on hilsa catching.

Sadar UNO and Executive Magistrate Mosharraf Hossain said of them, five fishermen were sentenced to three months imprisonment while six others fined Tk 5,000 each.

During the drive, they also seized 6,000 metres of fishing nets and 54 kg hilsa, he said, adding that the seized fishes were later distributed among different madrasas of the city.

# Villagers suffer as road condition awful

The four-kilometre-long LGED road in Rajbari developed numerous potholes due to lack of repair

Thousands of people of Rajbari Sadar and Kalukhali upazilas are badly suffering as the four-kilometre road from Gandimara intersection to Old Belgachhi Bazar has become almost unfit for vehicular movement due to lack of repair for long.

Rajbari Sadar Local Government Engineering Department (LGED) officials said 2.6-kilometre of the road is under Rajbari Sadar LGED and 1.4-kilometre under Kalukhali LGED.

During a recent visit, this correspondent saw a number of potholes in the road, which has become muddy in many places.

"Thousands of people from different villages of the two upazilas use the road regularly as there is a railway station at Old Belgachhi Bazar and two colleges, four high schools, a madrasa and five government primary schools are situated near the road. They suffer a lot due to the dilapidated condition

of the road," said Rajkumar Shil of Belgachhi village.

"Our sufferings know no bound when a critical patient has to be taken to a hospital in the district town," said a local.

Russel Rana, a college student of Basudevpur village, said, "We have to pay extra fare while commuting on the potholed road."

Abdul Karim Mondal, a three-wheeler driver said plying of sand-laden trucks for years caused serious damage to the road.

Accidents often occur and a good number of vehicle owners have stopped operation on the road to avoid damage to the vehicles, he said.

Atahar Hossain, chairman of Khanganj Union Parishad, said he urged the LGED officials to repair the road but no steps have taken yet.

Contacted, Rajbari Sadar Upazila LGED Engineer Khan A Shamim said, "Tender has been called for repairing the road. We hope the work will start soon."
