Ecuador counts cost of deadly protests after deal

AFP, Quito

Ecuador began counting the cost Monday of 12 days of indigenous protests against fuel hikes that left eight demonstrators dead and severely dented President Lenin Moreno's austerity program.

Moreno and indigenous leaders reached an agreement Sunday after the president pledged to withdraw subsidy cuts, known as Decree 883, that had more than doubled fuel prices.

The cuts were part of an austerity package to obtain a \$4.2 billion loan from the International Monetary Fund to shore up the oil exporter's brittle economy.

Moreno wrote on Twitter that the original plan would be replaced by new measures that "contain mechanisms to focus resources on those who need them most."

"These days should teach us to value peace, stability, security," Moreno said in a televised statement on Monday evening.

Under the deal, indigenous umbrella group CONAIE called off protests that brought chaos to the capital and forced Moreno to relocate his government hundreds of miles (kilometers) away to the second city Quayaquil.

Thousands of indigenous people began leaving Quito on Monday in convoys of trucks, returning to communities in the Andes and the Amazon rainforest that they left more than a week ago to vent their outrage at the increases.

The ombudsman's office reported

that 1,340 people had been injured in the protests, some of whom were in critical condition, while 1,192 people had been detained. The protests caused an estimated

\$1.5 billion in losses, according to head of the Ecuadorian Business Committee Patricio Alarcon.

Sunday's breakthrough after four hours of talks was announced by an official from the United Nations, which mediated negotiations along with the Catholic Church.

S Africa's Zuma files last-minute appeal

South Africa's embattled former president Jacob Zuma will appeal a court ruling that he stand trial on corruption charges, his lawyer said yesterday, in a last-minute move delaying a case over bribery allegations dating back to a 1990s arms deal.

The trial would have been the first time Zuma faced a court on graft charges, despite a string of accusations over his long political career.

The High Court in the southeastern city of Pietermaritzburg last week rejected his request to have charges of fraud, graft and racketeering dismissed, clearing the way for the trial to start yesterday.

But Zuma's lawyer Thabani Masuku told the court at the start of the trial that the ex-president would appeal, dragging on a case that has seen

numerous legal twists over 15 years. "Mr Zuma would like to exercise the full extent of his constitutional rights, which includes the right to appeal," Masuku said.

The other four are Abdul Jabbar Mondal, 89, his two sons Jachijar Rahman alias Khoka, 67, and Abdul Wahed Mondal, 65, and Montaz Alia Bepari alias Momtaz, 71.

All of them are from Gaibandha Sadar upazila and were involved with Jamaat-e-Islami, an antiliberation party, during the war, according to the case documents.

The three-member tribunal, led by its Chairman Justice Md Shahinur Islam and members Justice Amir Hossain and Justice Md Abu Ahmed Jamadar, asked the Inspector General of Police to take effective, prompt and appropriate measures to arrest the fugitives.

According to the case documents, Jabbar, a village quack, was an active member of Jamaat in 1971 and was involved in forming local Peace the Committee and Razakar Bahini. He was the commander of his union's Razakar Bahini.

Other convicts were also active members of Jamaat and Razakar Bahini and committed crimes during the Liberation War, according to the prosecution.

"Mode of their participation in perpetrating the crimes was indeed full of deliberate aggression," the tribunal said while delivering the 167-page verdict.

"Taking all these factors into

account we are of the view that the caught, tortured several people, wheels of justice must move not only to halt the culture of impunity but also for healing the immense union to leave the country. trauma and untold wound the victims and sufferers sustained."

Prosecutor Mukhlesur Rahman Badal expressed satisfaction over the judgment, saying that the victims' families got solace after a long time.

However, state-appointed defence counsel Abul Hasan said he would advise his client to file an appeal with the Supreme Court.

According to the International Crimes (Tribunals) Act, 1973, a war crimes convict can file an appeal with the SC within 30 days from the date of verdict delivery. With the latest judgement, the

war crimes tribunals have so far people. Of them, 68 have been sentenced to death.

According to the third charge, the four convicts with their fellow Razakars and army men carried out an attack in Daulatpur and killed five on the same day. They were given the death penalty for this too.

The five convicts on the same day launched a systematic attack in delivered 40 verdicts against 94 Nandina and Daulatpur and caught non-combatant freedom fighter Abul Kashem from Nandina and tortured him by hanging him with The tribunal found all the five a tree. He was forced to drink urine. Later, he was shot dead, according

to the fourth charge. Besides, they killed six other non-combatant freedom fighters, added the charge.

They were handed the death penalty for this. However, death sentences would naturally be merged, the tribunal said.
