# Govt waterbody recovered from illegal occupier

Former president of Nagda Shimla union unit AL occupied a portion of Kaicha Beel and cultivated fish

Gopalpur upazila administration on Monday recovered a government owned waterbody from illegal occupation by a local Awami League (AL) leader.

Abul Hossain, former president of Nagda Shimla union unit of AL, occupied a six-acre area of Kaicha Beel, a waterbody in Jagannathbari Mouja of Gopalpur, several years ago and continued fish cultivation there, upazila administration sources said.

To take control of the waterbody, the upazila administration demarcated it with red flags six months ago, they said.

Officials also directed Abul Hossain to catch and take away all his fish from the waterbody by one month and not to cultivate fish there further but the latter ignored the directive.

Following instructions from the district administration, Gopalpur Upazila Nirbahi Officer (UNO) Bikash Biswas and Assistant Commissioner (Land) Reza Masum

Prodhan along with a police team went to the spot on Monday.

They arranged netting the fish of the waterbody by local fishermen and brought the fish to the local union parishad (UP) premises by a truck.

They handed over the fish to the authorities of all the 19 orphanages in the upazila and suggested arranging feast for the orphans with the fish, officials said.

Besides upazila officials, M Hossain Ali, chairman of Nagda Shimla UP, Zoynal Abedin, president of Gopalpur Press Club, were present during the fish distribution.

Bulbul Miah, a resident of Mazidpur Orphanage, said they got about 60 kg of different fish including carps and pangas.

UNO Bikash Biswas said, "We have taken control of the government owned waterbody that remained under illegal occupation for years. The netted fish was distributed among the local orphans following rules."

## FERRY SERVICE DISRUPTION 200 vehicles stranded on both sides of Padma

More than 200 vehicles especially goods-laden trucks remained stranded for the third consecutive day yesterday at Shimulia-Kathalbari terminals due to severe disruption in ferry services caused by poor navigability in a stretch of the Padma.

Officials of Bangladesh Inland Water Transport Corporation (BIWTC) said the situation would not get any better before Friday.

The authority suspended ferry services in the terminals from 2:00pm on Sunday as silt deposited in the ferry channels and dropped the water level causing the poor navigability.

Abdul Alim, manager of Shimulia Ghat, said the water was only five feet deep in the channels while it must be at least seven feet deep for proper ferry operation.

He said though the operation was suspended on Sunday, the disruption had been going on since August.

The authority had been trying to dredge the channels to increase water level but struggling due to strong current, he added.

Officials of Bangladesh Inland Water Transport Authority (BIWTA) informed that all 17 ferries, operate normally on Shimulia-Kathalbari route, were anchored on the banks. They arranged three small ferries to carry ambulances for emergency situations.

Meanwhile, several hundred good-laden vehicles remained stuck for days in the terminals.

Traffic Inspector Md Helal Uddin of Shimulia Ghat traffic police said at least 200 trucks were waiting to cross the river since last week.

Drivers and helpers of these vehicles were passing days in misery as there was no hotel and shop near the terminals as illegal shops were recently evicted from the spot, locals said.

Sabuj Miah, a truck driver at Shimulia Ghat, said he was heading Jessore but got stranded as ferry operation stopped.

"I have been sleeping in the truck for last three days with nothing to eat. I don't know how would I survive till Friday," said Sabuj.

A driver of Hamim Paribahan Anu Mollah said he came with passengers from Dhaka. As they got stuck in the terminal, all the passengers got down from the vehicle and left.

## Woman found dead

Unidentified criminals stabbed a housewife to death at her house in Sadar upazila yesterday.

The deceased, Jhorna Mondal, 42, wife of Dulal Mondal of Pashchim Gangabardi village, was mother two children.

Locals said the incident occurred yesterday afternoon when Dulal, a mason, and his children were not present at home.

Villagers, spotted Jhorna's body around 2:30pm and informed the police, who recovered the body and sent it to Faridpur Medical College Hospital for autopsy.

Sub Inspector (SI) of Sadar Police Station Belal Hossain said victim's body bore several marks of stab injuries on the head, neck and back.

They were trying to find the motive behind the murder and arrest the killers, the SI said.

# Legal tangles hamper academic, administrative activities

21 teachers, staffers of the institution are not getting salaries for last 5 months

A bitter strife that ended up in court for the position of acting superintendent of a vocational school in Nilphamari's Domar upazila is hampering the academic and administrative activities of the institution.

Twenty-one teachers and staffs of Motukpur Vocational High School, listed under the Monthly Pay Order (MPO) system, are not getting paid and students complained of irregular classes.

Mesbahul Miskat, who will appear at the Secondary School Certificate (SSC) examination next year, said, "Classes of our school with 270 students seldom are held."

Another 10th grader Sathi Akhter alleged that the school often goes into recess after the tiffin-break.

Shahidul Islam, one of the 15 teachers of the school not receiving their salaries, said, "It has become very difficult to run our families. We have been living on loans and buying essentials on credit."

He explained that the acting superintendent of their school along with the chairman of the school managing committee (SMC) sign the bill sheet that confirms the salary of staffs and teachers.

"In April and May, we did not get the salary as the SMC chairman refused to sign the bill sheet because of some teachers' attendance issue. Then, from June onwards because of the indecision surrounding the acting super's post, the bill sheets did not get signed," he said.

Hence, upazila accounts department have withheld the salaries of teachers and staffs, he added.

Mentionable, established in 2000, Motukpur Vocational High School, did not have a permanent superintendent since 2003.

Assistant teacher of the school Sadikul Islam alleged that the school managing committee never wanted to appoint permanent supers as the committee's power would decline.

In 2003, Erfanul Islam, 47, was appointed as acting superintendent by the then committee and on December 30, 2015, he resigned from the post.

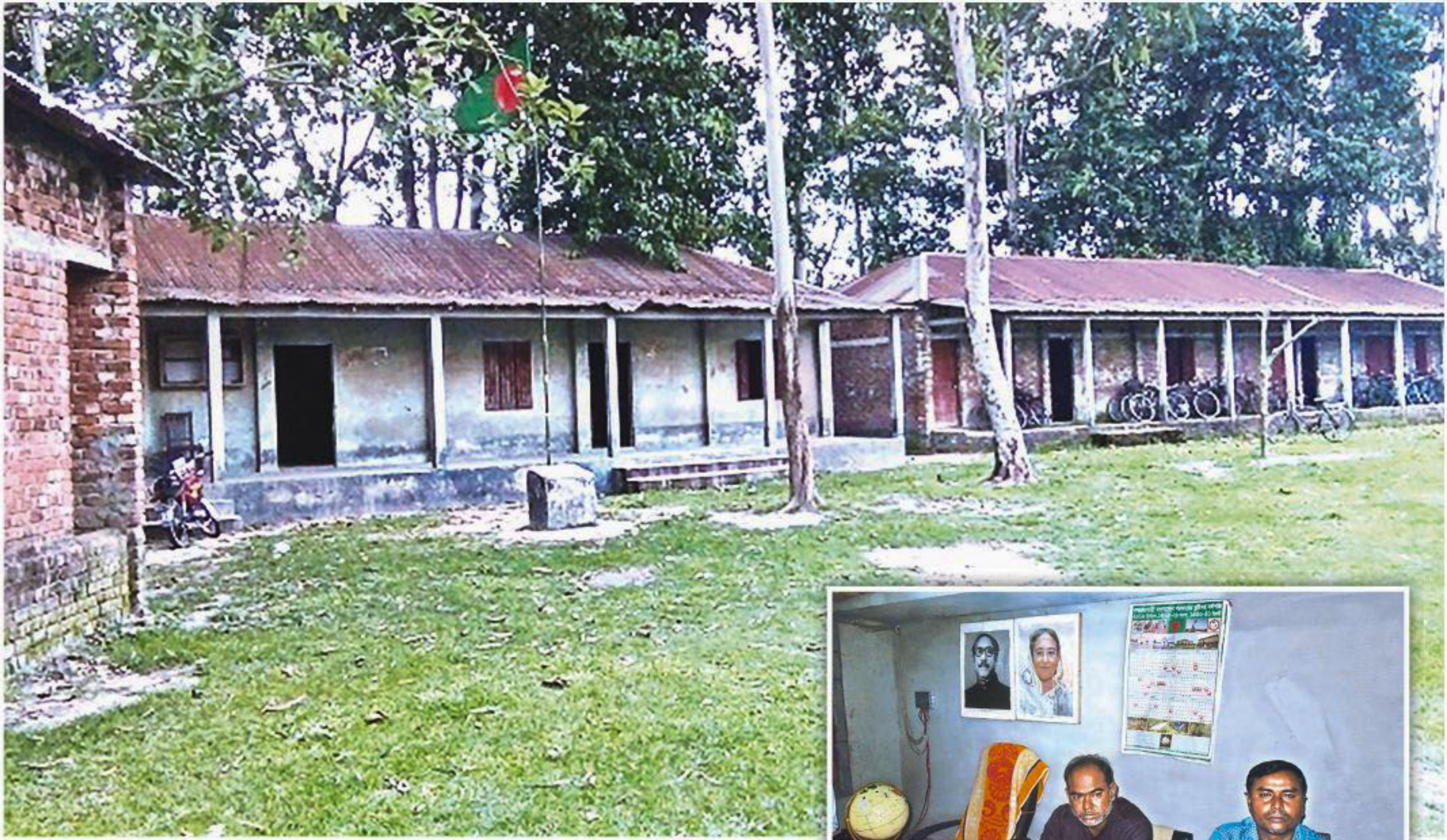

"I wanted to be a candidate for the permanent superintendent post as call for application was advertised in mid-December that year," he said.

Accepting his resignation on personal grounds, the then committee headed by Domar Upazila Nirbahi Officer (UNO) Sabiha Sultana appointed 45-year-old Abdul Mannan as the acting super.

In a letter dated Jan 11, 2016, the UNO asked for the opinion of Bangladesh Technical Education Board regarding this appointment because the second senior most teacher of the school Mohammad Zakaria had refused to take charge and there was another contender for the post of acting super.

Mentioning Erfanul's seniority and qualification, the then inspector of the board in reply admonish senior teachers' unwillingness in accepting the acting super's role and asked the UNO to take steps accordingly.

Meanwhile, the appointment process for permanent super got stalled and on October 16, 2016, Erfanul filed a petition with the managing committee to reinstate him as the acting super but the committee declined his request allowing Mannan to continue.

Three years later, on April 2019, the technical education board under the education ministry's directive wrote to the newly appointed Domar UNO

Umme Fatima to reinstate Erfanul as the acting super.

On June 3, through an executive order the UNO re-appointed Erfanul and directed Mannan to transfer his responsibility over to the former.

Mannan said, he filed a case with a Nilphamari court, seeking injunction against Erfanul's appointment and challenging the UNO's order, and refused to hand over charge until the case is settled.

Manan now shares a desk with Erfanul in the office of the acting super.

When contacted, the UNO said, "I have written to concerned authority requesting suggestion and will take action accordingly after getting guideline."

At the same time, the country has been improving the living standards of its population, he said, adding that political and policy challenges, however, remained.

Growth is expected to slow down to 7.4 percent in 2020 and 7.3 percent in 2024, said the report.

But this year, Bangladesh's GDP growth will tie with Rwanda's and will be bested only by Dominica and South Sudan, which are projected to grow at 9.4 percent and 7.9 percent respectively.

The IMF projected that Bangladesh will see less inflationary pressure this year. Inflation will be 5.5 percent this year, compared to last year's 5.6 percent.

It also highlighted that the current account deficit has been rising in the last two consecutive years. The negative balance was 2.1 percent of GDP in 2017 and 2.8 percent in 2018. In 2019, the negative balance will narrow to 2 percent of the GDP.

India's economy will grow at 6.1 percent, a downgrade from the IMF's April projection of 7.3 percent. Among the other South Asian economies, Bhutan will grow at 5.5 percent, the Maldives 6.5 percent, Nepal 7.1 percent, Sri Lanka 2.7 percent and Pakistan 3.3 percent this year.

The global economy is in a synchronised slowdown, with growth for 2019 downgraded to 3 percent from the IMF's April prediction of 3.3 percent -- the slowest pace since the global financial crisis.

Thereportsaid, "Thissubdued growth is a consequence of rising trade barriers; elevated uncertainty surrounding trade and geopolitics; idiosyncratic factors causing macroeconomic strain in several emerging market economies; and structural factors, such as low productivity growth and aging demographics in advanced economies."

"And yet, economies of Bangladesh, Cambodia, Nepal, Ethiopia, Rwanda, Dominica and South Sudan are projected

to grow at 7 percent or more this calendar year."

The report further added that "growth in low-income developing countries remains robust, though growth performance is more heterogenous within this group. Robust growth is expected for non-commodity exporters, such as Vietnam and Bangladesh, while the performance of commodity exporters, such as Nigeria, is projected to remain lacklustre."

"Downside risks to the outlook are elevated. Trade barriers and heightened geopolitical tensions, including Brexit-related risks, could further disrupt supply chains and hamper confidence, investment and growth."

Global growth in 2020 is projected to improve modestly to 3.4 percent, a downward revision of 0.2 percent from the IMF's April projections. Unlike the synchronised slowdown, however, this recovery is not broad-based and is precarious.

department and a spokesperson for the protesters.

"We will be watching whether the Buet authorities are implementing our demands," he added.

Sayem also said they would organise a mass oath-taking ceremony today to resist terrorism and communal forces on the campus.

Buet teachers and students will participate in the oath-taking, and the field-level protests will be called off at the programme, he said.

"The general students will not take part in any academic activities until the Buet authorities expel the accused on the basis of the charge sheet submitted by the law enforcers," he added.

"We do not want to share the same academic culture with the killers."

ONE MORE CONFESSED TO KILLING

Buet student Moniruzzaman Monir, an accused in Abrar Fahad murder case, yesterday

confessed before a magistrate that he and several others hit Abrar with cricket stumps.

In his statement, Moniruzzaman said he and some others took Abrar to Room No 2011 of the Sher-e-Bangla Hall where he struck Abrar four to five times with a stump, investigators and court sources said.

He also said several others, including Anik Sarkar, the information and research secretary of Buet BCL, hit Abrar the most, which led to his death.

After recording Moniruzzaman's statement, Metropolitan Magistrate Sarafuzzaman Ansary sent him to jail.

Earlier, five leaders of Buet BCL made confessional statements admitting their involvement in Abrar murder.

In another development, detectives arrested ASM Nazmus Sadat, an accused in the murder case, in Dinajpur early yesterday, while he was trying to flee to India.

With Nazmus's arrest, so far 20 people have been arrested in connection with the murder. He is a batch-17 student of Buet's mechanical engineering department.

Meanwhile, the same court yesterday placed Shamsul Arefin Rafath, another accused, on a fresh four-day remand after he was produced before the court on completion of his five-day remand.

The court also ordered to send Akash Hossain, an accused, to jail after his five-day remand.

The grisly murder took place between 7:30pm on October 6 and 2:30am on October 7. The incident sparked protests on university campuses across the country.

Road Transport and Bridges Minister Obaidul Quader, while talking to journalists at the secretariat yesterday, urged Buet students, who are protesting Abrar's brutal murder, to go back to the class as the prime minister has

assured Abrar's parents that there would be quick actions and disposal of the case.

Yesterday, the University Grants Commission requested the public universities to strengthen security measures for teachers, students, officers and employees ensuring round-the-clock monitoring of classrooms, halls and campuses.

'ANIK WAS NOT ASSAULTED IN JAIL'

Anik Sarkar, one of the accused in the Abrar murder case who is currently in jail, was not assaulted by inmates or jail police, the BSS reported quoting a senior official.

"After his arrest, Anik Sarkar was sent to Dhaka Central Jail and kept in a prison cell following proper procedures," said BSS quoting a statement issued by Inspector General of Prisons Brigadier General AKM Mustafa Kamal Pasha.

The media reports that earlier said Anik was beaten in jail were false, the statement said.
