A Dhaka court yesterday sent two juveniles to a correction home for allegedly raping a teenage girl in the district's Kamrangirchar area on Friday.

Police arrested the accused on Tuesday night after the victim's sister filed a case accusing four with Kamrangirchar Police Station, said Mostafa Anwar, inspector (investigation) of the police station. According to the case statement, one

of the victim's female friends took her to a house on Friday. Three boys were waiting in the house and raped the girl. The female friend was arrested for her

The victim then narrated the incident to her family, he added.

Police sent the girl to Shaheed Tajuddin Ahmad Medical College for forensic tests.

A Sylhet court yesterday sent two men to jail for their alleged involvement in raping a grade-nine student in the district's Zakiganj upazila on Monday.

The victim's family filed a case with Zakiganj Police Station accusing Kawsar Ahmed, 20, and Najim Ahmed, 21.

According to the case statement, battery-run auto-rickshaw driver Kawsar and his cohort Najim Ahmed, 21, picked up the girl on their auto-rickshaw along with some of her friends.

At one point the girl was alone inside the auto-rickshaw as rest of her friends got off the vehicle. The criminals then took the girl to an isolated area and raped her.

Former PNG PM temporarily avoids arrest

Papua New Guinea's ex-prime minister Peter O'Neill won a temporary reprieve in a corruption case yesterday when a court agreed to a brief suspension of

his arrest warrant. Acting police commissioner David Manning announced Tuesday that a warrant for O'Neill relating to graft allegations had been issued by a district court, but he refused to give details due to the "sensitivity" of the

investigation. O'Neill has denied the charges, calling them politically motivated, and refused to cooperate with police -- claiming a lack of legal process, including not being officially

presented with the warrant. "If this were a serious matter, not a political power play, a formal process would be in place that would have seen legal representation made to my office," the former leader said in a statement on Tuesday.

Papua New Guinea's national court yesterday granted O'Neill a short suspension of the arrest warrant until Monday, when the court will hear further arguments.

O'Neill's long tenure was marked by a string of corruption allegations, including the purchase of 40 Maseratis for an Asia-Pacific leaders' summit he hosted -- in a country where few homes have reliable electricity.

He was forced to step down in May after allies baulked at his decision to sign a multibillion-dollar liquefied natural gas deal with France's Total and US firm ExxonMobil.

Local communities had complained bitterly about not benefiting from similar deals in the past.

After promising to resign and then trying to cling to power via the courts, he was ultimately replaced by his former finance minister James Marape, who vowed to clean up the government.

"There is a natural life cycle to poverty, and well-designed safety nets can target support to households when they need it most: when children are young and when elderly household members must be cared for."

Talking about the issue, economist Zahid Hussain said the coverage of safety net schemes should be expanded in urban slums.

He said quality education, adequate healthcare and sanitation should be extended in the slums.

"A child born in a slum is not responsible for the poverty of the family. It is the responsibility of the state to provide proper education and nutrition to children so that they can break out of the vicious circle of poverty," he said.

He added steps were necessary to protect slum dwellers from various types of exploitation.
