has not given any approval for using foreign DTH technology,” the minister said.

He went on saying, “Foreign DTH services are being used in many areas which is completely illegal. All the illegal DTH connections must be removed by December 15. If not, we’ll then take action.”

The minister said one will have serve a prison term, at least two years, if he or she is found guilty, and pay a maximum fine of Tk 1 lakh while minimum Tk 50,000. If the offence is committed for the second time, the penalty will be three years’ rigorous imprisonment, at least Tk 1 lakh to Tk 2 lakh.

He said it is not prudent to telecast uncensored foreign serials since any movie must go through the censor board after it is produced.

Channels that are showing dubbed foreign serials have applied for approval and a committee will be formed to ensure the foreign serials are cleared by the censor board.

During the meeting, the minister said additional tax must be given if a foreign artiste is cast in any local advertisement adding that rules on making advertisements with foreign artistes will be introduced soon.

anti-liberation Jamaat-e-Islami, and a member of the Razakar Bahini during the war, according to the investigation agency.

He was arrested in May, 1972 under the Collaborators Order, 1972 but was released in August 1974. The accused retired as an assistant professor from Gopalpur Degree College in Natore’s Lalpur in 2011, it said.

The tribunal framed two charges against him on August 8 last year.

According to the charges, the accused was involved in the killing of at least 10 people, torturing of two people, looting of and arson attacks on 12 houses in areas under Boalia Police Station of Rajshahi.

The prosecution produced 14 witnesses, including the investigation officer of the case, to prove the charges while defence declined to produce any witness.

Railway demolishes 500 illegal structures in Narayanganj

Shops, restaurant of AL leader untouched

Railway authorities in Narayanganj yesterday evicted around 500 shops, which were built illegally occupying Railway’s land in the town, although a restaurant and 10 shops owned a local Awami League leader remained untouched.

Locals alleged that Railway authorities were favoring AL men, who denied the allegations and said he constructed the structures by taking lease from proper authorities.

Railway authorities started the eviction drive at around 11am at Rail Gate no.2 area in the town.

At one stage, they tried to evict a restaurant titled Monir Hotel and its 10 adjacent shops, which are owned by Moniruzzaman Monir, general secretary of word-2 unit AL of Narayanganj City Corporation.

At the time, Narayanganj city unit AL president Anwar Hossain, along with his supporters, came to the spot and requested Railway officials not to evict the restaurants and the shops. Finally, railway officials stepped back

and give Moniruzzaman three days to remove the structures by himself.

However, railway authorities did not give such opportunity to others.

“He (Monir) is an AL leader. That is why, he has got the chance. But we are common people. So, our shops have been evicted,” said a small trader whose shops were taken down.

Contacted, Moniruzzaman said,

“I did not construct any structure illegally. Rather, I took lease of the land from railway authorities.”

Contacted, Nazrul Islam, divisional estate officer of Dhaka of railway, said owner of a few structures -- which needs to be evicted partially -- were given deadline.

“We will demolish it if they fail to remove those on time,” said Nazrul.

KGC Principal said. “It is a family decision,” said Fayaz’s father Barkatullah when journalists asked him why he decided to move out of Dhaka. “We want him to stay close to us,” he added. “He is now my only son; he will fulfill the empty space that has been created after losing Abraar Fahad,” the devastated father said.

Contacted, chairman of Jashore board Prof Abdul Alim said the formalities were completed within the shortest time.

Abraar Fahad, a second-year student at Buet, was beaten to death by Bangladesh Chhatra League men at his university dorm on October 7. His father filed a murder case against 19 Buet students, mostly BCL leaders, and several other unnamed accused with Chawkbazar Police Station. A total of 19 people have been arrested over the murder, a number of whom have already confessed.

Regarding the lack of drives against Aedes mosquito, the mayor said the drives had slowed down, but it would start in full swing soon and will be continued throughout the year.

Dhaka North City Corporation mayor Atiqul Islam said they were planning to allocate a separate budget to control Aedes mosquito.

“Experts like entomologists and doctors have been working to prepare a masterplan for IVM, which will be completed shortly,” said Atiq.

He said they were also going to introduce a monitoring system by a team of entomologists from outside the corporation. These teams will inspect mosquito control drive of DNCC each month and provide reports.

Saying that most of the people have lost their legs in road crashes, she underscored the need for taking initiatives to reduce accidents in future.

Bhagwan Mahaveer Viklang Sahayata Samity (BMVSS) is making the prosthetic legs.

While taking measurements of Khadem Ali, who lost both legs about 12 years ago, BMVSS technician Sudama Rai said it took them one and a half hours to install an artificial leg on a person.

Asked about the durability of the prosthetic legs, he said, “Each [prosthetic leg] lasts about three years. If you use shoes, it will last longer.”

Dr Md Wahidur Rahman, secretary general, Bangladesh Orthopaedic Society said they have already installed 300 prosthetic legs. “Two hundred more will be installed,” he said, adding that distribution of 750 more will begin from November 4.
