Vector control guideline must for Aedes control: experts HELEMUL ALAM

Despite the record spread of dengue fever this year, Bangladesh is yet to form a vector control centre and integrated vector guideline, both of which are essential to control vector-borne diseases.

Vector-borne diseases are human illnesses caused by parasites, viruses and bacteria that are transmitted by mosquitoes, sandflies, ticks, lice and various other insects.

"A national vector control guideline and its proper implementation is very important to control Aedes mosquito, said Prof Kabirul Bashar, an entomologist of Jahangirnagar University. He said a separate institute for mosquito

control is also very important. It would also help with research on the matter and provide helpful information to authorities concerned. Research is needed not only on mosquitoes, but other kinds of vectors such

as sandflies (which spreads black fever), and bed bugs, he said. Bashar said, in the meantime local government organisations would have to continue their drives against Aedes

mosquito at least till the end of October.

An official of local government division (LGD) said a team from World Health Organisation (WHO) visited recently and provided technical advice to both city corporations of Dhaka and LGD. The WHO team will submit a report to LGD by this month, outlining the proper way of integrated vector management (IVM).

"We are now working to prepare an IVM strategy for the whole country and also preparing an institutional framework

for it. WHO's report will help us," said the official.

He said they are also planning to strengthen the activities of department of mosquito control, which is now in a

shabby state. Md Mahbub Hossain, additional secretary of LGD, recently told the Daily Star that as the huge spread of dengue was new in the country, city corporations were

still figuring out their approach. He said they have sought masterplans from every city corporation of the country regarding mosquito control activities.

Meanwhile, Director of Communicable Disease Control at Directorate General of Health Services (DGHS), Sanya Tahmina said they organised an integrated vector management (IVM) preparation workshop on Sunday involving entomologists and other stakeholders.

"We will start working on the IVM

management guideline soon," she said. Dhaka South City Corporation Mayor Sayeed Khokon said they want to prepare a five-year development project to control Aedes mosquito.

Under the project, an integrated research centre for communicable disease control will be constructed under a separate department, he said. "We will appoint necessary manpower, including entomologists, to conduct research and take steps accordingly," he said.

It will take around 10 days to complete the development project proposal and work will begin after the Executive Committee of National Economic Council approves it, he

Doctors and health experts at a roundtable yesterday urged the government to stop unnecessary caesarean deliveries (c-section), which have been growing in an alarming rate in recent years.

They urged health service providers to give more priority to natural birth and encourage expectant mothers and families in this regard. Bangla daily Prothom Alo in association with "Stop Unnecessary

C-section" organised the discussion at the newspaper's office in Dhaka. Speaking at the event, Ishtiaq Mannan, deputy country director of Save the Children Bangladesh, said mothers who have caesarean births face

various health complications. It is also costlier, he added. "Majority of doctors feel more convenient to handle caesarean birth," Mannan said, stressing the need for doctors' skill development on normal birth.

Noted gynaecologist Rowshan Ara Begum said the government needs Secretariat on digitalisation to extend its [normal delivery] services and ensure quality treatment if it of cable television channels wants to stop the rising trend of c-section. She suggested increasing the in Bangladesh. number of community clinics, particularly in rural areas.

Prof Mohammod Shahidullah, president of Bangladesh Medical and Dental Council; Abdul Quayum, associate editor of Prothom Alo; Shams El Arefin, a researcher of icddr,b; and Rashna Imam, a Supreme Court lawyer, also spoke at the event.

Indian High Commission donates 500 prosthetic legs to those in need

Eight-year-old Morium Aktar Mim used to remain dispirited most of the time because she could not walk like her friends.

To bring smile to her face, her father Mohammad Joynal Abedin -- a rickshawvan puller -- had purchased a prosthetic leg for Tk 5,000 three years ago from a roadside shop in Sher-e-Bangla Nagar. But it became defective about a year ago.

Yesterday, as a technician at Nitor was taking measurements for a new prosthetic leg for her, Mim was all smiles.

"I saw news on television that prosthetic legs would be given away among the underprivileged, so I came here," said Joynal, who lives in Gazipur. He was among 50 people who gathered at National Institute of Traumatology and Orthopaedic Rehabilitation (Nitor) yesterday.

Indian High Commission, association with Nitor and Bangladesh Orthopaedic Society, is holding Jaipur Foot Artificial Limb Fitment Camp to provide 500 prosthetic legs to those in need in Bangladesh, on the occasion of Mahatma Gandhi's 150th birth anniversary.

Mehedi Hasan Rony, 24, lost his left leg under the wheel of a bus about one and a half years ago in Khulna.

"The accident turned my life upside down," he said during a test walk at the corridor of Nitor.

"I'm happy. I can walk again," Mehedi. While inaugurating the programme, Indian High Commissioner Riva Ganguly Das said, "I hope the artificial legs will bring changes to all beneficiaries' lives,"

Verdict in case against Rajshahi man any day

The International Crimes Tribunal-1 will deliver verdict any day in a case filed against a Rajshahi man for allegedly committing crimes during the Liberation War.

The three-member tribunal led by Justice Md Shahinur Islam yesterday kept the verdict waiting after both the prosecution and the defence counsel completed closing arguments in the case, said Prosecutor Muklesur Rahman Badal.

Abdus Sattar alias Tipu alias Tipu Sultan, 66, is facing two charges. He pleaded not guilty before the court and sought justice.

Counter-terrorism officials claimed to have arrested three alleged operatives of "Neo JMB" in the city's Gabtoli area on Wednesday night.

The arrestees are: Md Abdullah, 24; Shafiqul Islam alias Mollaji, 38, and Musatafa Hosen Arif, 25.

A team of Counter Terrorism and Transnational Crime (CTTC) unit arrested them around 8:30pm after they arrived in Dhaka by a bus from a northern district, said Masudur Rahman, deputy commissioner (media) of Dhaka Metropolitan Police.

According to CTTC officials, the three were once members of JMB. They joined Neo JMB through Sohel Mahfuz alias Haatkata Sohel, an accused in the Holey Artisan attack case.

Officials said Shafiqul and Musatafa took several other operatives to India to train them on making bombs and using firearms.

Both returned after some of their associates were arrested by Indian authorities in June. Afterwards, they started strengthening the outfit through Abdullah, said the CITC official.

A case was filed with Darussalam Police Station under Anti-Terrorism Act.

3 'Neo JMB' men Don't go beyond rules: PM to UGC

Last witness starts deposition

Prime Minister Sheikh Hasina yesterday asked the University Grants Commission (UGC) authorities to strictly follow concerned rules in overseeing public and private universities in the country.

"Don't go beyond the law, and follow rules strictly in overseeing public and private universities of the country," she said when a delegation of the UGC led by its Chairman Professor Dr Kazi Shahidullah called on her at her office here.

After the meeting, PM's Press Secretary Ihsanul Karim briefed reporters. The prime minister also laid emphasis on increasing monitoring on

private colleges affiliated with the universities. She said UGC will be empowered by formulating a law, and its capacity will be enhanced further.

The UGC chairman said they are strictly following the law in monitoring public and private universities. The delegation apprised the prime minister of the activities of the commission.

Kazi Shahidullah said they have outlined a policy for conducting research at the universities. "We want a training academy like the Pubilc Administration Training

Centre (PATC) for teachers," he said. Prof Shahidullah said there are now 155 public and private universities in the country, adding that UGC has identified 30 private universities for

various irregularities in running the institutions. The UGC chairman also stressed the need for increasing manpower of the commission to deal with a large number of institutions, saying they

are strung by inadequate manpower. PM's Principal Secretary Md Nojibur Rahman and PMO Secretary Sajjadul Hassan were present at the meeting.
