

Profit-mongers to face stern action

Warns Ctg DC at meeting with onion traders

Stern actions will be taken against traders if they are found selling onion at exorbitant prices and making excessive profit, warned Deputy Commissioner (DC) of Chattogram Mohammad Ilias Hossain yesterday.

While addressing a views-exchange meeting with onion traders on controlling prices of the vegetable, the DC urged them to keep the price at reasonable stage.

Warehouse owners and commission agents of Khatunganj wholesale hub as well as leaders of trade associations were present at the meeting, held at the conference room of Chattogram district administration.

In his speech, the DC said, "We are not against traders. But when people suffer, we are ready to take action. We don't want you to make excessive profit and also don't want to disturb the trade."

He made it mandatory for all wholesalers and retailers to display price charts at their outlets.

The DC directed depot owners and commission agents to keep the names and phone numbers of importers as well as receipts of their purchase. The administration or the ministry will directly contact the importers if necessary, he said.

He warned of punitive actions if any trader is found engaged in selling onion

through illegal means.

Traders at the meeting urged the DC to take steps for allowing onion-laden trucks entering the city at daytime for smooth supply of the vegetable.

The DC assured them of taking steps in this regard. He mentioned that fewer number of such trucks are arriving at Khatunganj market these days.

He suspected that some unscrupulous traders may have been preventing those trucks from coming to Khatunganj, sensing less profit due to recent mobile court drives. "We are looking into the matter," he added.

DC Hossain said that according to the commerce ministry's list, they found names of eight Chattogram-based onion importers but none of them showed up in yesterday's meeting even after they were informed. He said the administration will inquire about it.

Former director of Chittagong Chamber of Commerce and Industry Mahfujul Hoque Shah; Khatunganj Trade and Industries Association general secretary Syed Sagor Ahmad; Hamidullah Mia Market Traders Association general secretary Mohammad Idris and Chaktai-Khatunganj Aratdar Samity president Jahangir Alam spoke at the meeting, among others.

Abrar's brother completes transfer to Kushtia college

The transfer admission process of Abrar Fayaz, younger brother of murdered Buet student Abrar Fahad, from Dhaka College to Kushtia Government College (KGC) has been completed.

Fayaz applied to the Dhaka College authorities for transfer his credits on Tuesday, as he wanted to get admission to KGC. Through a mediation of Dhaka Board authorities, principals of both colleges gave no objection clearance to it, confirmed KGC Principal Prof Kazi Manjur Quadir yesterday afternoon.

Fayaz's father went to KGC on Wednesday to fill out the paperwork. Fayaz, however, not present as he was sick, said his father Barkatullah.

The Dhaka board authorities then sent a letter to Jashore Board.

"After completion of all procedures, Jashore board approved the admission of Fayaz and sent a letter to us,"

Two cops among four sued for falsely implicating youth

Four persons, including a former officer-in-charge (OC) of Panchlaish Police Station, have been sued on charge of producing a youth before a mobile court over a "false" sexual harassment incident.

The incident occurred in 2017 but Rubaiyat Sayem, 26, of port city's Bakalia area filed the case yesterday with the court of Metropolitan Magistrate Shafi Uddin -- accusing the four, including two policemen.

The accused are: Shahana Yalin Sumi, 26; her elder brother Kamrul Islam; the then Panchlaish OC Mohiuddin Mahmud; and Sub-inspector (SI) Abu Taleb of the same police station, said plaintiff's lawyer

Advocate Nazmul Alam.

"After filing the case, the court ordered Detective Branch (DB) of CMP to investigate into the case and submit the report before the court," said Advocate Nazmul.

Advocate Nazmul said Sayem and the accused Sumi were BBA students of Premier University (PU) and the duo were in a relationship in 2017, but Sumi's brother opposed the relationship.

Both Sayem and Sumi's families met several times over the issue, and Sumi's brother Kamrul threatened to have Sayem sent to jail if he did not leave her, added the lawyer.

The lawyer added that failing to stop Sayem, Kamrul set up a trap for him and later handed him over

to Rapid Action Battalion (Rab-7) tactfully when he went to Sumi's house on April 10, 2017.

"After detaining him, Rab handed over Sayem to Panchlaish Police Station. Despite having no specific allegation against Sayem, Panchlaish police held him overnight and on the following day, Sayem was brought in front of Bodna Shah Mazar area of Prabartak where police staged a sexual harassment drama with the help of Sumi and his brother," said the lawyer.

According to the case statement, the mobile court run by Executive Magistrate Abdus Samad sentenced Sayem to three months' jail over the alleged sexual harassment and sent him to Chattogram jail on that day.

BASIC BANK LOAN SCAM HC asks businessman to surrender to trial court

The High Court yesterday cancelled the bail of businessman Syed Mozaffar Hossain in a case filed for misappropriating Tk 141 crore from BASIC Bank, and ordered him to surrender to the trial court immediately.

The HC bench of Justice Md Nazrul Islam Talukder and Justice KM Hafizul Alam dismissed a bail petition filed by Mozaffar, director of IG Navigation Ltd.

Deputy Attorney General AKM Amin Uddin Manik said Mozaffar took Tk 75 crore loan from the bank's Agrabad Branch in Chattogram in 2010 by mortgaging an old ship worth Tk 12 crore. The amount stands at Tk 141 crore with interest till 2018, but Mozaffar did not pay any amount.

Anti-Corruption Commission filed a case with Double Mooring Police Station against him on January 10, 2018.

DAG Manik said following a bail petition by Mozaffar, the HC on April 6, 2018 granted him six months' bail. The Appellate Division of the Supreme Court later upheld the bail on condition that he will reimburse Tk 25 crore to the bank, but since he did not do so, the HC yesterday ordered him to surrender, DAG Manik added.

Yaba peddler held from Barishal doctors' dorm

Law enforcers conducted a drive at FM Nur-Ur-Rafi Doctors' Hostel of Sher-E-Bangla Medical College Hospital (SBMCH) yesterday afternoon and arrested an outsider in possession of drugs.

The arrestee, Md Rifat, took shelter in room 303 of the intern doctors' hostel. Police sources said that they conducted drive based on a tip-off. They recovered 500 pieces of yaba, a knife, an iron pipe and a hammer, Barishal Metropolitan Police (BMP) sources said.

"Authorities informed us about the drug peddling operation which has been running for a long time," said Mohammad Rasel, assistant commissioner of BMP.

Bakir Hossain, director of SBMCH told the Daily Star, "No outsiders will be allowed to stay in the dormitory. We will take action against those who don't have permission to stay here."

DEATH ON ROADS

7-year-old, hit by auto-rickshaw, dies in Dhaka

A seven-year-old girl died yesterday after being run over by a battery-run auto-rickshaw, in Nandipara bank colony of the capital. The deceased was identified as Ujma Islam Jannat, a third-grader of a local madrasa.

Her father Mohammad Sohag, a construction worker, said an auto-rickshaw ran her over while she was playing with other children near her residence around 10am.

Locals rushed her to a nearby hospital in Mugda, from where Sohag took her to Dhaka Medical College Hospital. He said the girl breathed her last at 5pm.

Mahbub Alam, officer-in-charge of Sabujbag Police Station, said the auto-rickshaw was seized but its driver managed to flee.

MOTORBIKER KILLED, TWO INJURED ON HANIF FLYOVER

Meanwhile, a motorcyclist died and two others were injured after the rider lost control of bike on Mayor Mohammad Hanif Flyover in the city's Tikatuli area early yesterday.

The deceased was identified as Kamruzzaman Heera, 26, a private job holder. The injured are Sohail Hossain, 27, and Khadiza Akhtar, 25.

Uncle of the deceased Abdul Motaleb said Kamruzzaman, a resident of east Nakhalpara, was going to Shanir Akhara to drop two of his friends to their home on his motorbike. Commuters in the area rushed them to Dhaka Medical College Hospital, where doctors declared Kamruzzaman dead.

Sohail and Khadiza are undergoing treatment at the hospital.

Sub-inspector Abul Kalam Azad of Wari Police Station confirmed the incident, adding that an unnatural death case was filed in this regard.

Traffic cop killed in Ctg

An on-duty traffic sergeant of Chattogram Metropolitan Police was killed in a road accident in port city's Halishahar Toll Road area yesterday evening.

The deceased is Bakshi Md Abdullah, 30, from Kurigram. He joined the force in 2015.

Alake Biswas, additional deputy commissioner (traffic) of Bandar Zone, said a speeding covered van hit Bakshi's bike around 5:30pm.

After he fell down, Bakshi was hit by another covered van, injuring him critically.

Locals and patrol police rushed him to Chattogram Medical College Hospital where he succumbed to his injuries around 6:30pm, the ADC said.

Police seized the two vans but their drivers managed to escape, he added.

Trucker runs over another in Panchagarh Family file murder case

A truck driver allegedly killed another trucker by running him over in Panchagarh on Wednesday.

Later at night, the victim's family filed a case with Tentulia Police Station, accusing Abdul Quddus, 25, and his helper Sagor, 23, of murdering Abdullah Al Mamun, 32, said police.

Mamun was driving to Banglabandha from Tentulia's Tiroihat village with several workers on his truck, said Officer-in-Charge Johurul Islam citing the case statement.

He tried to overtake another truck that did not give him room to pass, said the OC.

When Mamun was able to overtake at Sipaipara, he stopped his vehicle, got off and asked the other driver, Quddus, why he was not letting him pass, triggering a scuffle between them, said OC Johurul.

At one stage, Mamun was heading back to his vehicle but Quddus ran him over intentionally, the police officer said, quoting the case statement.

Locals took him to Panchagarh Sadar Hospital where he was declared dead.

Agitated people halted Quddus' truck and handed him over to police while his helper managed to escape.

8 Rohingyas detained in Goalanda

Police arrested eight Rohingyas from Goalanda Bus Terminal area in the upazila yesterday.

The arrestees are -- Rashid, 25; Kalema, 20; Minar, 20; Zohura, 55; Khushnara, 18; Rashida, 18; Kamal, 16; and Mirzafar, 18. All of them came from the Kutupalong Rohingya camp in Cox's Bazar, police said.

SI Mizanur Rahman said they had boarded a Satkhira-bound bus from Dhaka, and were forced down from the bus around 7:30am, as no one could understand their language. Later, police detained them after interrogation.

Bangladesh is currently hosting more than 1.1 million Rohingyas. Most of them fled here from their homeland in Myanmar's Rakhine State in 2017.

DEATH OF SCHOOLBOY Locals demand arrest of culprits

Protesting the death of a schoolboy who was brutally knifed, locals blocked Mymensingh-Kishoreganj road in Ishwarganj upazila of Mymensingh, demanding immediate arrest of the culprits.

Locals blocked the road for three hours, from 11am to 2pm, creating serious traffic congestion. They also brought out a procession and formed a human chain to press home their demand.

On information, police rushed to the spot and brought the situation under control.

Md Jahidul Islam, 15, a Secondary School Certificate examinee, was stabbed by masked miscreants in Ishwarganj upazila around 9:45am on Tuesday. He later succumbed to his injuries at Dhaka Medical College Hospital on Wednesday.

Deceased's mother Noor Jahan lodged a case with the police station, accusing 11 persons. Ex-joint secretary of Bangladesh Chhatra League's Ishwarganj Degree College unit Moshirur Rahman Kanchan was named as the prime accused, the OC informed.

Police arrested Kanchan for his alleged involvement in the killing. He was produced before a Mymensingh court with a five-day remand prayer on Wednesday afternoon.

No hearing was held on the remand prayer and the court sent him to jail. Drives are underway to arrest the other accused, the OC said.


'Troublemakers will be uprooted from CHT' Home minister says
