# Open ground remains water-logged half the year

The 3-acre field remains inundated due to poor drainage system

Like previous year, the playground in front of Rakhine Mahila Market in Patuakhali's Kalapara upazila has gone under rainwater impeding commercial and cultural activities in the area.

The three-acre field remains inundated from May to October due to poor drainage system, said traders, who run shops at the market frequented by tourists.

One shop owner, Umeng Uchu, said the nuisance occurred last year after some shops were set up on the edge of the field.

Those shops blocked the old drain lines resulting into waterlogging, she said. "Customers get irritated as their dresses get dirty while shopping here,"

said the lady.

earlier this month, Abu Bakar Siddique, a tourist from Gazipur, said, "I visited Kuakata in the dry season last year. The field looked great then but now all I can see is knee-deep stagnant water."

Abul Kalam, another tourist from Barishal, said, "People come to Kuakata to buy goodies from the Rakhine Market. It is difficult to shop when the field is flooded," he said urging the authorities concerned to take due steps without a delay.

Kuakata municipality had built a stage on the east side of the field for holding public meetings and cultural programmes. Local cultural organisations and political parties used it on occasions like Victory Day and Independence Day.

"The stage is no longer in use as the field remains inundated for six While talking to this correspondent months. No cultural activity could

be held in about last two years due to reoccurring waterlogging," said Amir Hossain, a leader of a local cultural organisation.

Moreover, youths are not being able to play on the field.

The upazila administration had built two helipads on the field for easy landing of political leaders. Those have also been submerged by rainwater.

Kuakata Municipality Mayor Abdul Barek Mollah said a pipeline was temporarily built last year to remove the water but some Rakhine people

"They broke it because it touched parts of their land and homes. They anticipated that it was a permanent thing," said the mayor.

"In coming dry season, we will dump sand on the field and build a permanent drainage system. We will also renovate the stage," he added.

# Pregnant housewife tortured, shaved for dowry

Accused husband, mother-in-law arrested

A pregnant housewife became victim of brutal torture by her dowry-greedy husband in Baufal upazila of Patuakhali on Tuesday.

The victim Priyanka Rani, 20, was able to flee from confinement at her in-laws' house in Kalaiya launch terminal area of Baufal upazila and reach her father's house the next day.

Police arrested the victim's husband Tapos Chandra Mondol, 25, and his mother Laksmi Rani, 45, on Wednesday night.

Priyanka said her husband is a drug addict and he often asked her to bring money from her father's house.

"On Tuesday he asked me to bring Tk 50,000 from my father. As I refused, he physically tortured me. At one stage he cut my hair with a boti (a sharp tool used in kitchen). Then he called a man from the to jail," said Md Mostafizur Rahman, OC of nearby saloon and got my head shaved. Baufal Police Station. "Afterwards, they confined me to my room.

from my in-laws' house and informed my father," said the victim, in tears.

Priyanka's father Shushil Chandra Karmakar said, "During marriage of my daughter five years ago, I gave her husband Tapos three tolas of gold along with cash money but he continued pressing for more. I demand justice for the brutal torture on my daughter."

Priyanka filed a case accusing her husband Tapos, father-in-law Porimol Mondol, mother-in-law Laksmi Rani and sister-in-law (husband's sister) Bithee Rani with Baufal Police Station on Wednesday night.

"Police arrested Tapos and Laksmi Rani from their house on Wednesday night They were produced before Patuakhali Senior Judicial Magistrate's Court today [Thursday] noon and the court sent them

### Youth arrested for killing wife

Police on Wednesday evening detained a youth in connection with a case for killing his pregnant wife allegedly over a family feud in Kishoreganj Sadar upazila the same day.

The detainee, Sumon Mia, 21, an auto-rickshaw driver, is son of Abdur Rahim of Chaog Sholakia village in the upazila.

Quoting locals and deceased's family members, police said Juyena Akter, 19, daughter of Oli Newaz of Kashurarchar village, was married to Sumon some six months ago.

Following a family feud with her husband, Juyena returned to her parents' house about 15 days ago, Officer in Charge (OC) of Sadar Police Station Abu Bakar Siddiq said.

Sumon came on visit his in-laws' house on Tuesday night and left the house on Wednesday early morning.

Later, around 8:00am family members found Juyena's body lying on the bed and informed police, who recovered the body and sent it to Kishoreganj General Hospital for autopsy.

Meanwhile, following a case filed by the victim's father with Sadar Police Station the same noon police arrested Sumon from Sogra area in the evening.
