## 3 murders shock

10:00am on Friday as an unidentified for interrogation, said Kamrul Islam, person. His relatives came to Chattogram Medical College morgue at night and identified him.

The inspector said that soon after Alam left ĥis Sitakunda clinic around 9:30pm on Thursday to go to his home in Chattogram city's Chadgaon residential area, he went missing.
On information from locals, police

recovered the body with multiple stab wounds in the hands, face and legs, Inspector Shamim said.

Mir Mohammad Helal Uddin, brother-in-law of the victim, said Alam came to Bangladesh after retirement to do something for the people of his village even though his relatives had told him not to come back. "He was so gentle and polite. I can't believe someone murdered him.

"I also discouraged him to return, leaving the secured life and career in Saudi Arabia," said Helal, also a member of BNP central executive committee, adding, "But he was determined to serve people in his village.'

"He founded the clinic in the village but could not serve the people for too long as his clinic began operation in January... It is very unfortunate that a brilliant mind, who returned to the country to serve his people, has been brutally killed.

Alam used to use public transport to go home from his clinic, said Izab Uddin, the receptionist at Alam's clinic.

"On Thursday night, I escorted him to a Safe Line Paribahan human haulier," he said, adding, "There was only one other passenger with the doctor when I saw him off.

Alam's niece Nasrin Akhter said that the murder seemed to be planned since valuables, like his wrist watch, were still with him. The murder could not have been carried out by muggers, Nasrin

Inspector Shamim, however, said the victim's mobile phone was missing and found switched off.

The doctor was a batch-20 student of Chattogram Medical College and completed his MBBS in 1983.

Dr Mujibul Huq Khan, president of Bangladesh Medical Association (BMA) in Chattogram and also a class mate of the victim, said that Alam was very soft-spoken and good natured. "As far as I know, he did not have any enmity with anyone.

Such an incident will discourage brilliant minds, who are abroad, to return to the country and serve its people, Mujibul said.

Monwar-ul-Haque Shamim, vicepresident of BMA in Chattogram, said, "I demand the administration to arrest the criminals immediately.

Ajmeri Shikder Kanta, wife of Alam, said she called her husband several times on Thursday night but did not get any response. "At one stage, his phone was found switched-off," she said, adding, "Worried, I started contacting our relatives.

"How will I live now?" she said as she wailed in front of the CMC

The couple has two sons -- Nabil, a university student, and Ryan, an O' Levels candidate.

Inspector Shamim said a case was being filed with Sitakunda police station. Police have not been able to arrest anyone in connection with the incident till filing of this report.

Meanwhile, police yesterday recovered the bodies of a man and his four-year old daughter from their house in the port city's Nimtala-Biswa Road area.

The dead were identified as Abu Taher, 35, a day labourer, and his daughter Bibi Fatema, from Noakhali, said police.

Their bodies were found with the throats slit.

## British MPs force

"The Prime Minister will not ask for a delay.'

Brussels urged Britain to explain its plan as soon as possible while Labour leader Jeremy Corbyn, whose party opposed the deal, said: "The prime minister must now comply with the

Securing the deal at Thursday's Brussels summit was a personal victory for Johnson, a figurehead in the 2016 Leave campaign who has vowed to deliver Brexit on October 31 come what may.

He has spent the last 48 hours frantically trying to persuade MPs to back it, and won support from many of the eurosceptic Conservative MPs who rejected a previous divorce

But parliament -- like the frustrated public -- is still bitterly divided over how and even if Britain should end four decades of integration with its closest neighbours.

Opposition parties and Johnson's own Northern Irish allies rejected the text, and joined together to back an amendment brought by former Conservative minister Oliver Letwin.

This amendment made approval of the deal contingent on parliament passing legislation to ratify the text before Britain leaves the EU.

Johnson needed a clear vote in favour of the deal to avoid triggering a law passed against his will last month, requiring him to send a letter asking for a delay of three months to Brexit.

If he refuses, he is likely to face a

court challenge forcing him to send it. If EU leaders agree, he must accept, or if they offer an alternative date, he must also accept unless parliament trade terms.

Johnson earlier warned a third Brexit delay was "pointless", adding: "Now is the time to get this thing done.'

He said he would introduce legislation next week to implement his Brexit deal, expressing hope that if it passes, Britain could still leave on October 31. The first vote could come as soon

Outside parliament, tens thousands of people marching to demand a new referendum that might reverse Brexit erupted into cheers at the result.

The first referendum was jumping on a train without a destination. Now that we have a destination, we need to have a second referendum," said Douglas Hill, 35, on the march with his Estonian wife.

The leader of the main opposition Labour party, which opposed the Brexit deal, echoed this.

"We will not back this sell-out deal," Jeremy Corbyn said.

He added: "Voting for a deal today won't end Brexit. It won't deliver certainty and the people should have the final say."

An online Survation poll of 1,025 adults on Thursday and Friday for the Daily Mail found that 50 percent said MPs should vote for the deal, while 38 percent said not.

EU leaders in Brussels this week urged lawmakers to back the deal to allow both sides to move on to discussing their future relationship.

The deal covers Britain's financial settlement, protects the rights of EU citizens and sets out a post-Brexit transition period potentially until 2022 to allow both sides to agree new

# More trains, longer delays

make way for other trains, leading to delay in schedules," Mamun told this newspaper over the phone recently.

Besides, the length of the "block section" -- the distance from one station to another -- between Joydebpur and Bangabandhu Bridge (East) Station is relatively long, meaning each train has to wait longer to make way for the other.

Another reason for the delay is Bangabandhu Bridge.

Trains have to run at the "restricted speed" of 20 kilometres per hour while crossing Bangabandhu Bridge. It takes about half an hour to cross the seven-km stretch between the bridge's east and west stations, he added.

The pressure intensifies further during the Eid rush as the BR operates special trains to carry additional passengers. The train schedules collapsed During the last Eid-ul-Azha, forcing people to wait for up to 16 hours at Kamalapur and Dhaka airport rail stations to catch trains bound for western districts.

Earlier in January 2016, the government took up a Tk 9,734-crore project to construct Bangabandhu Sheikh Mujib Rail Bridge over the Jamuna river. Physical work of the 4.8-km bridge will start in January next year and end by 2023, the railways minister said recently.

At a press briefing on September 17, the minister said the problems regarding train schedules on the western routes cannot be resolved until the construction of the bridge and the dual-gauge double line from Joydebpur to Ishwardi.

The demand for more trains has gone up drastically but it's not possible now to add more than one or two on the western routes, mentioned the minister.

"More trains will result in more delay in train schedules," he added. In January this year, the

government took up a Tk 14,250.61 crore project to turn the Joydebpur-Ishwardi section into a dual-gauge double line. It is scheduled to be completed by December 2024. However, physical work of the project is yet to start.

WHY NEW TRAINS?

The authorities launched "Banalata Express", a nonstop intercity train service, on Dhaka-Rajshahi route in April this year -the first train after Railways Minister Sujan took charge in January this

extended up to Chapainawabganj.

Launching a non-stop intercity train on Dhaka-Rajshahi route was one of the election pledges of Rajshahi city Mayor AHM Khairuzzaman Liton.

A month later, a semi-nonstop intercity train service -- "Panchagarh Express" -- was launched between Dhaka and Panchagarh, the home district of the railways minister.

Besides, "Benapole Express" was launched in July on Dhaka-Benapole route to facilitate passengers going to India via Benapole.

On October 16, the government introduced an inter-city train on Dhaka-Kurigram route. It also plans to increase the frequency of Maitree Express on Dhaka-Kolkata route. The trans-border train could run five or six days a week instead of four.

However, a BR official who worked as divisional manager (Pakhsi) said they had urged the higher authorities not to launch any more train in the western zone. Rather, they suggested replacing and increasing the number coaches of existing trains.

"But the authorities didn't pay heed to our suggestion," said the official on condition of anonymity. Prominent transport expert Prof

Shamsul Haque said that in the railway, "politics" often gets priority over technical issues and service. The government is introducing express trains only to show off its

required infrastructure, he said. Prof Shamsul, also former director of Accident Research Institute at Buet, said no new train should be introduced without having necessary infrastructure including multiple

railway tracks. "Schedules of many trains get delayed for hours in the absence of alternative railway lines, leading to an increase in operational costs of the trains," he mentioned.

Atiqur Rahman, project officer of Work for a Better Bangladesh Trust, said the railway usually does not carry out any analysis before launching a train on a route. "The authorities choose routes

for new trains under influence from local politicians," alleged Atiqur, who has experience of more than eight years in the sector.

He suggested that the authorities should add new coach, instead of new train, until they can increase the work in selecting stations."

POOR RESPONSE

The Benapole Express is failing to get expected response from passengers.

Almost half of its seats, except for the air-conditioned berths and chairs, remain vacant during its journey from Dhaka to due to inconvenient schedule and delay, said a BR official early this month.

The train reaches Dhaka from Benapole within eight hours. But it takes more than 10 hours to reach Benapole from Dhaka as it has to wait at several crossings, he said.

The authorities now plan to have two to three more stoppages to get more passengers.

### US court convicts Honduran president's brother of drug trafficking

A New York court convicted the Honduran president's brother of drug trafficking Friday, a verdict immediately rejected by the Central American leader while opponents called for his resignation.

Tony Hernandez was found guilty on all four counts following a trial in Manhattan that lasted almost two

President Juan Orlando Hernandez said his brother had been convicted with "testimony from confessed murderers.

"On behalf of my family, and personally, it is with great sadness that I received word of the verdict in New York," the president wrote on Twitter.

Tony Hernandez was arrested at a Miami airport in November 2018 on charges including conspiring to import cocaine into the United States, possessing machine guns and making false statements

former Honduran congressman, 41, is due to be sentenced on January 17. He faces between five years and life in prison.

Following the verdict, opposition parties in Honduras called for street protests to demand that the president step down.

Manuel Zelaya, the former president of Honduras who was overthrown in a coup in 2009, tweeted that the verdict had "unmasked the drug and corruption network run by the government of Honduras."

Although he wasn't on trial himself, the court proceedings featured compromising allegations against the president. Prosecutors said the Honduran

leader took millions of dollars in

bribes from drug lords including

jailed Mexican kingpin Joaquin "El Chapo" Guzman. President Hernandez, an ally of US President Donald Trump, dismissed the accusation as "absurd" and "less serious than Alice in Wonderland," in

The Manhattan prosecutor's office filed a motion in August alleging that President Hernandez received at least \$1.5 million in drug money from one of the prosecution's cooperating witnesses for his first campaign, and \$40,000

for the second. He has rejected the accusations and has not been formally charged by the US judicial system.

The US government successfully argued that Tony Hernandez was a large-scale drug trafficker who worked from 2004 to 2016 with others in Colombia, Honduras and Mexico to import cocaine into the US by plane, boat and submarine.

He helped facilitate more than 200 tons of cocaine into the US. Some of the it was labeled with his initials TH," prosecutors argued. Hernandez made millions of

dollars from the trafficking and used the proceeds to influence three presidential elections, according to US The prosecution also said Hernandez, who served as a member

of the Honduran Congress from 2014

to 2018, was involved in at least two

presidium meeting. The allegations included that he misbehaves with party leaders, does not attend office regularly and run the organisation at will staying at his Dhanmondi residence.

Jubo League insiders said in his early age, Omar Faruk was the general secretary of 'Biri Sramik League' of Chattogram at the 70s. He started importing 'Tendu leaf' (alternative of tobacco) from Myanmar. In the

following years, he started garments

Later, Faruk started his political career with Sramik League's politics. When late HM Ershad assumed power and late Najiur Rahman Manju became a minister, Faruk joined Jubo Sanghati, the youth wing of the Jatiya Party. Manju is a brother-in-law of Faruk.

After the fall of autocratic ruler Ershad in 1990, Omar Faruk joined AL's politics in Chattogram and was elected as a treasurer of Chattogram (North) unit in 1997. He became the presidium member of Jubo League at

its congress in 2003. Nine years later, he became the chairman of the organisation.
