Road carpeting damaged within days of repair

Use of substandard materials alleged

Carpeting got damaged and potholes have developed only a few days after completion of the work on one-km-long Bishnathpur-Gouripur road in Juri upazila of Moulvibazar.

Following tender, Local Government Engineering Department (LGED) gave Tk 45 lakh work order to contractor Noman Ahmed for the carpeting of the road and he started the work on November 28, 2017, LGED sources said.

As per schedule, May 25, 2018, was the deadline for completion of the work but the contractor failed to do the work in time.

Later contractor Kamal Hosain got work order for the 196-metre portion at the end of the road at Gauripur and completed the work in four days from last October 10 to 13.

But the carpeting has already started getting removed due to use of cheap bitumen, locals said, adding that the carpeting was done with 10 to 15 millimetres of thickness instead of scheduled 25 millimetres.

"The contractor threatened us when we protested it," said a local.

"This road is already getting damaged in such a way that it is not suitable for pedestrians, let alone vehicles. Re-carpeting of the main road and adjoining other lanes is essential to mitigate sufferings of thousands of people of Bishnathpur and as per schedule."

"As per schedule, the thickness of the road carpeting was to be 25 millimetres. However, it may be a bit more or less at one or two places," he added.

MA Moid Faruk, chairman of Juri Upazila Parishad, said, "After receiving complaints from locals, I visited the road and found irregularities in the work. We will call a meeting of the upazila parishad and ask the contractor to do the work again

Tortured fisherman lands in hospital

The victim said he faced wrath for giving TV interview on irregularities in leasing water bodies

Criminals beat up a fishermen's association leader in Gobindaganj upazila allegedly over giving interview with a television channel on corrupt practices in leasing water bodies.

The incident took place at Kocharshaher on Saturday.

The victim Shambhu Majhee, president of Mohimaganj Matsyajibi Samity, is undergoing treatment at Gaibandha Sadar Hospital.

Demanding justice and punishment of the attackers, members of the association brought out a protest procession at Mohimaganj Bazar and formed a human chain there on Saturday afternoon.

Talking to this correspondent at hospital, Shambhu said Shaheen, Ramjan, Anwar and a few others attacked and beat him mercilessly,

causing severe injuries. Locals rescued him and sent to Gaibandha Sadar Hospital.

"A section of ruling party men take lease of water bodies from the authorities concerned and later hand those over to members of fishermen's association members under sub-lease in exchange of high amounts, whereas we have all the rights to lease water bodies directly from the administration," he said.

"As I exposed the irregularities in leasing water bodies in an interview with Talash programme of Independent Television on October 4, the vested interest group became

furious and attacked me," Shambhu said. AKM Mehedi Hasan, officer in charge of Gobindaganj Police Station, said, "Police arrested three people in this connection. Investigation is on and we are trying to arrest

OC Syed Lutfar Rahman of Sadarpur Police Station said informed by the victim's husband, they recovered the hanging body of Shikha from the house around 11:00pm and sent it to Faridpur Medical College Hospital for autopsy.

Mobile courts seize 8.24 lakh metres of fishing nets, jail 90

Shelter houses under Ashrayan project built at Bangla Bazar in Haripur union of Gaibandha's Sundarganj upazila have got badly damaged due

Catching of hilsa is going on in all upazilas of Patuakhali although there is a 22-day ban in force against catching of the country's most sought-after fish.

A large number of fishers have been out in the rivers -- especially the Tentulia, Ramnabad, Buragourango and Payra -- at night, while many others have been fishing even in the

Yesterday around noon, at least five fishing boats were spotted netting hilsa in the Tentulia river near Nimdee area of Baufal's Dhulia union.

More fishing boats were seen catching the fish in Barodalima and Chandradwip areas of the same upazila. The scene was similar in Banshbaria area under Dashmina

A Nimdee resident said the fishers have been selling four pieces of hilsa for Tk 600 to Tk 1,000 and many of them are making door to door sales.

Fisherman Shah Alam from

Banshbaria area said, "I've got monthly instalment payment for a loan that took from an NGO. I can't help fishing hilsa defying the ban as I have a family to support and there's no other

the NGOs and banks from making the borrowers repay loans during the fishing ban, he also said.

Zakir Hossain, another fisherman from Dashpara area in Baufal upazila, echoed the same.

Banshbaria Union Parishad Chairman Altaf Hossain said the government should take measures so the NGOs and banks do not collect payments against loans taken by fishers during the fishing bans. Contacted, Mohammad Badol,

coordinator of a local NGO, said they do not force fishers to repay loans and they would take it into consideration if any of the fishers approached the NGO, seeking exemption from payment obligations during the fishing ban.

Meanwhile, department, assisted by the local administration, have been conducting raids against violators of the hilsa

fishing ban. As of yesterday, since the hilsa The government should forbid fishing ban commenced on October 9, the department and the administration carried out a total of 171 raids against violators of the ban in different parts of Patuakhali and seized 8.24 lakh metres fishing nets, with an estimated value of Tk 1.66 crore, according to sources at the fisheries department in Patuakhali.

So far, 2,195 kilograms of hilsa were seized, 90 fishermen were given jail sentences, Tk 1.90 lakh was collected in fines and 136 cases were filed during 92 raids carried out by mobile courts in the district

Patuakhali District Fisheries Officer Molla Emdadullah said they have been maintaining a vigilant watch to protect mother hilsa during the ban.

The hilsa fishing ban will end on October 30.
