# BGMEA building demolition starts this week

Rajdhani Unnayan Kartripakkha (Rajuk) is finally set to demolish the 15-storey BGMEA building later this

Bangladesh Garment Manufacturers and Exporters Association (BGMEA) building was supposed to be demolished by Rajuk on April 16 this year after getting clearance from the High Court, but the process could not be initiated on

Rajuk also did not take any decision at the time regarding the method which would be applied to demolish the building.

"We are going to start the demolition work of BGMEA building manually by this week and the procedure in this regard has been completed," Rajuk Chief Engineer ASM Raihanul Ferdous told The Daily Star yesterday.

He said they have already given work order to Four Star Group to demolish this building.

"We have given them [Four Star Group] six months' time primarily to demolish the building, and they will provide Tk 1.55 crore to Rajuk for the demolition -- taking away all the material that they will get from the building," he said.

Raihanul said they held an auction for the demolition and gave the work order to the highest bidder. There will be two vigilance teams

from Rajuk and the construction firm so that safety measures are taken properly during the demolition, he

The HC had earlier given the building owners three chances to vacate the building.

The last chance allowed them until April 12, after which the building was

even that was not heeded to.

On April 16, Rajuk went to BGMEA Complex with police and bulldozers off. -- apparently ready to bring down the building built on a canal.

Eventually the building was not brought down because authorities

supposed to be demolished -- but found that office bearers were still residing in it. They were given the day to vacate, and the building was sealed

The then Prime Minister Sheikh Hasina laid the foundation stone of the building on November 28, 1998. SEE PAGE 4 COL 5

### Quality treatment at primary level inadequate: speakers

Despite a rise in non-communicable diseases (NCD), quality treatment for such diseases at primary-level healthcare centres across the country is still largely inadequate, speakers at a roundtable said yesterday.

Currently, NCDs like diabetes, heart disease and cancer cause thousands of deaths each year due to "imbalanced lifestyle, insufficiently diverse diet and lack of awareness", they added, referring to studies.

Under this circumstance, there is no alternative to strengthening quality care for NCDs at upazila health centres of the government as well as generating awareness through health education in schools, speakers said at the programme at Bangabandhu Sheikh Mujib Medical University (BSMMU) in Dhaka.

Clinical Research Platform -- a tripartite initiative of icddr,b, BSMMU and British Medical Journal -- organised the discussion on the first day of the two-day "1st Scientific Congress on NCD".

In Bangladesh, there has been an 8.7 percent rise (from 58.3 percent to 66.9 percent) in deaths related to noncommunicable diseases between 2010 and 2016, according to World Bank data.

One in four Bangladeshi adults -- 25 years and above -- are hypertensive, while one in 10 have diabetes, according to a 2015 estimate.

The prevalence of lung diseases is 13.5

Prevalence of cancer is also very high -an estimated 1.3 to 1.5 million patients are suffering from cancer, with 200,000 newly diagnosed cases each year. Kidney Foundation of Bangladesh

estimates 18 million people suffer from kidney disease, of whom annually 35,000-40,000 patients develop chronic kidney

disease, eventually leading to kidney

Conducted by Dr Aliya Naheed, the discussion was attended by chiefs of major healthcare institutions and specialists.

Prof Sohel Reza Choudhury, head of the department of epidemiology and research at National Heart Foundation, talked about ensuring quality treatment for NCDs in upazila health complexes across the country. "At upazila-level health centres, patients come, physicians write prescriptions and provide some drugs, and the patients leave. There is no system of keeping records or following up."

However, an effective intervention at primary-level healthcare could control hypertension and other NCDs, he said.

Prof Shahedur Rahman Khan, director of the National Institute of Diseases of the Chest and Hospital, spoke of government intervention in stopping tobacco use in all forms -- especially smoking, ensuring safe food, health education in schools and so

He asked, "Our government allows Fawzia Karim Firoze told tobacco plantation but we are speaking against tobacco. [Then] how will it be innocent, but he is still an possible to control tobacco?"

Prof Mosharraf Hossain, director of investigation of the case was National Institute of Cancer Research and not completed. Hospital, said, "Some 30 percent cancer patients could get better if the disease is detected early. But in reality, 80 percent of cancer patients come for treatment at advanced stage."

He stressed on extending cancer treatment facilities up to district-level hospitals. "We have to think of prevention," he said.

#### People must be freed of misrule: Rob

Demanding resignation of the Awami Leagueled government, Jatiya Samajtantrik Dal (JSD) President ASM Abdur Rob yesterday demanded formation of a national government to "free the people from the misrule of this government".

"They [AL] have failed to run the country properly, so there is no alternative to forming a national government to hold a free and fair election and establish human rights in the country, eliminating the ongoing crisis," he said.

He made the demand while speaking at a human chain organised by his party at the Jatiya Press Club.

#### Backtracks from comments on people not being able to vote in last polls

Workers Party President Rashed Khan Menon yesterday said his Saturday's remarks on people not being able to vote in the last polls have sent a wrong message to the national and 14-party alliance politics. "This confusion arose for presenting

my remarks partially," he claimed in a statement yesterday. "I want to say clearly that the elections till date are the outcome of struggles of

the 14-party alliance and the government was constituted through the struggles of 14-party," Menon said. "This struggle will have to be taken forward to face the emergence

fundamentalism and sectarianism," he added in the statement. alliance, especially of ruling Awami League, took to the social media against Menon after he during a party programme in Barishal alleged that people could not vote

in December 30, 2018 national election. "Although I was elected in the polls, I am testifying that people couldn't cast their votes in that election. They couldn't vote in the union parishad and upazila parishad

polls," he said on Saturday. Responding to Menon's Saturday's claim, Awami League General Secretary Obaidul Quader yesterday questioned whether Menon would have made such claim had he been a minister.

"We need to find out what he said in this regard and whether he was misquoted... If he had made such remarks, then my question is why did he do so after so many days?" Quader said.

In yesterday's statement, Menon further said, "When I was addressing on the president's speech in the parliament, I lauded that the 11th parliamentary election was held in a successful manner. But the experience was not pleasant."

Khondaker Tabakkharul Islam Tanvir, one of the accused in the Abrar Fahad murder case, confessed to a magistrate yesterday that he was present at the meeting where the murder plan was prepared.

Magistrate Metropolitan Sadbir Yasir Ahsan Chowdhury recorded the confessional statement of Tanvir after Detective Branch Inspector Md Wahiduzzaman, also the investigation officer produced him at his chamber.

In his statement, Tanvir told the magistrate that he checked Abrar's laptop and his mobile messages and found some information about Jamaat-Shibir on the

day of the incident. Then he told the other offenders this information.

This led to the assailants beating Abrar to death, Tanvir said in his confessional statement

After recording his statement, the magistrate ordered to send Tanvir to Keraniganj Central Jail.

Meanwhile, two other accused -- Amit Saha and Shamsul Arefin Rafat -- were sent to jail yesterday on expiry of their three-day remand in the case.

Abrar, a second-year student of Buet's electrical and electronic engineering department, was beaten to death by a group of BCL men at the university's


