Putin steps up push for influence in Africa

REUTERS, Moscow

President Vladimir Putin stepped up Russia's push for influence in Africa days before he hosts a summit with African leaders, saying yesterday that Moscow can offer help without political conditions unlike what he cast as the exploitative West.

The Kremlin has said it expects 47 African leaders to converge on the Black Sea city of Sochi for the October 23-24 event, Moscow's first Russia-Africa summit and part of an ambitious push for influence and business in Africa.

Putin yesterday gave the clearest idea yet of his pitch to African countries, warning of rising competition over Africa and accusing the West of intimidating African countries to exploit their

Nearly two dozen people had their bank accounts frozen and had been facing investigations since the government launched the drive.

Judge Shaikh Nazmul Alam of Dhaka's Special Judge Court-4 handed down the verdict in the presence of Harun after rejecting his bail plea, while the other two are on the run.

The punishment of the fugitives will be effective from the day of their arrest or surrender, the judge said.

After cross-examination of all 12 prosecution witnesses, the judge handed down the sentences. He also gave directives that said Enayet's vehicle should be handed over to the government. Road safety remains as elusive as ever | Lessons from Bhola

got their fitness certificated renewed in two months.

"We think a very few out of the 4.79 lakh unfit vehicles renewed their fitness certificates before the deadline. Among the 89,269 vehicles are those which might have renewed their certificates before their expiry," a BRTA official said.

He said many among the 4.79 lakh vehicles might not be running now.

A total of 41.76 lakh vehicles, 27.54 including motorcycles, got registered with the BRTA till September this year since the country's independence.

As per the law, all vehicles but motorcycles must have their fitness checked and certificates renewed by the BRTA every year. Therefore, 14.22 lakh vehicles are required to have their fitness certificates renewed

But the BRTA data shows that only 5.75 lakh vehicles renewed their fitness certificates in the last fiscal year. A total of 1.40 lakh received fitness clearance in the first three months of

the current fiscal year. People involved in the transport sector said there are several lakh unregistered vehicles in the country.

Mahbub-E-Rabbani, director (road safety) of BRTA, said their mobile courts conduct drives regularly against unfit vehicles and police also work on

"Problems arose due to a huge number of unfit vehicles, but we are trying our best to check plying of such vehicles," he told this correspondent yesterday.

At least 3,488 people were killed and 5,863 others injured in 3,131 road crashes till October 18 this year, according to the Accident Research Institute (ARI) of Buet.

Some 4,076 people were killed in 3,513 road crashes last year, up from 3,672 deaths from 2,917 road accidents in the previous year, says an ARI report, prepared based on media

Bangladesh Jatri Kalyan Samity, a passengers' welfare organisation, put the figure much higher.

Although official figures are significantly lower than that of the two organisations, they also show that the number is on the rise.

According to police, 2,635 people were killed in 2,609 road crashes last year, up from 2,513 deaths in 2,562 accidents in the previous year.

Experts and road safety campaigners said it would be impossible to achieve the target of Sustainable Development Goals (SDG) to cut the number of deaths from road accidents by 50 percent by next year, given the present road network and safety measures.

Asked about the rise in the number of road accidents, Rabbani, also the BRTA spokesperson, said the number of road crashes has increased as the numbers of population and vehicles went up.

He, however, claimed that the rate of road crashes decreased compared

NEW LAW NOT IN FORCE

The country witnessed a massive student agitation for safe road after the death of two college students in the capital in July last year.

Following the protest, parliament passed Road Transport Act-2018 in September last year, aiming to ensure road safety. But the government did not issue any gazette making the law operative, as stipulated by the law.

Meanwhile, different transport organisations have been demanding amendments to several sections of the law, including making all offences under the law "bailable".

Several media reports said the government was going to amend the law giving into the pressure of transport leaders. However, the road transport minister said the information was not correct.

is that police fired in retaliation. Even if we accept the police story in full, killing of four people and injuring of hundred others, almost inevitably, lead to the view that it was a case of overreaction. Of course, we, as armchair analysts, cannot know the real situation but still need to ask, couldn't the matter have been dealt with differently? Police know very well that those who organise agitation with a view to creating mob violence try, as part of their strategy, to instigate the police to force them to react the more violently the better. The challenge is not to fall into that trap. Did we, in this case?

In this particular case there were two advantages that the police had - first, the incident started on Friday afternoon whereas the firing occurred on Sunday. This gave them ample time to prepare for any eventuality and second, police already knew that the Facebook account that was used to spread the hate messages was hacked proving that the whole thing was a setup. In fact, before the firing occurred police had already arrested the hackers.

Police did the right thing, and for which we commend them, by engaging with the local religious leaders and the Imams and diffusing the tension to a great extent. In the morning of the fateful day police officials again engaged with the religious leaders. When the situation was greatly diffused and calm appeared to have been restored, a highly charged group of agitators came onto the scene, incited the crowd to become violent and attacked the police officials, including the SP and additional DIG of the Barishal range, and other officials who had gathered in a nearby madrasa. The mob opened fire injuring a police constable and the retaliatory firing ensued, according to the police.

It would appear to us that when the vested group saw that police were able to calm the situation and realised that their aim to create a violent situation was being thwarted, it resorted to incitement that ended in the loss of four lives. It is a typical method mob inciters use and we should have been prepared for it.

What our law enforcers appear not to have factored in is the role of the people who were originally responsible for hacking the said FB account, putting in the fake messages and creating an abusive conversation, whose screen shots were then made and distributed widely. This group wouldn't let their well laid out effort fail just because of an intelligent police initiative and sensible reaction of the local religious leaders. And hence the violence, the attack on the police and the unfortunate deaths.

As of writing this commentary, police have done a commendable job of both containing further violence and protecting the religious group that has been targeted. The handling of the situation throughout Monday also deserves appreciation.

The pattern in all the above cases is similar. A Facebook account of a religious minority person is hacked, a fake post against our religion and denigrating our Prophet is posted, which is then made viral, and in apparent retaliation a huge 'spontaneous' mob (in one case it was reported that participants in the rally were brought in by buses) gathers within a very short time that attacks places of worship of other religions and vandalises their properties. In the case of Ramu, several Buddhist temples reduced to ashes were historical treasures for Bangladesh.

We in the media, especially this newspaper, have always raised questions about the contrived nature of the so-called spontaneous outburst and the retaliation by a mob who appeared, in almost all cases, to suddenly appear out of nowhere in the shortest possible time and start indulging in violence.

A point needs to be made here that must be addressed immediately. A total of 36 cases were filed in the above instances (excluding the present one in Bhola) but most regrettably trial of not a single one has been completed. They are all at various stages of investigation, etc. There cannot be any acceptable explanation for this lack of police action. By not completing the cases the police gave, perhaps unwittingly, a message that prosecuting those attacking the minorities or vandalising their places of worship and properties was not the priority of our law enforcers.

Imagine if we had prosecuted all the criminals responsible for the attacks on minorities. We would have, at least, sent out a strong message against such actions. More than anyone else our law enforcers should know that when a crime goes unpunished it is not only that justice is being denied to the victim but also that other criminals are being encouraged to commit the same crimes. This must stop forthwith.

We echo our prime minister when she warns "not to try to cash in on the Bhola incident". We must all be ready and willing - and we are - to work alongside the government to create a tolerant and harmonious society for without a universal acceptance of our varied culture, diverse religious and ethnic heritage the Bangladesh of Liberation War will not be achieved.

But wishes and warnings are hardly

To start with we must expose the fact that all the incidents so far of an individual from a minority community denigrating our religion were NOT TRUE. That they were done by vested quarters who wanted to destroy the fundamental ethos of Bangladesh and of our Liberation War which is tolerance of diversity and harmonious and peaceful co-existence of all groups. This means we must immediately, in the shortest time possible, complete investigation and finish all legal formalities to expose these vicious attempts to destroy Bangladesh of our dreams and punish the people behind all such actions.

We commended Sheikh Hasina in the past, and do so again, for holding the trial of our war criminals. We now

30 mummies in wooden coffins

The discovery was unveiled in front of Hatshepsut Temple at Valley of the Kings in Luxor.

Egyptian Minister of Antiquities Khaled El-Enany described the 3,000-year-old coffins, which were buried in Al-Asasif Cemetery, as "exceptionally well-preserved, exceptionally well-coloured.

They contained the mummified remains of men and women, as well as two children, who are believed to be from the middle class, Waziri said.

While the mummies were found completely wrapped in cloth, their genders could be identified by the shape of the hands on the coffin. Coffins which were carved with the hands open meant they were female, while if the hands were balled into

fists, they held males, according to

According to archaeologist Zahi Hawass, finding coffins belonging to a child is a rare occurrence. The discovery of two have caused tremendous interest 'worldwide," he said.

The coffins were sealed, stacked on top of each other and arranged in two rows about three feet below the sand,

They are adorned with intricate carvings and designs, including Egyptian deities, hieroglyphics and scenes from the Book of the Dead, a series of spells that enabled the soul to navigate the afterlife. Names of the dead were also carved onto some of the coffins, Hawass said.

The inscriptions are especially unique because of the vivid colours,

which stayed intact even though the coffins were buried for thousands of years. This is because ancient Egyptians used natural colours from stones, such as limestone, red oak, and turquoise, mixed with egg whites, according to Waziri.

After painting, egg yolk was mixed with candle wax and spread over the coffin to maintain a natural shine, which is still visible, he said.

Officials said the first coffin was discovered because its head was partially exposed. When they continued to dig, 17 more coffins were found. After those coffins were excavated, the archaeologists discovered an additional 12.

The cache of coffins was most likely hidden to keep tomb robbers away from them, according to Waziri.
