2 top leaders of AL fronts under scanner

NBR asks banks to freeze all accounts of Maruf, Kawser

The National Board of Revenue yesterday asked banks to freeze all accounts of Jubo league presidium member Sheikh Fazlur Rahman Maruf and Awami Swechchasebak League President Molla Mohammad Abu Kawser.

Amid the ongoing anti-corruption drive, the NBR also directed banks to freeze accounts of their spouses and their business firms in its bid to look into their tax compliance. The banks were asked to provide within seven days the details of their accounts since July 2012.

Several top leaders of Jubo League and Krishak League have been arrested and are facing multiple investigations since the government launched a drive against corruption

The party president's progovernment role and the party's failure to raise voice on different crucial national issues over the years made its leaders and activists frustrated, the insiders said.



BNP lawmaker jailed for 5 yrs for evading tax

A Dhaka court yesterday sentenced Harunur Rashid, BNP lawmaker in Chapainawabganj-3, to five years' imprisonment in a case filed for tax evasion during the import of a luxury

The tax was dodged by abusing the MPs duty-free car import facilities, according to the case statement.

The court also sentenced Enayetur Rahman Bappi, former managing director of NTV, to two years' imprisonment while Istiaq Sadek, owner of Sky Autos, was sent to jail for three years in the same case. Harun was fined Tk 50 lakh, in default

of which he will have serve six more months in jail, while Enayet was fined Tk one lakh, in default of which he will suffer two more months in jail. Istiaq was fined Tk 40 lakh and will have to serve six more months in jail if he fails to pay the amount.

UK PM denied new Brexit deal vote

Speaker rules it would be 'repetitive and disorderly' for MPs to vote again on deal

British Prime Minister Boris Johnson was dealt another blow yesterday when the speaker of parliament denied him a second shot at winning MPs' approval for his EU divorce deal, with Brexit looming in just 10 days' time.

House of Commons speaker John Bercow -- a colourful figure who has played a starring role in the Brexit drama -- said Johnson was not allowed

to push for the same measures twice in the same parliamentary sitting. Lawmakers, meeting on a Saturday for the first time in 37 years, had voted to demand that the Conservative prime minister delay Brexit while they further consider his newly-agreed EU divorce agreement.

"The motion will not be debated today because it would be repetitive and disorderly to do so," Bercow said.

"Today's motion is in substance the same as Saturday's motion and the House has decided the matter."

Johnson is trying to secure an October 31 break from Brussels that severs many of the island nation's economic relations with Europe after 46 years of EU membership.

But lawmakers refused on Saturday to give their backing to his revised settlement plan until all the domestic legislation needed to ratify it has passed.

They also mandated the British leader to send a letter to Brussels asking to postpone the Brexit deadline until January 31 next year.

Johnson's foes are now forging new alliances and trying to attach amendments that could either force him to push for closer trade ties with the EU -- or abandon the deal and accept a third delay this year.

The option of extending Brexit past the latest October 31 deadline is now in the hands of the 27 remaining EU member states.

EU worried over rights situation

The European Union has raised concerns over the human rights situation in Bangladesh, particularly focusing on the reports of extrajudicial killings and enforced disappearances.

In response, Bangladesh reiterated its "zero tolerance" policy to violations of laws and human rights by law enforcement agencies and the government's commitment and continued efforts to ensure accountability and uphold human rights.

The EU and Bangladesh agreed to develop a roadmap to help improve labour and human rights situation in the country.

"We have raised concerns on some areas of human rights... We have agreed to continue the discussion," said Paola Pampaloni, EU's deputy managing director of the External Action Service SEE PAGE 13 COL 3

30 mummies in wooden coffins found in Egypt

Egyptian authorities on Saturday revealed the contents of 30 ancient wooden coffins discovered in Luxor and yes, they include mummies. Mostafa Waziri, secretary general of the Supreme

Council of Antiquities, told reporters the discovery was the country's largest in more than a century. It is the first cache of coffins to be discovered

by an Egyptian mission, after years of foreign-led archaeological digs.

"The last one was in 1891, [led by] foreigners. 1881, [also] foreigners. But ... 2019 is an Egyptian discovery," Waziri said. "This is an indescribable feeling, I swear to God."

Man's body found in travel bag

Police yesterday recovered the beheaded body of a man from an abandoned luggage in Shambhuganj bridge area of Mymensingh Police could not

immediately identify the victim aged about 40, said Khondaker Shaker Ahmed, officer-in-charge (investigation) of Kotwali Police Station. A five-member bomb

disposal unit reached the spot in the early morning and opened the luggage where they found a body wrapped in plastic, said Humayun Kabir, additional police superintendent of police in Mymensingh. Several parts of the body

were amputated, he said. Terming the incident as a cold-blooded murder, police said the killing might have taken place somewhere outside the district and the perpetrators left the body there to mislead the law enforcers.
