CLASH IN BHOLA

Four sent to jail for 'spreading rumour'

At least four persons have been sent to jail across the country in the last 24 hours for allegedly spreading rumour on social media over the police-protesters clash in Bhola on Sunday.

At least four people were killed and more than a hundred were injured as zealots clashed with police in Borhanuddin upazila over a hate conversation spread through Facebook and its messenger.

At one stage of the clash that broke out around 10:30am, law enforcers had to fire shots to disperse the mob, said police.

JOURNO SENT TO JAIL IN KHULNA

A Khulna court yesterday rejected the remand appeal against journalist Munir Uddin Ahmed after police sought a sevenday remand for interrogating him and sent him to jail, reports our correspondent.

Munir was arrested on Monday in a case filed against him under the digital security act for posting provocative status on social media. Judge Md Amirul Islam of Khulna Metropolitan Magistrate Court rejected the

Munir is the former general secretary Khulna Press Club and district correspondent of English daily The New

Law enforcers arrested him from his Dolkhola residence on charge of posting provocative status on Facebook over the police-protesters clash in Bhola, said Sk Moniruzzaman Mithue, additional deputy commissioner of Khulna Metropolitan

He said police seized Munir's phone and found evidence of posting messages claiming that the clash took place due to failure of the authorities concerned.

Sub-inspector Md Sariful Alam of Khulna Sadar Police Station filed the case against Munir with the police station under sections 25, 28, 29 and 31 of the digital security act.

Murdered child specialist victim of mugging gang

Rab says after arrestee confesses

The Saudi-returnee child specialist who was found murdered on Dhaka-Chattogram highway on Friday, was the victim of a mugging gang inside a moving human haulier, said Rapid Action Battalion yesterday.

Rab-7 officials said the mugging gang stabbed Dr Shah Alam, 61, to death after roughing him up, as he tried to resist them.

The elite force disclosed the information after arresting a human haulier driver from Chattogram city's Railway Station area early yesterday in connection with the murder.

The arrestee was identified as Md Omar Faruk, 19, a resident of Barabkunda of Sitakunda upazila, said Rab

"A gang of five muggers including Faruk took part in the killing while the physician was returning to Chattogram in the vehicle, which plies between the city and Sitakuda upazila," said Kazi Tarek Aziz, assistant superintendent of police (ASP) of Rab-7.

ASP Tarek said, "Like other days, he boarded the human haulier of 'Bin Mansur Paribahan' from Choto Kumira for the city on October 17. At the time, Faruk was on the steering wheel and two of his associates were inside the transport in guise of passengers."

"After a few minutes, two other members of the gang boarded the vehicle, and the four started beating Dr Shah Alam for his belongings," said ASP

The Rab official said, "The muggers at one point stabbed the physician as he tried to resist them. They even stabbed him in the face so he could not be identified."

"After the murder, they dumped the body beside the highway, and later Faruk took the vehicle from Barabkunda to Sea Beach area for washing the blood inside," he said.

3 BCC officials suspended over corruption

20 Shibir men arrested in Ctg

Police arrested 20 local leaders and activists of Islami Chhatra Shibir, a pro-Jamaat student front, from Bakolia area of Chattogram city yesterday, on charge of "planning subversive activities against government establishments and employees".

Tipped off, a team from Bakolia Police Station launched a drive on several flats at Bogarbil in the area around 12:30am and detained the 20 men when they gathered there, Nejam Uddin, office-in-charge (OC) of Bakolia Police Station, told our staff correspondent in Chattogram.

"We had information that a group of Shibir men had gathered to plan subversive activities against several government establishments and employees in Chattogram," said Nejam.

Several Shibir men managed to flee but police are conducting drives to arrest them, he added.

61 JAMAAT-SHIBIR MEN SENT TO JAIL

Warns Hefajat at Ctg rally

Hefajat-e-Islam Bangladesh has threatened to repeat the Shapla Chattar incident, if needed 100 times, if any defamatory remark is made against Islam or the Prophet (PBUH).

The Chattogram-based Islamist group's General Secretary Junaid Babunagri made the remark at a rally in Chattogram. He was addressing a rally on port city's

Jamiyatul Falah Mosque premises after Zohr prayers yesterday. Earlier on Monday, the group announced

a countrywide programme for yesterday to press home their 13-point demand, which include punishment of the police personnel involved in firing on "Towhidi Muslim Janata" during a rally in Bhola on Sunday.

At least four people were killed and more than a hundred injured as zealots clashed with police in Borhanuddin ipazila over a hate conversation spread through Facebook.

At yesterday's event, Babunagri alleged that police fired on innocents and they must be punished for that.

"We did not go to Shapla Chattar in 2013 to grab power... We had shed our blood to uphold dignity of the Prophet (PBUH)...," he said, adding that those who were killed and injured in the incidents [Bhola and Shapla Chattar] did so for the Prophet (PBUH).

At one point, the Hefajat leader asked the crowd to raise their hands to repeat the Shapla Chattar incident at least 100 times, if needed. The activists also brought out a procession from Wasa intersection to realise their demands.

SHAPLA CHATTAR VIOLENCE

Hefajat men marched towards Dhaka and held a rally on April 6, 2013 at Shapla Chattar in Motijheel to press for their 13-point demand which included enactment of anti-blasphemy law and measures for stringent punishment of "atheist bloggers".

They returned a month later and occupied Shapla Chattar on May 5, 2013. Paltan and Motijheel areas were plunged into mayhem as unruly Hefajat men burned down and vandalised public and private properties and clashed with law enforcers

Its activists were driven out from there in the early hours of May 6 by the law enforcement agencies. At least 39 people were killed in the two days' violence.
