# Roommate on 5-day remand

## 19 other accused land in Kashimpur prison

A Dhaka court yesterday placed Buet student Mizanur Rahman on a five-day remand in Abrar Fahad murder case.

Dhaka Metropolitan Magistrate Baki Billah passed the order after police placed Mizanur before court with a seven-day remand plea.

Meanwhile, 19 accused in the case were shifted to Kashimpur high security jail in different phases, reported our Gazipur correspondent.

Eight accused gave their confessional statements narrating horrific descriptions of torturing Abrar to death.

Abrar, a second-year student of Electrical and Electronic Engineering

department of Bangladesh University of Engineering and Technology (Buet), died after he was brutally beaten allegedly by some Chhatra League men at dormitory of the university between October 6 night and the early hours of October 7.

The incident triggered a firestorm of protests on campuses across the country.

Abrar's father filed a murder case against 19 students of the university, mostly Buet BCL leaders, and several other unnamed accused with Chawkbazar Police Station on October 7.

Police so far have arrested 20 people, including 16 FIR-named accused, in connection with the murder case.

The situation is almost the same at most other dormitories of the university... They are staying there illegally under different banners [of various student organisations], the tutor said.

He was speaking at the view-exchange meeting attended by DU Vice Chancellor Prof Akhtaruzzaman, two pro-VCs, and the provosts and house tutors of all the 19 halls at the Senate Building.

The DU authorities convened such a meeting after more than 12 years amid growing concern among students and guardians about security at university dormitories following the killing of Buet student Abrar Fahad.

Abrar was beaten to death by a group of Buet unit Chhatra League leaders and activists at its Sher-e-Bangla Hall on October 7.

"We asked them [the illegal occupants] to leave the hall by October 30... What will we do if they don't leave after the deadline?" Shamsuzzoha questioned at the meeting.

The teacher further said the regular students are being deprived of different facilities as the reading rooms of dormitories and libraries are occupied by "influential" non-students.

On October 9, the DU authorities issued a notice asking students to leave dormitories within 15 days of completing their Master's degree examinations.

Defying the notice, hundreds of such students, mostly affiliated with pro-ruling party student body BCL, are still staying at male dormitories, several teachers and students told this newspaper.

At the meeting, at least two teachers alleged that many of the house tutors do not visit their halls regularly.

"We tried to oust the former students, who have been staying illegally at the hall, several times but we had to fall back, which was uncomfortable for us as teachers," the meeting source quoted Shahidul Hasan, a house tutor of Kabi Jasimuddin Hall, as saying.

Shahidul told the meeting that

they sometimes felt helpless and were ashamed of holding the post of house tutors.

Jewel Mia, a house tutor of Bijoy Ekattor Hall, proposed that every hall should maintain an online data base on students so that the authorities could know with a single click about those staying there illegally.

Another teacher told the meeting that the time has come to analyse whether the university authorities are making efforts to fulfil the students' expectations.

AKM Iftekharul Islam, a house tutor of Haji Muhammad Mohsin Hall, said when a student gets admitted to the university, he is deprived of the right to stay at a hall because of non-students.

Following the meeting, the DU VC in a press statement said the hall authorities must make collaborative efforts to solve the problems that have been piling up at dormitories for years.

Non-students should not be allowed to stay at the dormitories, the VC said, adding that seats should be allotted among the first-year students on the basis of merit.

The VC further said the hall authorities should engage the hall sangsads in their initiatives. He also requested the house tutors to visit all floors of the dormitories regularly.

Meanwhile, the DU authorities suspended four students for possessing drugs and firearms.

They are Hasibur Rahman, fourth-year student of Institute of Education and Research; Imran Hossain, fourth-year student of World Religion and Culture; Iftekharul Islam Tusher, fourth-year student of Pali and Buddhist studies; and Abu Bakar Alif, first-year student of Philosophy.

The university authorities served show-cause notices on the four, asking them to explain why they would not be expelled from the DU. They have been given a week to reply.

Earlier on October 8, Hasibur and Alif were arrested with yaba pills, a pistol and sharp weapons from Mohsin Hall of the university.

# Players call off strike

The players had originally put forward an 11-point demand on Monday, saying that they would boycott all cricket-related activities if they were not met. That led to a heated press briefing by Hassan on Tuesday, and tempers had apparently not cooled down when yesterday's meeting started.

"I was angry at first and scolded them," Hassan said after the meeting. It was learnt that Hassan had focused his anger on Mehedi Hasan Miraz when the players had come in.

"We thank them for coming. They had some demands and I let you know yesterday [Tuesday] that most of them were agreeable and that they would be done if they came to us, and that happened today," Hassan said.

"Of the 11 demands, there is nothing the BCB can do about the first one [demand for more respect from the Cricketers' Welfare Association of Bangladesh and resignation of its committee] and the last one [permission to play in more than two foreign leagues per year]. We said the last one would be on a case-to-case basis because not many players get the chance to play in more than two leagues. We are not saying anything solid because we have a certain line of thinking behind that.

"I think it is a very good resolution. The players may not think that because of my anger the previous few days."

A major notch for the players was that the BCB agreed to revert to the players' draft system in the Dhaka Premier League, the clubs of which had been recruiting players in the player-by-choice system that imposed salary caps and divided the players

into grades. The players' draft, which was the method employed before 2013, allowed players greater freedom to choose clubs and negotiate their salaries.

"Most of our demands were heard by everyone here, including the president, and they agreed to meet them as soon as possible. With that hope, first-class players will start playing [in the NCL] from Saturday and the national team players will start camp from the 25th," Test and T20I captain Shakib Al Hasan, one of the major forces in the players' movement, said after Hassan finished speaking.

Asked about the number one item on their list of demands, the demand for the CWAB committee to step down, Shakib said: "We spoke about that. We do not know the names of the rules or regulations even but we asked to hold the elections as soon as possible. We asked that the players have a representative to hear the issues of the players. We will do that when we have time, maybe after the NCL."

Earlier, Hassan and CWAB president Naimur Rahman had visited Gono Bhaban to meet with Prime Minister Sheikh Hasina in the afternoon and the premier, according to Hassan, urged the cricketers to return to action immediately.

"The prime minister asked why the players had boycotted and said that they should return to cricket as soon as possible," Hassan told 'The Daily Star' last night while waiting for the cricketers to come and meet him in Mirpur. "She said that they could have easily come to me or [Naimur Rahman] Durjoy with their demands, or they could even have gone to her."

# 39 bodies found in Essex lorry

The police said they were alerted by the ambulance service shortly before 1:40am following the discovery of a truck container with people inside at the Waterglade Industrial Park.

Officers in white forensic suits could be seen working by the truck and a white tent was erected outside.

Ambulance services said the victims were already dead by the time they arrived.

'VILE' PEOPLE-TRAFFICKING  
"We are in the process of identifying the victims. However, I anticipate that this could be a lengthy process," said Mariner.

"We believe the lorry is from Bulgaria," he added.

"We have arrested the lorry driver in connection with the incident, who remains in police custody."

The tragedy sparked questions about the route taken by the truck -- and whether people trafficking had played a part.

In August 2015, at the peak of Europe's migration crisis, the bodies of 71 migrants including a baby girl were found piled up in the back of a poultry refrigerator lorry left in Austria.

Investigations later revealed they had been transported along the Balkan

migrant route and left to suffocate in the back of the truck after the driver dumped the vehicle near the Hungarian border.

The truck discovered yesterday is left-hand drive, indicating that it was not British or Irish.

Police said it was thought the lorry entered Britain on Saturday at Holyhead on the northwest tip of Wales -- one of the main ports for ferries from Ireland.

The UK and the Republic of Ireland are not in the European Union's no-borders Schengen zone but have their own historic Common Travel Area, meaning there are no checks on the movement of goods or people between the two.

Richard Burnett, chief executive of the Road Haulage Association which represents truck drivers in Britain, said: "Our thoughts are with the families of the deceased but whatever the circumstances, it highlights the danger of migrant gangs people-smuggling on lorries."

Jackie Doyle-Price, the MP representing the local Thurrock constituency surrounding Grays, said the news was "sickening".

"People trafficking is a vile and dangerous business," she said.

"Let's hope they bring these murderers to justice."

PM 'APPALLED'  
British Prime Minister Boris Johnson said he was receiving regular updates and sent his sympathies to the victims' families.

"I'm appalled by this tragic incident in Essex," he said.

"My thoughts are with all those who lost their lives and their loved ones."

Meanwhile, Home Secretary Priti Patel, Britain's interior minister, said she was "shocked and saddened". "Home Office immigration officials will be working closely alongside them to establish how this horrific event came to happen."

Cases of this kind are rare in Britain. In 2014, staff at the Tilbury container port -- next to Grays -- heard screaming and banging coming from inside a shipping container, and found 34 Afghan Sikhs alive inside suffering from severe dehydration, hypothermia and lack of air.

One man was found dead, having passed away during the sea crossing from Belgium.

In 2000, the bodies of 58 clandestine Chinese immigrants were discovered in a Dutch truck at the British port of Dover. Two people survived.

# Bhola tense as ultimatum ends today

Guard Bangladesh, police and Rapid Action Battalion, deployed in the Bhola area to keep the situation under control, were seen patrolling different areas yesterday.

The parishad's Joint Member Secretary Mizanur Rahman said they were in discussions with the local administration over the demands. "We will continue our protests until the demands are met," he said.

"The local administration has started the process of meeting our demands and has informed us that some of them [demands] were not possible to meet," he said.

Mizanur said they were postponing their scheduled human chain at 11:00am today as it falls within the deadline of the ultimatum.

Sharbadaliya Muslim Oikkya Parishad has been protesting the police firing in Borhanuddin upazila that killed at least four people and injured another 100 on Sunday.

At Borhanuddin, locals gathered to protest after a message hurting religious sentiments was circulated allegedly from Biplob Chandra Baidya's Facebook messenger.

Shorbodoliyo Muslim Oikkya Parishad placed a six-point demand at a press conference at Bhola Press Club around 12:00 noon on Monday.

Their demands include immediate withdrawal of the superintendent of police in Bhola and the officer-in-charge of Borhanuddin Police Station, proper investigation and the punishment of those who gave directions to open fire on the rally, enactment of a law with a provision of capital punishment for those who would malign the image of the Prophet (PBUH), Allah and Islam, capital punishment of the Hindu youth who they claimed was

responsible for the spread of messages against the Prophet, compensation to the families of those who died in Sunday's clash and bearing the treatment expenses of those injured, unconditional release of those who were arrested in connection with the clash, and no filing of cases aiming to harass or arrest any protestor.

Contacted, Deputy Commissioner of Bhola Mohammed Masud Alam Siddique told this newspaper that they are holding discussions with the leaders of the parishad.

"We have started the process of giving compensation to the families of the victims who died in Sunday's clash and bearing the treatment expenses of the injured people," he said.

Some of their demands like the enactment of a law with a provision of capital punishment for those who would malign the image of Prophet (PBUH), Allah and Islam have to be realised from a national level, he said.

"We cannot withdraw the SP of Bhola or the OC of Borhanuddin police station for the sake of ongoing investigation," he added.

ATTACKERS BEING IDENTIFIED  
Police yesterday began the process of identifying the people who attacked law enforcers during Sunday's rally at Eidgah Maidan by analysing videos and photos of the incident, said M Enamul Haque, OC of Borhanuddin police.

Borhanuddin police detained three people from different places of the district early Tuesday after identifying them, he said, adding that the detainees were being interrogated at the station.

CASE FILED  
A case was filed against 400 to 500 unknown people in connection with the vandalism of houses belonging to the Hindus, destruction of temples

and arson attack in a shop during the clash between police and religious zealots in Borhanuddin upazila.

Sattya Prashad Das, 78, a retired school teacher who was also physically assaulted during the atrocities, filed the case with Borhanuddin police station last night, said OC Enamul.

A group of people who joined a rally entered the Hindu locality and vandalised a temple, eight houses and a shop, the case statement said.

They also set fire to a portion of a house and a motorcycle and torched a nearby shop, the statement said, adding that assets worth Tk 32 lakh were damaged in the attack.

OC Enamul said they were trying to identify all the criminals who attacked the Hindu houses and temples.

BIDHAN RELEASED  
Bidhan Majumder, a brother-in-law of Biplob Chandra Baidya, was freed around 30 hours after law enforcers picked him up from his jewellery shop in Bhola.

Bidhan's family claimed yesterday that some unidentified men introducing themselves as detectives picked him up and his employee Sagar from his jewellery shop in Dolarhat area around 7:00pm Monday.

Bidhan and Sagar were released from the Rab office in Bhola's Sadar upazila around 1:00am yesterday, they said.

Biplob is the prime accused in a case filed on Sunday night under the Digital Security Act. He, however, had lodged a general diary with police on Friday afternoon, saying his Facebook account was hacked and hateful messages were spread through it.

Mizanur Rahman Bhuiyan, senior assistant director of Rab's Legal and Media wing, also confirmed that Bidhan was picked up for questioning in connection with the incident.

Quader, also the road transport and bridges minister, made the comment a day after the National Board of Revenue (NBR) asked different commercial banks to freeze all accounts of Kawser, his wife Parveen Luna, daughter Nujhat Nadia Nila, and his business entity Fine Power Solution Limited.

The NBR issued the order in its bid to look into their tax compliance.

The banks were asked to provide within seven days the details of their

accounts since July 2012, sources at the NBR said.

According to police documents, Molla Abu Kawser is also the president of Dhaka Wanderers Club, which is among the clubs that had been closed on charges of running illegal casinos following the start of law enforcement agencies' drive against illegal casino business in the city.

Several top leaders of Jubo League and Krishak League were arrested after the drive began on September 17. They are now facing

investigations for their alleged involvement in various irregularities and corruption.

Last week, the NBR asked banks to freeze the accounts of recently removed Jubo League boss Omar Faruk Chowdhury, his wife, three sons and two business entities: Lake View Properties and RAO Construction Ltd, according to source.

Since September 17, RAB and police have raided different clubs across the country, busting illegal casino business.

# Two 'robbers' killed in 'crossfire'

Key suspect of Chattogram child specialist murder killed in 'gunfight'

The prime suspect in the Saudi-returnee child specialist murder case and an alleged robber were killed in separate "gunfights" with law enforcers in Chattogram and Cox's Bazar yesterday.

The prime suspect of the child specialist murder case was killed in a reported gunfight with Rab-7 in Sitakunda upazila of Chattogram in the early hours of yesterday.

Najir Ahmed Suman alias Kalu, 26, was the suspected mugger who, along with his gang members, killed Dr Shah Alam on Friday, said Kazi Tarek Aziz, assistant superintendent of police (ASP) of Rab-7.

Acting on a tip-off, a patrol team of the elite force raided Uttar Bashbaria area to arrest Kalu and his associates, said Aziz.

Sensing presence of the elite force members, associates of Kalu opened SEE PAGE 13 COL 1

# Man held for raping 4th grader

In Laxmipur, the arrestee, Masud Golder, 20, is a resident of Charkachiya village in Raipur upazila.

Police said the student on Tuesday morning was on her way to the madrasa from home. On her way, Masud intercepted her, took her to a nearby betelnut garden and raped her there.

When the girl started screaming, locals rushed to the spot to rescue her. The accused had fled by then.

Later at night, the victim's mother filed a complaint with police, said Tota Miah, officer-in-charge (OC) of Raipur police station.
